C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Colorado State Engineers' Office has historically administered the waters at the project site as "futile", meaning that it would be futile to administer this water because it would never get or flow to a downstream water right user. Additionally, Nahthan Green, USACE Regulator, the consultant, and the a representative of the landowner traversed the site in September of 2008. We continued down slope from the site in question and crossed the valley on foot, perpendicular to any potential flow, searching for evidence of any bed/bank or wetland. At each of the three transects there was no evidence of confined flow or wetlands. At one location, there was a large gulch within the drainage area, approximately 30 feet across and 20 feet deep, with vertical side slopes. This gulch continues for approximately 0.4 mile and then opens up to a flat sagebrush upland with no evidence of a channel. Even where the drainage connects to Piceance Creek there is no evidence of confined flow.
