Summarize overall biological, chemical and physical functions being performed: Seasonal wetland complexes provide habitat diversity within the oak woodland-savannah, filter roadside and commercial development runoff, and retain floodwaters, releasing water into the intermittent stream more slowly and for a longer period of time.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

Seasonal Wetland 01 is adjacent to Intermittent Stream 01, separated by a narrow sandy berm. Intermittent Stream 01 is an unnamed tributary to Secret Ravine, which is tributary to Dry Creek, which is tributary to the Natomas East Main Drainage Canal, which is tributary to the Sacramento River.
