It was noted by the consultant that the wetlands on the site may have been influenced by past agricultural practices and land management. Irrigation**

water was shut off in 2005 and vegetation has shifted from hydrophytic to non-hydrophytic in the previously mapped wetland areas no wetlands were identified on the site in the June 2010 wetland delineation. Some features such as hydric soil indicators remained visible in some plot locations. However, all three parameters were not met at each of the sample plot locations.

C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD:

An approved JD (SPK-2005-50413) was completed on October 21, 2005 for this site. That approved JD identified 0.152 acres of waters of the United States, including wetlands. It was noted by the consultant that the wetlands on the site may have been influenced by past agricultural practices and land management. Irrigation water was shut off in 2005 and vegetation has shifted from hydrophytic to non-hydrophytic in the previously mapped wetland areas no wetlands were identified on the site in the June 2010 wetland delineation. A flowing well on the property was capped. This well was providing hydrology to the area. In addition, new development has occurred south west and north of the site. This development may have altered and redirected some hydrology for this property. In general the area can be classified as upland meadow. After reviewing the datasheets and conducting a site visit the small areas once identified as wetlands no longer appear to have all three wetland parameters present. Abundant thick stands of *Kochia scoparia* (FACU) dominate the site. The landscape position of the site relative to nearby wetlands and surrounding development did not appear suitable to support wetlands. Wetlands, situated in low lying areas, are present on near by parcels that are located downgradient towards the south and north of the subject property. Hydrology observed in 2005 was most likely sustained by the flowing well. This area has not been directly disturbed since the well was capped and hydrology at this point would be considered natural. Test holes did not indicate hydrology within 12 inches of the soil surface. In genreal the spring precipitation was slightly above average in May to average in June 2010. This idicates that signs of hydrology would have been observed if the area

was still a wetland. Some features such as hydric soil indicators remained visible in some plot locations. However, all three parameters were not met at each of the sample plot locations.

The June 2010 wetland delineation documents that the 0.152 of an acre of wetlands previously identified no longer meet the three parameters for a wetland. This was confirmed by a site visit on September 9, 2010. Therefore no waters of the United States, including wetlands, are present within the 6.23 acres survey area.
