Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **One wetland, approximately 3.43 acres in size was identified in the wetland study area. This wetland appears to be isolated with no apparent hydrologic connection to other Waters of the United States. The area is a closed depression with high groundwater as the source of hydrology. The high groundwater is sufficient to support wetland conditions. Interstate I-15 borders the property on the west and south sides and the north and east is**

bordered by a commercial shopping complex and residential communities. A jurisdictional determination (SPK-2008-00027-UO) was completed for the UDOT Layton interchange project. This approved JD determined that the wetland was isolated and has no connection to a water of the United States, therefore the wetland was determined to be non-jurisdictional. Currently UDOT is reconstructing the interchange. A review of the new site conditions for the interchange indicated that there is no constructed or proposed culvert under the highway. The highway improvements have not altered or improved the connection of this wetland to any other waters. No culverts or drainage paths were identified flowing from the wetland. The nearest potentially jurisdictional water to the site are two streams, Kays Creek is approximately 0.32 miles to the northwest and the other, North Fork of Holmes Creek is approximately 0.45 miles to the southeast. There is no reasonable way for water to flow between the wetland area and these streams. Development including a highway, residential and commercial sites exists between the wetland and streams. The site is located outside of the 100 year floodplain which at this location exists on the west side of I-15.

C. SIGNIFICANT NEXUS DETERMINATION

Interstate I-15 borders the property on the west and south sides and the north and east is bordered by a commercial shopping complex and residential communities. A jurisdictional determination (SPK- 2008-00027-UO) was completed for the UDOT Layton interchange project. This approved JD determined that the wetland was isolated and has no connection to a water of the United States, therefore the wetland was determined to be non-jurisdictional. Currently UDOT is reconstructing the interchange. A review of the new site conditions for the interchange indicated that there is no constructed or proposed culvert under the highway. The highway improvements have not altered or improved the connection of this wetland to any other waters. No culverts or drainage paths were identified flowing from the wetland. The nearest potentially jurisdictional water to the site are two streams, Kays Creek is approximately 0.32 miles to the northwest and the other, North Fork of Holmes Creek is approximately 0.45 miles to the southeast. There is no reasonable way for water to flow between the wetland area and these streams. Development including a highway, residential and commercial sites exists

between the wetland and streams. The site is located outside of the 100 year floodplain which at this location exists on the west side of I-15. No interstate or foreign commerce connection with this wetland system is known to exist.
