Lone Tree Creek (previously determined isolated in SPK-2008-00666, December 23, 2009) drains eastward from Eagle Mountain (elevation 924' above sea level) to the Valley floor (elevation 50' above sea level) where it meets Highway 580 and runs under the highway into an agricultural field where it loses its OHWM before being ditched approximately 0.36 miles north along South Bird Road. The ditch turns 90 degrees east and follows Blewett Road for approximately 0.16 miles where it flows into a culvert under the road. The OHWM is defined once again and the feature flows northward across an agricultural field and crosses over the California Aqueduct in a pipe and daylights into the adjacent field where the creek channel is reformed. The creek channel leads under Vernalis Road/Highway 132 where it fans out again over an agricultural field and loses its OHWM. Beyond the field, the water flows into a pipe and crosses over the Delta-Medota Canal and into a small detention basin where it terminates and has no hydrologic connectivity to a navigable water body or tributary.

Wetlands 1, 2 and 3 meet the three-parameter test for wetlands; however, all three are man made storm water drainages and lack a significant-nexus to waters of the U.S. They occur in depressions that collect storm water runoff from the highway. I have reviewed the National Wetland Index Mapper, historical aerial photos, and other information and could not find any indication of historical aquatic features located at these locations.

The roadside ditch does not appear to meet the definition of "Waters of the United States". First, this feature encounters extremely low volume flows that are infrequent in nature. Secondly, this feature has been excavated wholly in and drains only uplands and does not carry a relatively permanent flow of water. Section 328.3: Definitions, states that we generally do not consider the following to be "Waters of the United States." (a) Non-tidal drainage and irrigation ditches excavated on dry land.

Furthermore, the June 5, 2007, Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in *Rapanos v. United States & Carabell v. United States* memorandum to EPA regions and U.S. Army Corps of Engineers districts specifically states, "The agencies generally will not assert jurisdiction over the following features:

1) Swales or erosional features (e.g., gullies, small washes characterized by low volume, infrequent, or short duration flow), and 2) Ditches (including roadside ditches) excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Lone Tree Creek (previously determined isolated in SPK-2008-00666, December 23, 2009) drains eastward from Eagle Mountain (elevation 924' above sea level) to the Valley floor (elevation 50' above sea level) where it meets Highway 580 and runs under the highway into an agricultural field where it loses its OHWM before being ditched approximately 0.36

miles north along South Bird Road. The ditch turns 90 degrees east and follows Blewett Road for approximately 0.16 miles where it flows into a culvert under the road. The OHWM is defined once again and the feature flows northward across an agricultural field and crosses over the California Aqueduct in a pipe and daylight into the adjacent field where the creek channel is reformed. The creek channel leads under Vernalis Road/Highway 132 where it fans out again over an agricultural field and loses its OHWM. Beyond the field, the water flows into a pipe and crosses over the Delta-Medota Canal and into a small detention basin where it terminates and has no hydrologic connectivity to a navigable water body or tributary.

Wetlands 1, 2 and 3 meet the three-parameter test for wetlands; however, all three are man made storm water drainages and lack a significant-nexus to waters of the U.S. They occur in depressions that collect storm water runoff from the highway. I have reviewed the National Wetland Index Mapper, historical aerial photos, and other information and could not find any indication of historical aquatic features located at these locations.

The roadside ditch does not appear to meet the definition of "Waters of the United States". First, this feature encounters extremely low volume flows that are infrequent in nature. Secondly, this feature has been excavated wholly in and drains only uplands and does not carry a relatively permanent flow of water. Section 328.3: Definitions, states that we generally do not consider the following to be "Waters of the United States." (a) Non-tidal drainage and irrigation ditches excavated on dry land.

Furthermore, the June 5, 2007, Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in *Rapanos v. United States & Carabell v. United States* memorandum to EPA regions and U.S. Army Corps of Engineers districts specifically states, "The agencies generally will not assert jurisdiction over the following features:

1) Swales or erosional features (e.g., gullies, small washes characterized by low volume, infrequent, or short duration flow), and 2) Ditches (including roadside ditches) excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water. .
