Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Two data points were taken at the ephemeral pool. One data point was taken in uplands but the other was taken in a wetland - there was hydrophytic plants, hydric soils and hydrology in the form of surface water. The waterbody meets the three criteria for a wetland but it is isolated. It is a single pool not adjacent to or abutting any channel and is immediately next to a road that does not have any culverts. There is a large (~200ft) topographic rise between the ephemeral pool and the nearest "blue line" channel, preventing the possibility of the two being hydrologically connected by overland flow. The wetland appears to be the result of water draining off the hill being**

trapped at a topographic low spot by the presence of the road which alters the topography and thereby prevents the water from continuing further down slope.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

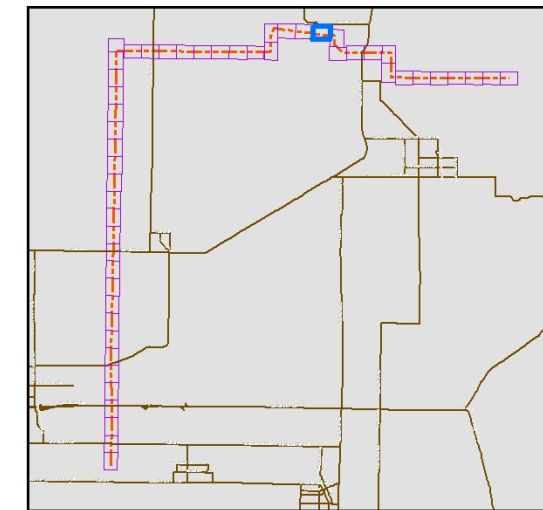
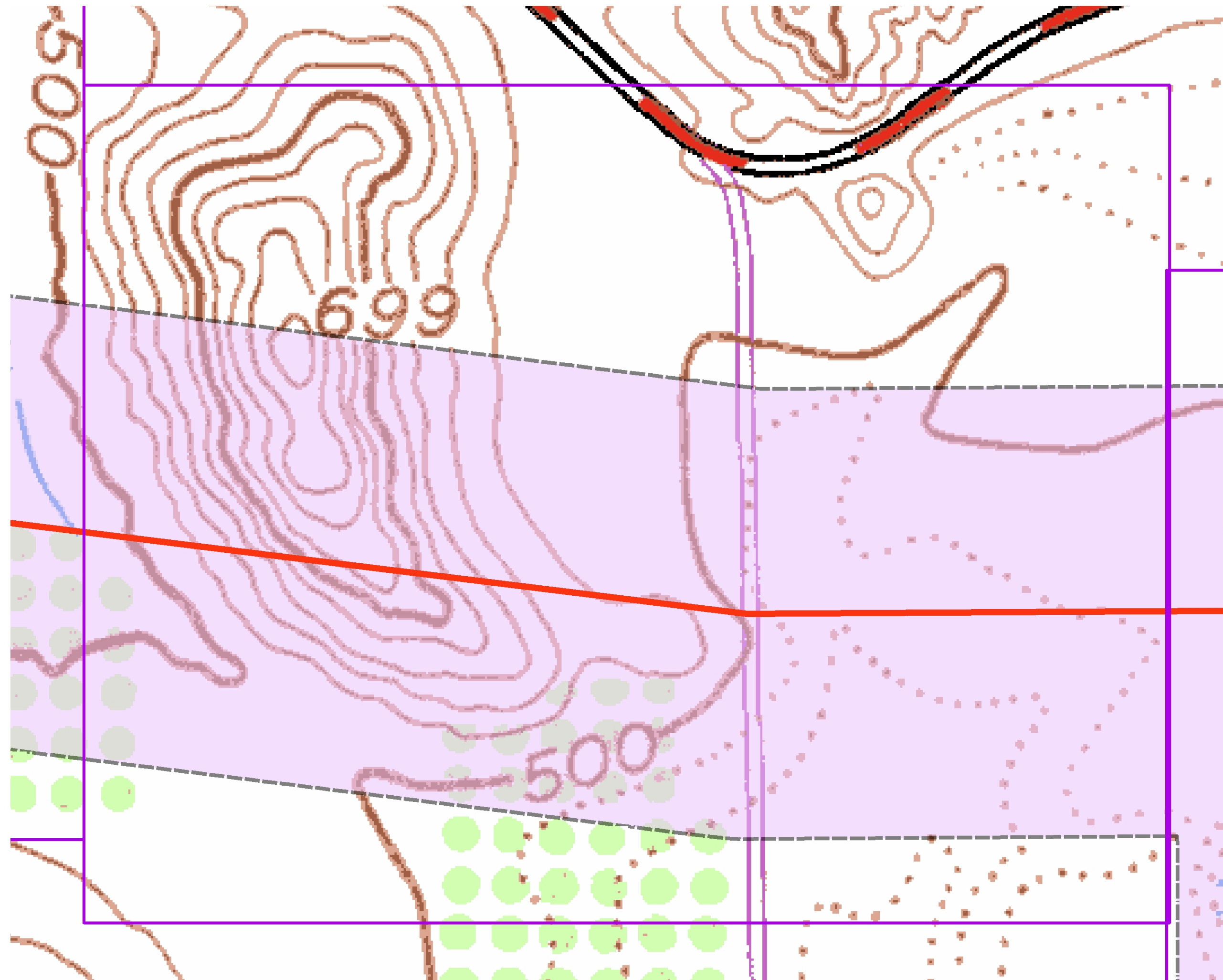

B. ADDITIONAL COMMENTS TO SUPPORT JD:




The ephemeral pool meets the three criteria for a wetland according to the 1987 manual. However there is no hydrologic connectivity between the ephemeral pool and the nearest waterbody because there is a very large hill separating the wetland and the channel located on the other side of the hill. The wetland appears to exist in a topographic low spot from the hill and is bounded on one side by a paved two-lane road. The waters in the wetland are prevented from flowing further downhill by the presence of a paved two-lane road that is higher in elevation than the wetland and there are no culverts under or along this road.

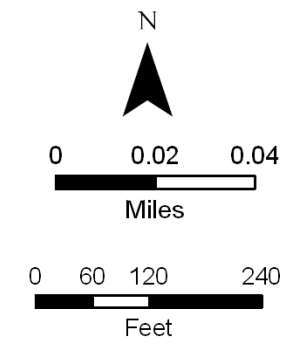


Feature 'ep20.' Ep20 meets all the criteria of a wetland however it is isolated. The nearest water feature is a channel on the other side of the hill that appears in the background of this photo. Ep20 exists in what appears to be a topographic low spot and seems to be collecting runoff from the surrounding hillsides. Water is prevented from flowing further downhill by the presence of the paved road which sits higher on the landscape than the wetland.



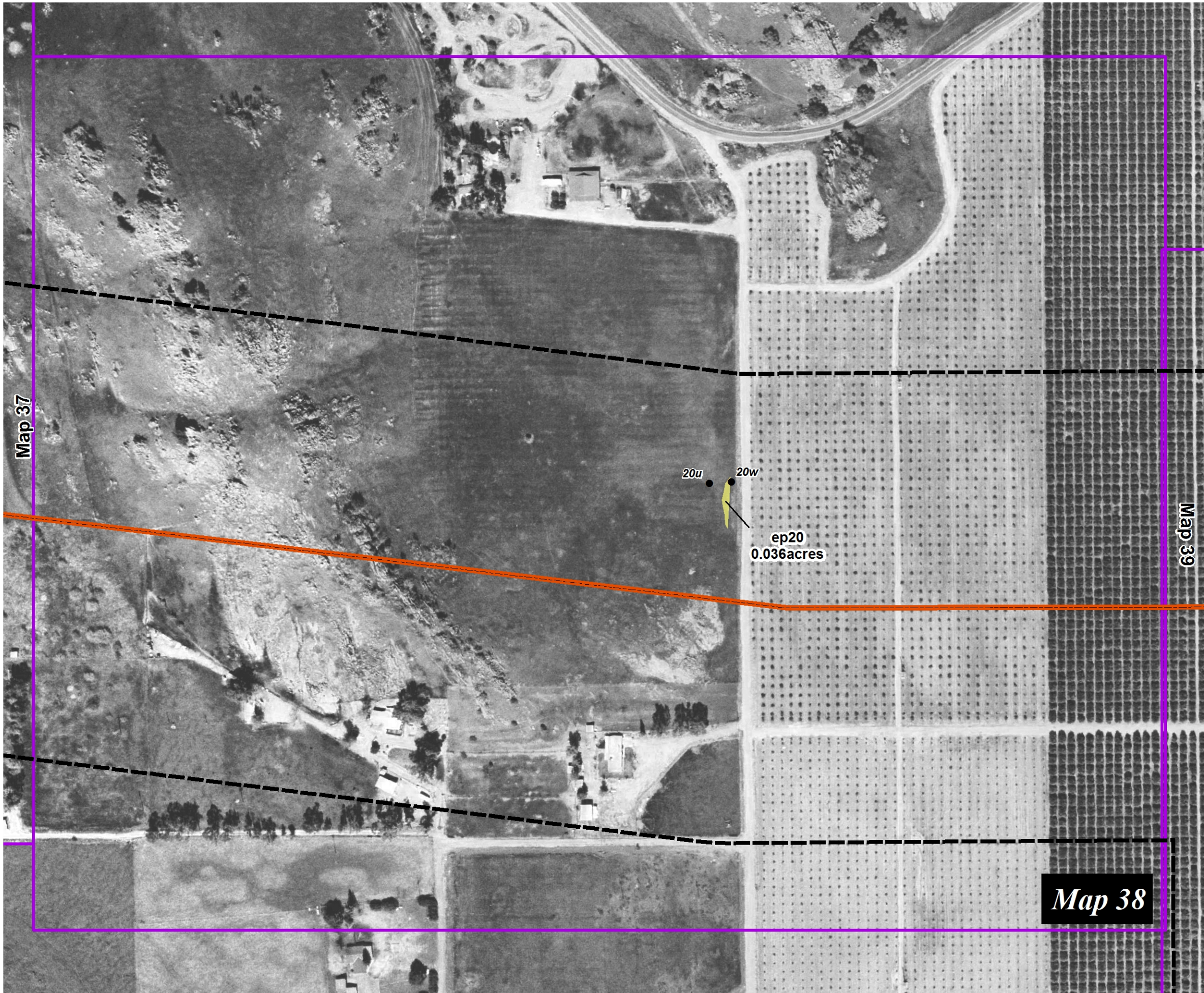

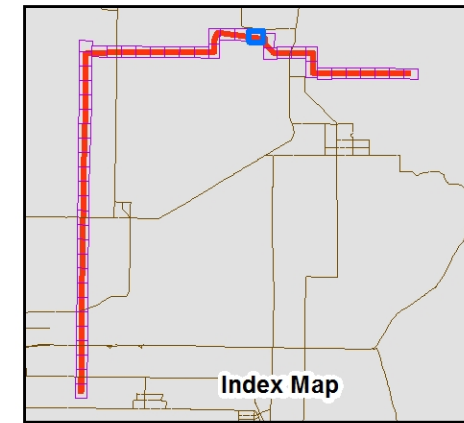
