Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The wetlands labeled by the applicant as 'sw41' and 'ep23' meet all three criteria for a wetland according to the 1987 manual. However these wetlands are nearly three-quarters of a[n aerial] mile from Cottonwood Creek, the nearest channel and an RPW. A slight topographic rise exists immediately adjacent to the wetlands, impeding the possibility of overland flow to Cottonwood Creek. Beyond the pasture land where the wetland was found there is at least a half-mile of orchard separating between the pasture with the wetland and Cottonwood Creek and there are several topographic rises within the orchard land.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

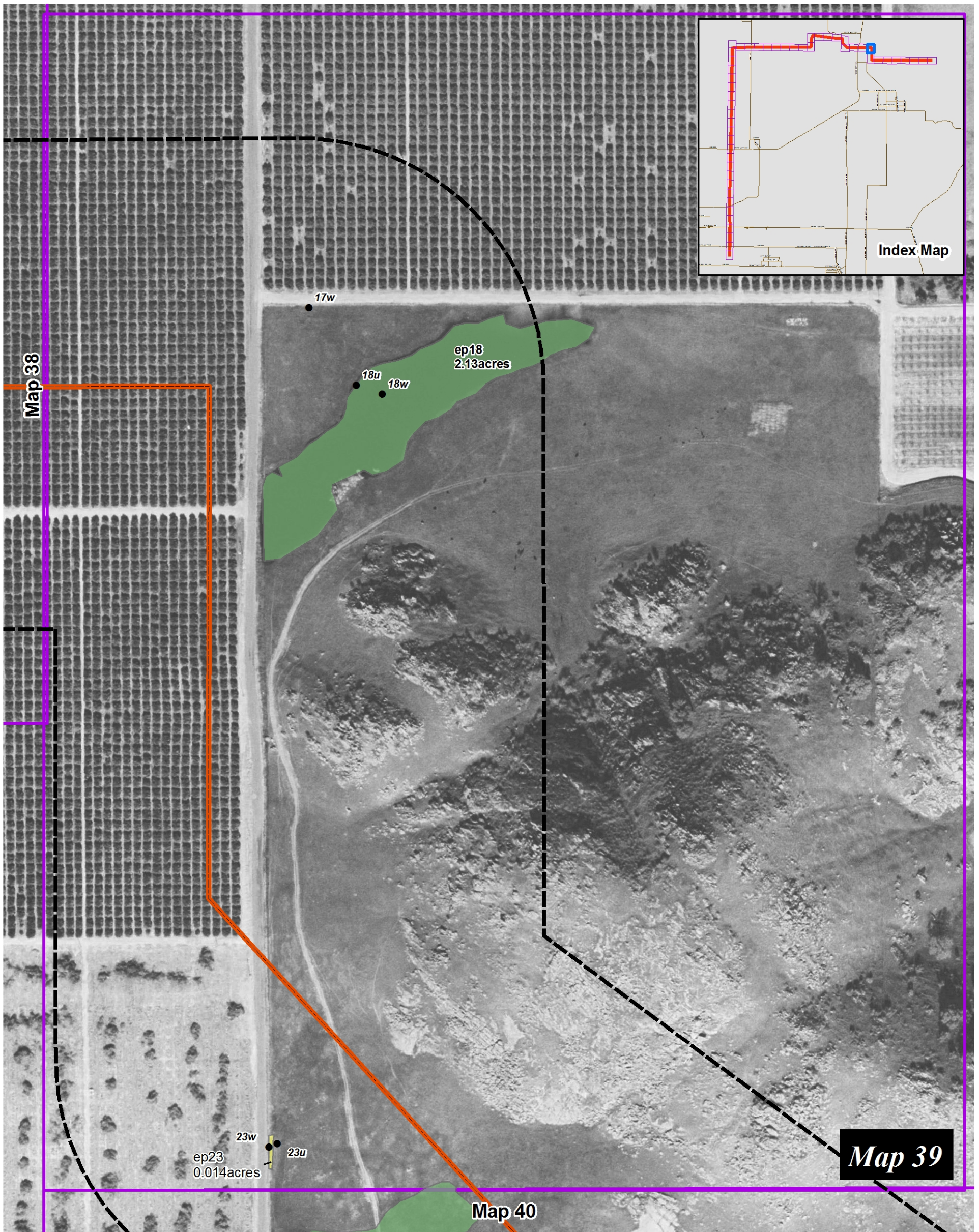

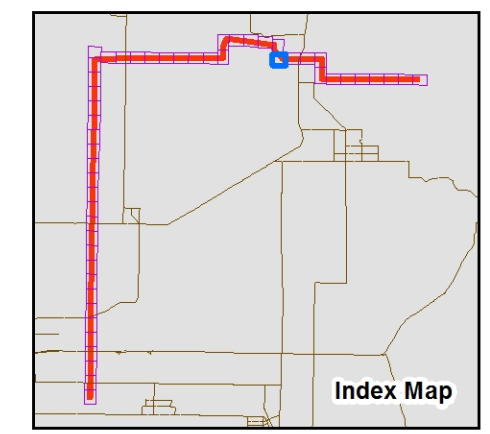
