C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Mathews Ditch is a constructed water feature that draws water from the St. John's River and carries it for use by agriculture before eventually joining Elbow Creek. From Elbow Creek the water flows into Cottonwood Creek and then Cross Creek and then the Tule River and the Tulare Lake Bed. Mathews Ditch is a straightened channel with a trapezoidal bed and bank. It may have originally been a natural water feature. In addition, the adjacent habitat and hydrologic conditions have been altered by the development of land for use by agriculture and the diversion of water to provide irrigation for agriculture. Flows in Mathews Ditch typically begin with the onset of rains in November and December and continue until June or July as the summer drought dominates and irrigation demands increase.

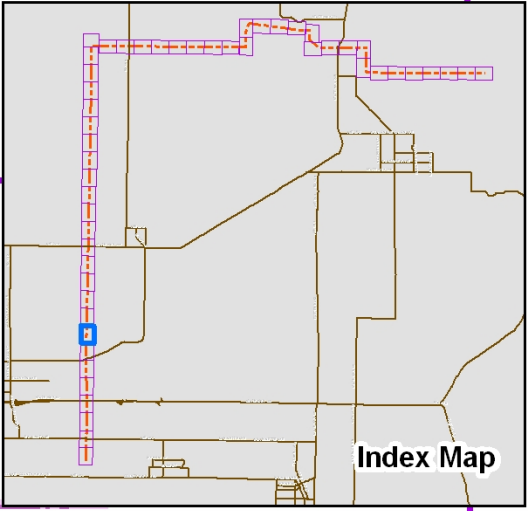
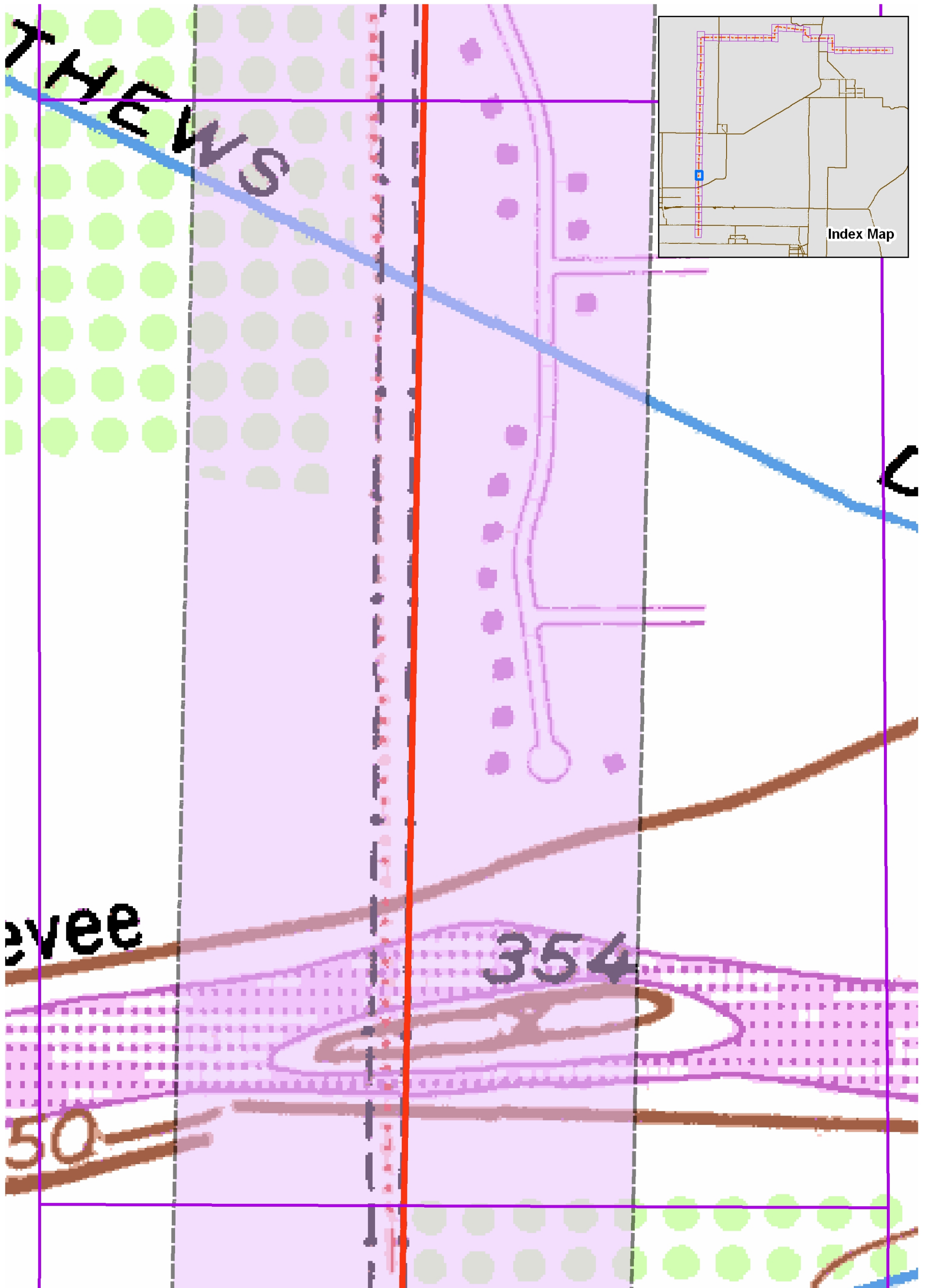

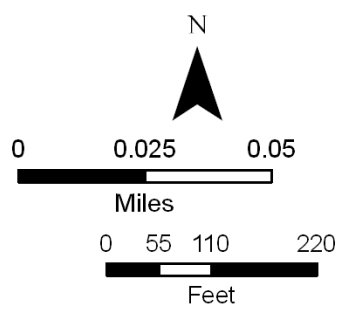

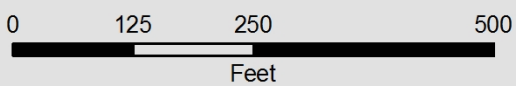
