Explain: **The feature labeled sp22 is not apparent on the topographic map. A datum point taken at sp22 shows that the water body has hydrology but not hydrophytic plants or hydric soils. The channel labeled by the applicant as dcCH begins immediately below sp22 but is separated from sp22 by an earthen berm that is several feet thick. Channel dcCH is a natural drainage channel with an OHWM but no clear connectivity to a TNW or RPW. The channel has an OHWM as it travels downslope, however once the slope gradient flattens out the channel loses its definition and disappears. No channel appears on the topographic map in the area where dcCH is located.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

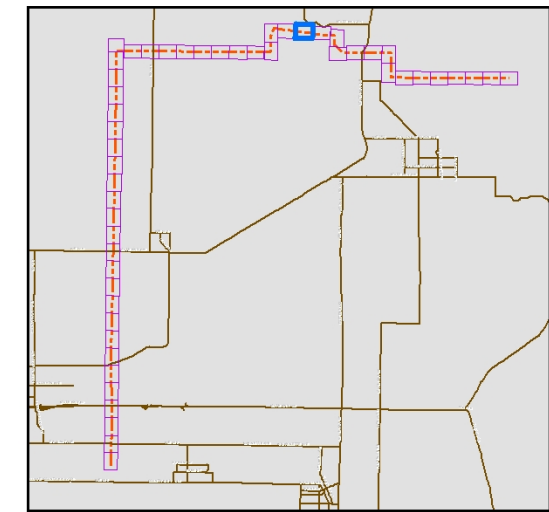
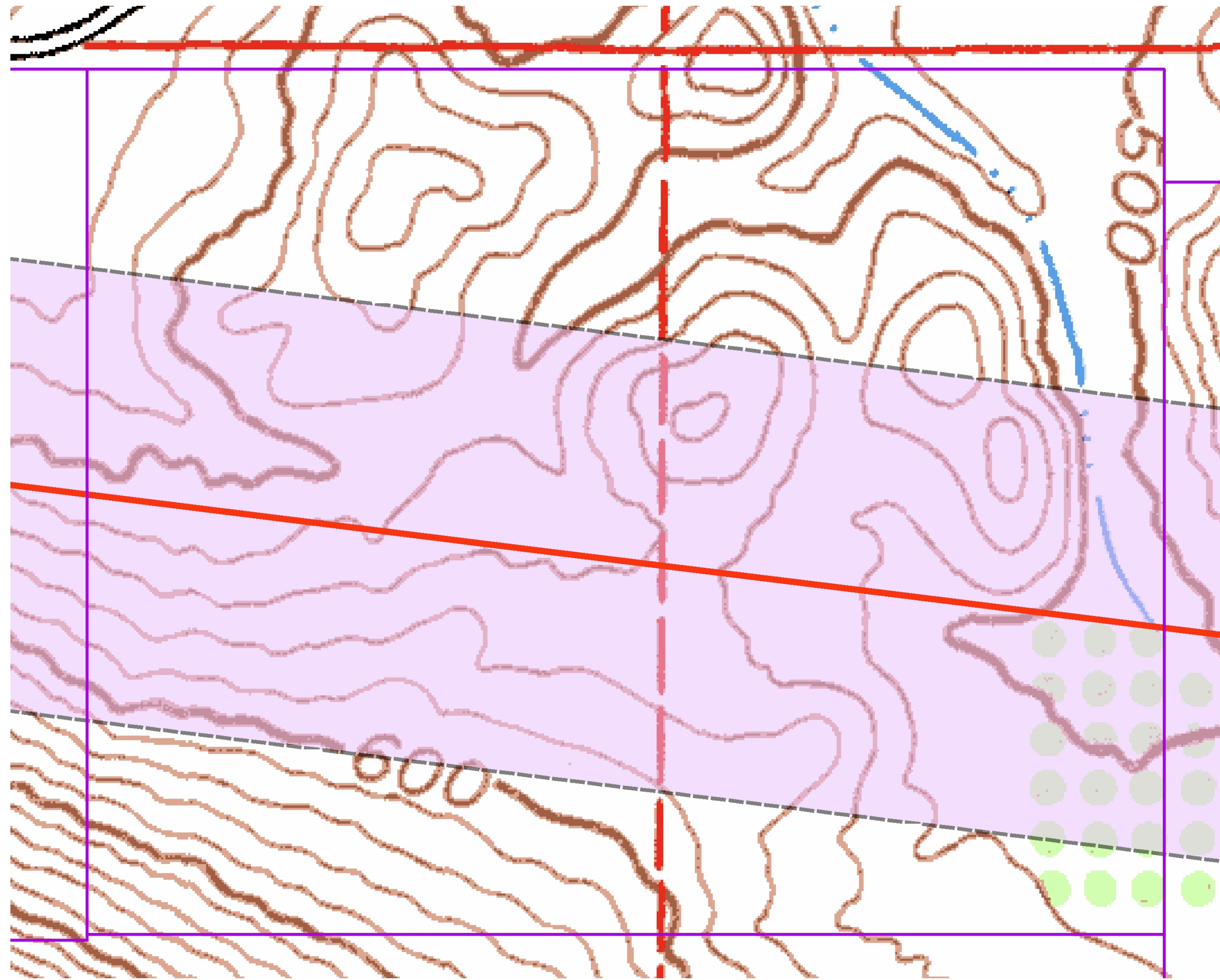

Upstream view of channel dcCH.

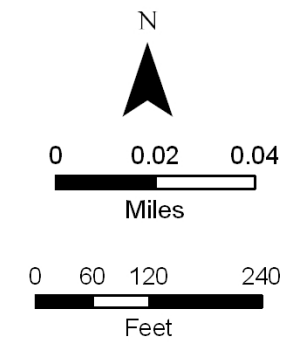



Downstream view of channel dcCH.

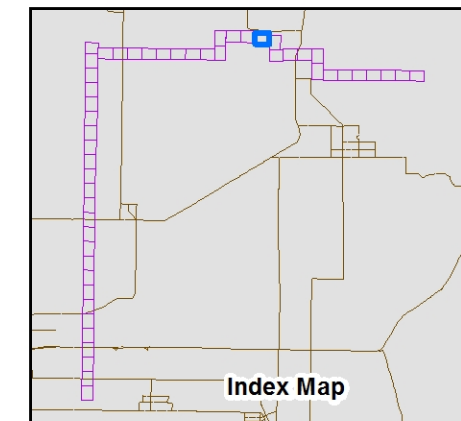
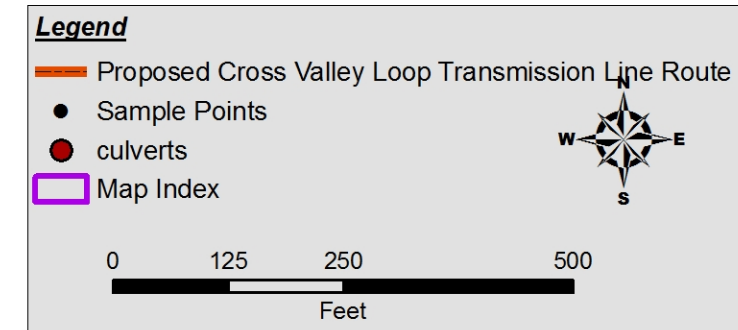
