C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The artificially created irrigation ditch labeled dCH19/Cottonwood Levee drains into Cross Creek via Cottonwood Creek. Cross Creek joins into the Tulare Lake Bed. The water body labeled "pb30" by the applicant is an artificially constructed ponding basin adjacent to a man-altered irrigation ditch identified by the applicant as "dCH19" and by the USGS topographical map as "Cottonwood Levee." Data points taken at this basin show that it does possess hydrophytic vegetation, hydric soils and hydrology. The basin clearly exists in historic aerials that date to August 10, 2004; prior to that date it is difficult to determine if the shape is a basin or a field. The applicant states in the wetland delineation that water is pumped into this feature from dCH19/Cottonwood Levee. The earthworks that separate the pond from the channel appear to prevent any possibility of a natural surface hydrologic connection existing. The levee separating dCH19 and pb30 is higher than the levee on the other side of dCH19, that separates the channel from orchards. However neither the ponding basin nor the channel are concrete lined thus the possibility of a subsurface hydrologic connection does exist. In addition pumps exist in both the channel and the basin which means that water is pumped through the levee in both directions. Cottonwood Levee is a jurisdictional water because it flows into Cottonwood Creek, Cross Creek, and finally the Tulare Lakebed.

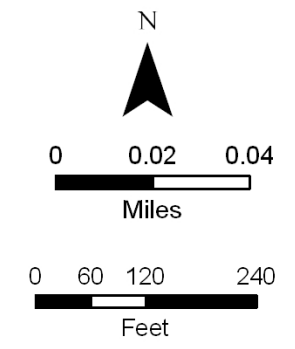
