C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

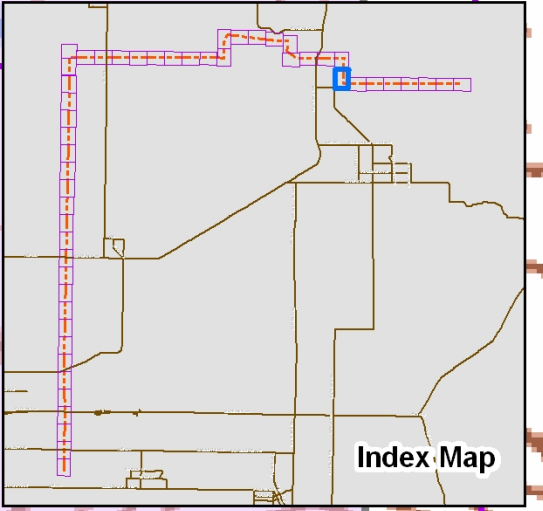
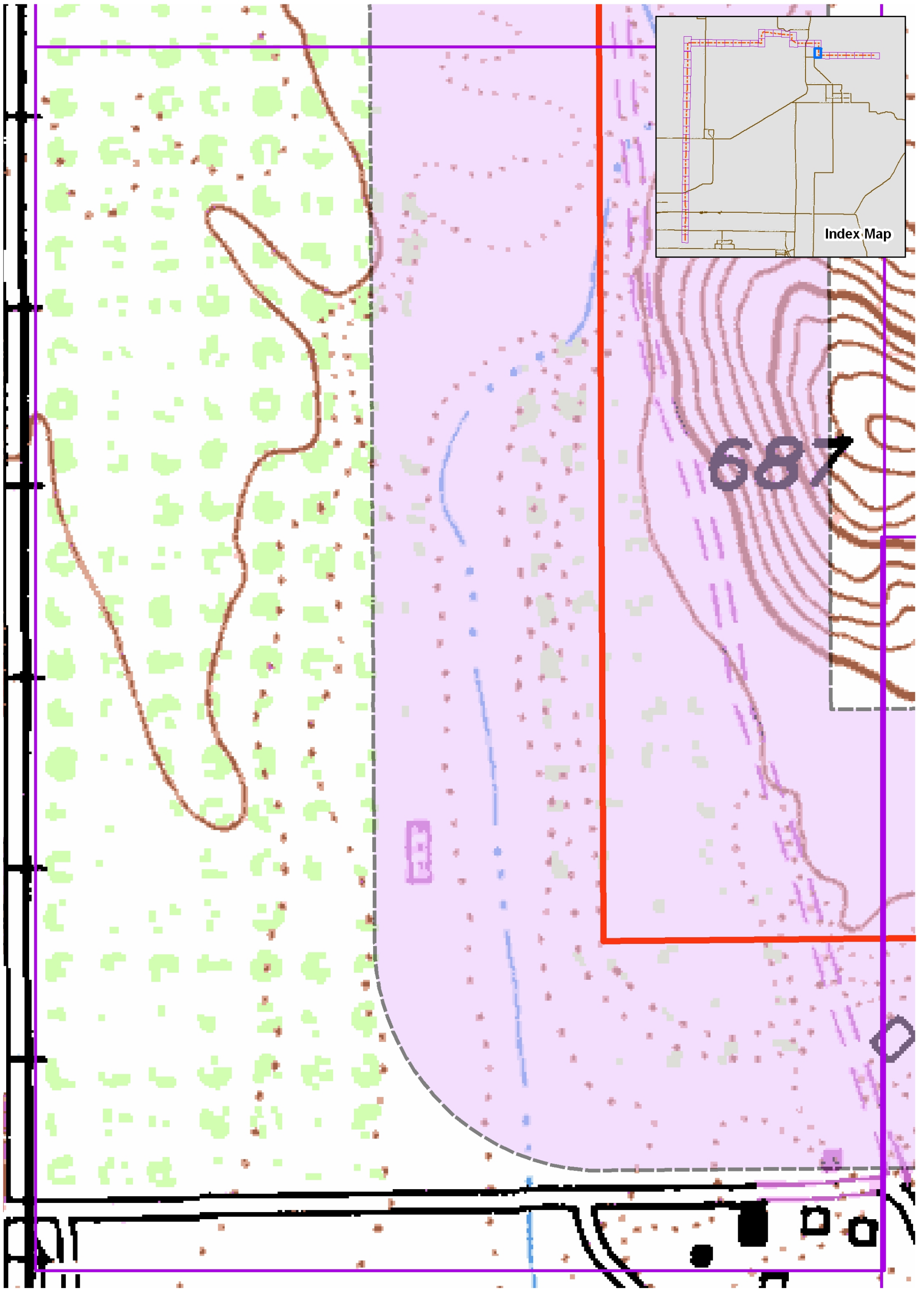

B. ADDITIONAL COMMENTS TO SUPPORT JD:

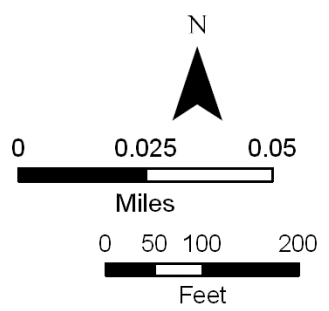
Features wd13, dcCh14, vs12 and ep05 are all hydrologically connected to one another as they all exist within the confines of a unnamed historic channel that drained into Watchumna Ditch. The mapped waterbodies meet the definition of a wetland, or else are a channel with an OHWM. The unnamed blue-line stream that wd13, dcCH14, vs 12 and ep05 are all components of joins to the blue-line stream Antelope Creek prior to joining Watchumna Ditch. The location on the topographical map where the unnamed blue-line and Antelope Creek join is currently surrounded by orchard and the two streams come together and flow down a agricultural ditch for two miles before joining Watchumna Ditch. Watchumna Ditch enters Cottonwood Creek, flows into Cross Creek and then ends up in the Tulare Lake Bed, a TNW The tributary catches runoff from the surrounding land before joining the Antelope Creek and then Watchumna Ditch. According to the RWQCB these are used as irrigation systems and also to channel excessive storm water and thereby flow frequently.

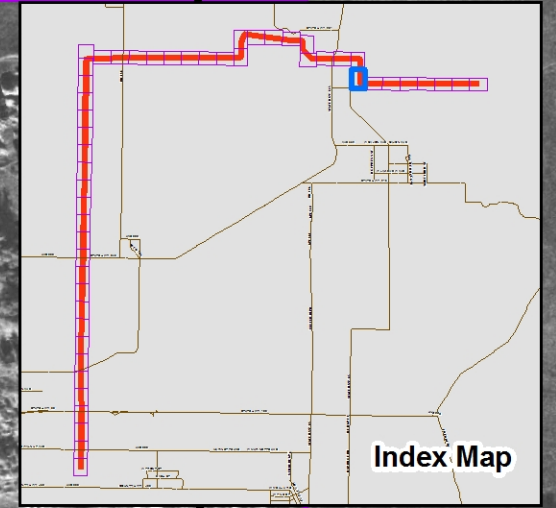

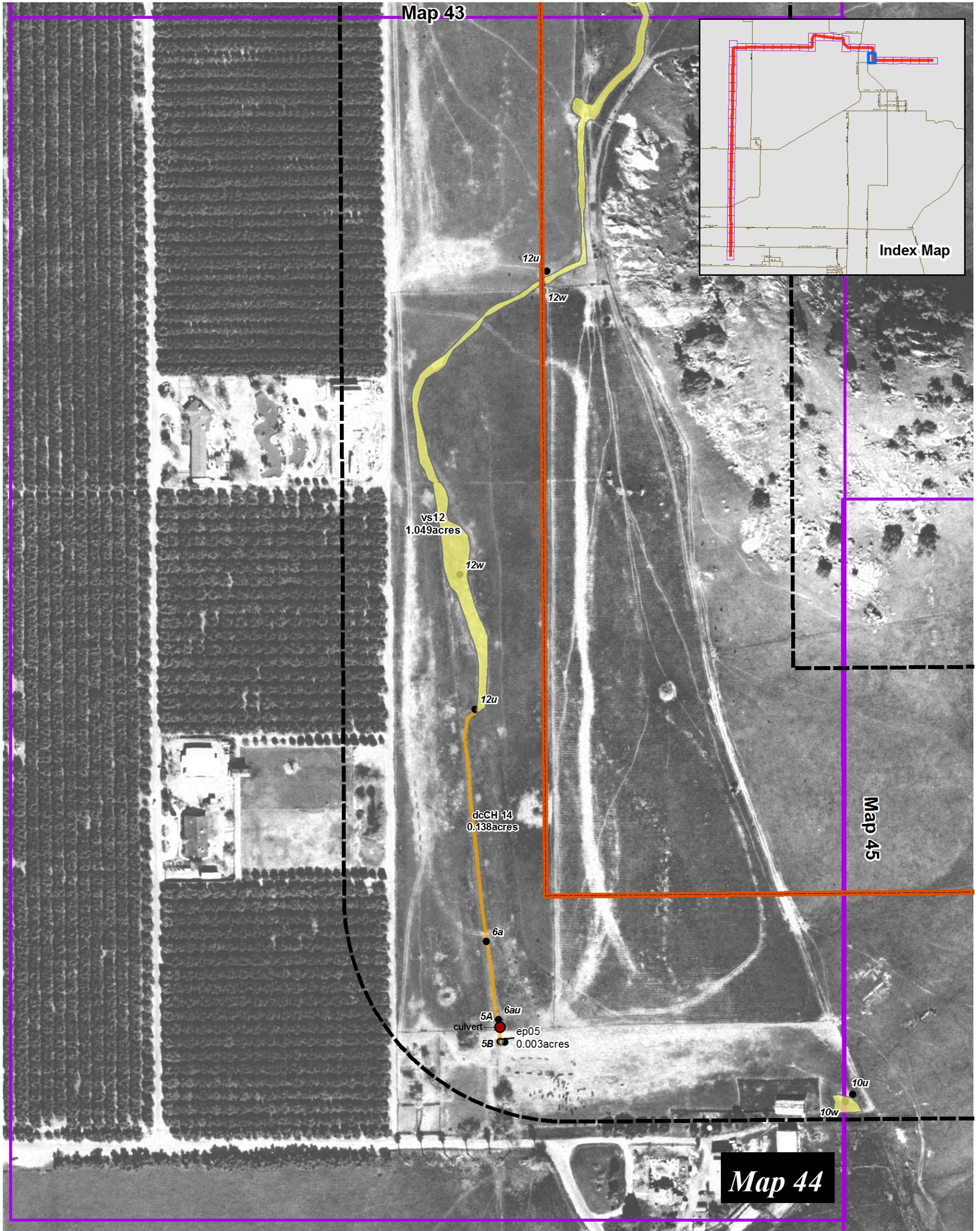

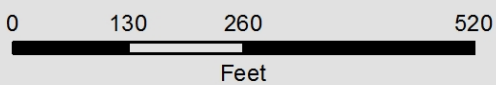
