Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **A 0.58-acre abandoned stock pond is located on the northwest corner of the site. This pond was previously connected to the Fairbanks Lateral through a side ditch. Both the lateral and the ditch appear dry in all available aerial imagery. Water could flow passively from the ditch into the pond through an unregulated concrete culvert installed in the pond berm. The pond is not connected to other waters and water does not flow from the pond back to the ditch or lateral canal. The point where the ditch connects to the canal was inaccessible due to fences and a heavy growth of blackberries. The landowner stated that the ditch is regulated and can be turned off by the water district. The land owner no longer uses the pond and covered the opening of the culvert with plastic prior to burying it within the ditch to keep any water from entering the pond (See photos below). The pond consists of elevated**

berms on four sides and the bottom appears slightly lower than the surrounding land, possibly due to excavation for berm construction. The pond is located approximately 0.85 miles west of the South San Joaquin Main Canal, 0.9 miles north of Lone Tree Creek, and 4.9 miles north of the Stanislaus River. The pond is an isolated feature and is not connected to a jurisdictional water of the U.S. The ditch is not part of this jurisdictional determination.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

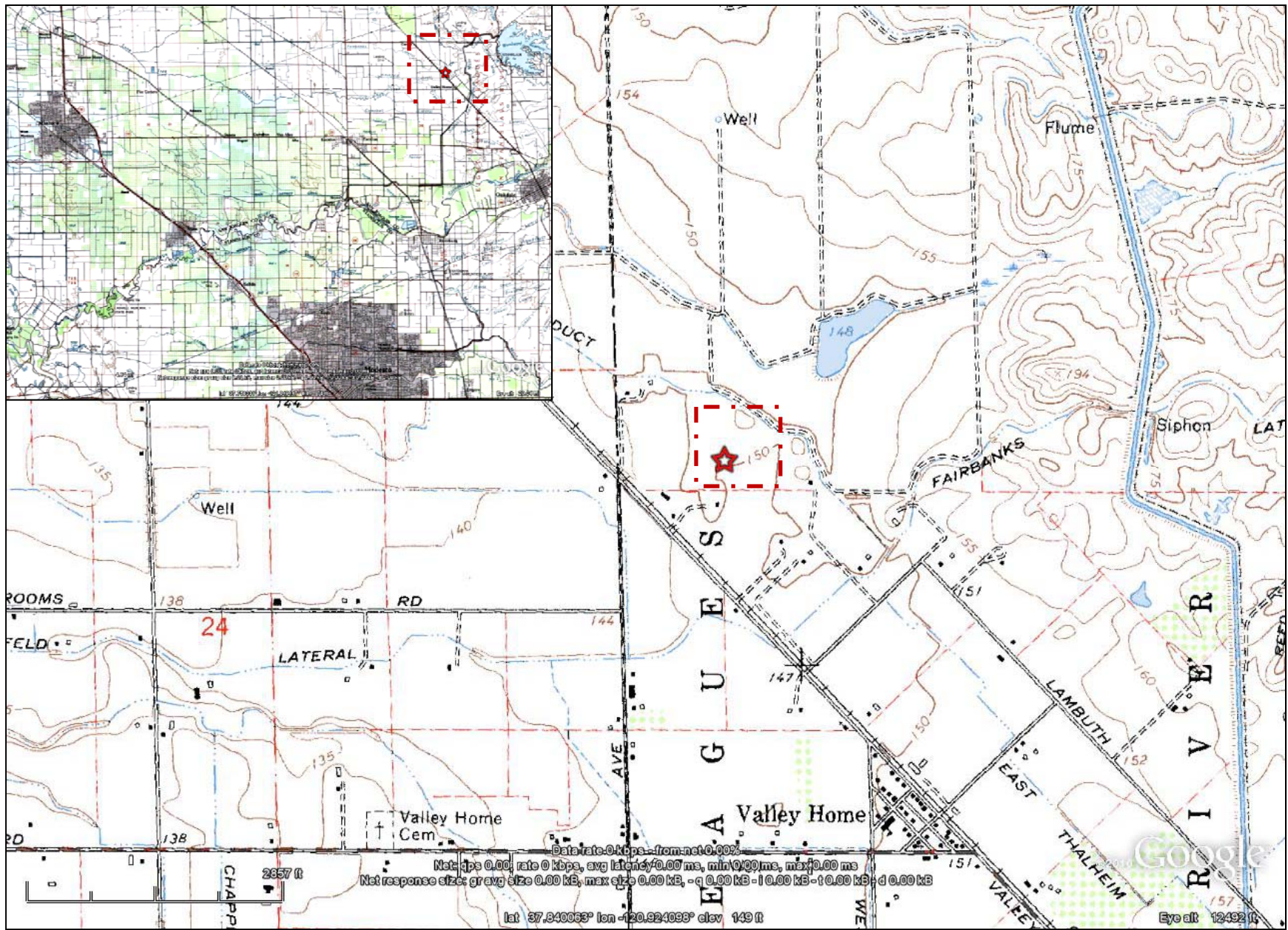


Figure 1. Milazzo Pond, Site and Vicinity

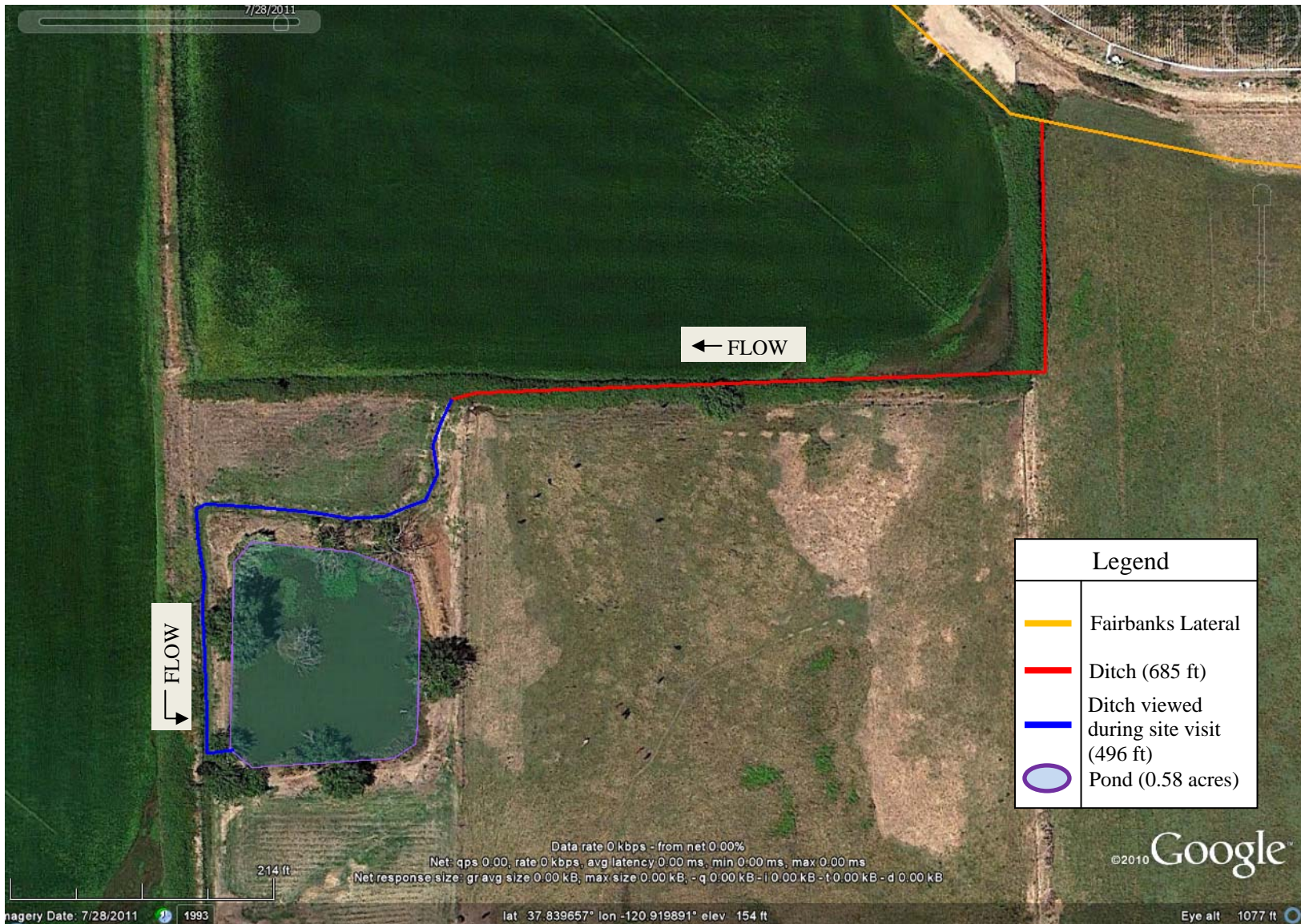


Figure 2. Milazzo Pond, Delineation of potential waters of the U.S.
