**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These three channels are ephemeral and are non-RPWs. No wetlands or other waters were present on the site. Reaches 9 and 14 are ephemeral washes that have OHWMs and flow into Channel 1, which has an OHWM for its entire length in the survey area. Channel 1 has ephemeral flow and flows for 4 miles then flows into Center Fork Asphalt Wash, which after 7 miles flows into Asphalt Wash. Asphalt Wash continues for another 5 miles until it reaches the White River. At this location the White River is a perennial river that is a significant tributary to the Green River, a TNW. The flow path is depicted in the attached figures and represents a clear, physical connection with the Green River. Any pollutant that is introduced to Channel 1 and Reaches 9 and 14 would eventually flow into the Green River, demonstrating chemical connectivity. Therefore, Channel 1 and Reaches 9 and 14 have a significant nexus with the Green River, a TNW.**

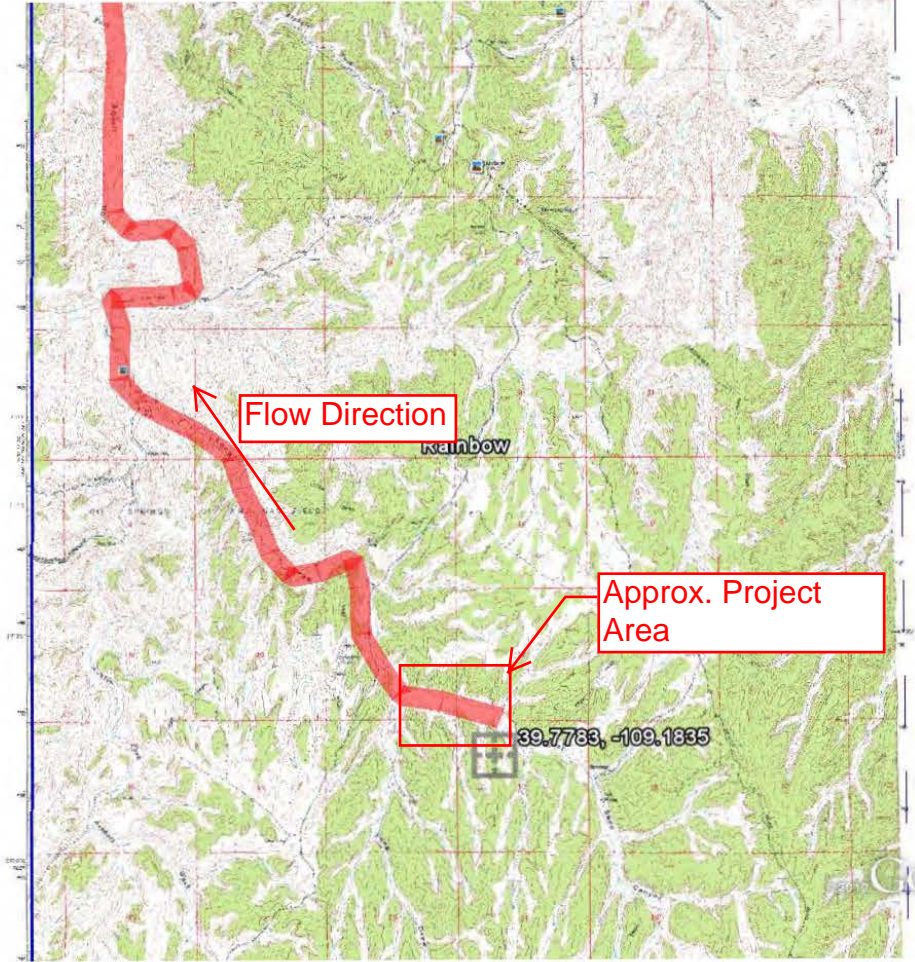


Figure 1. Flow path



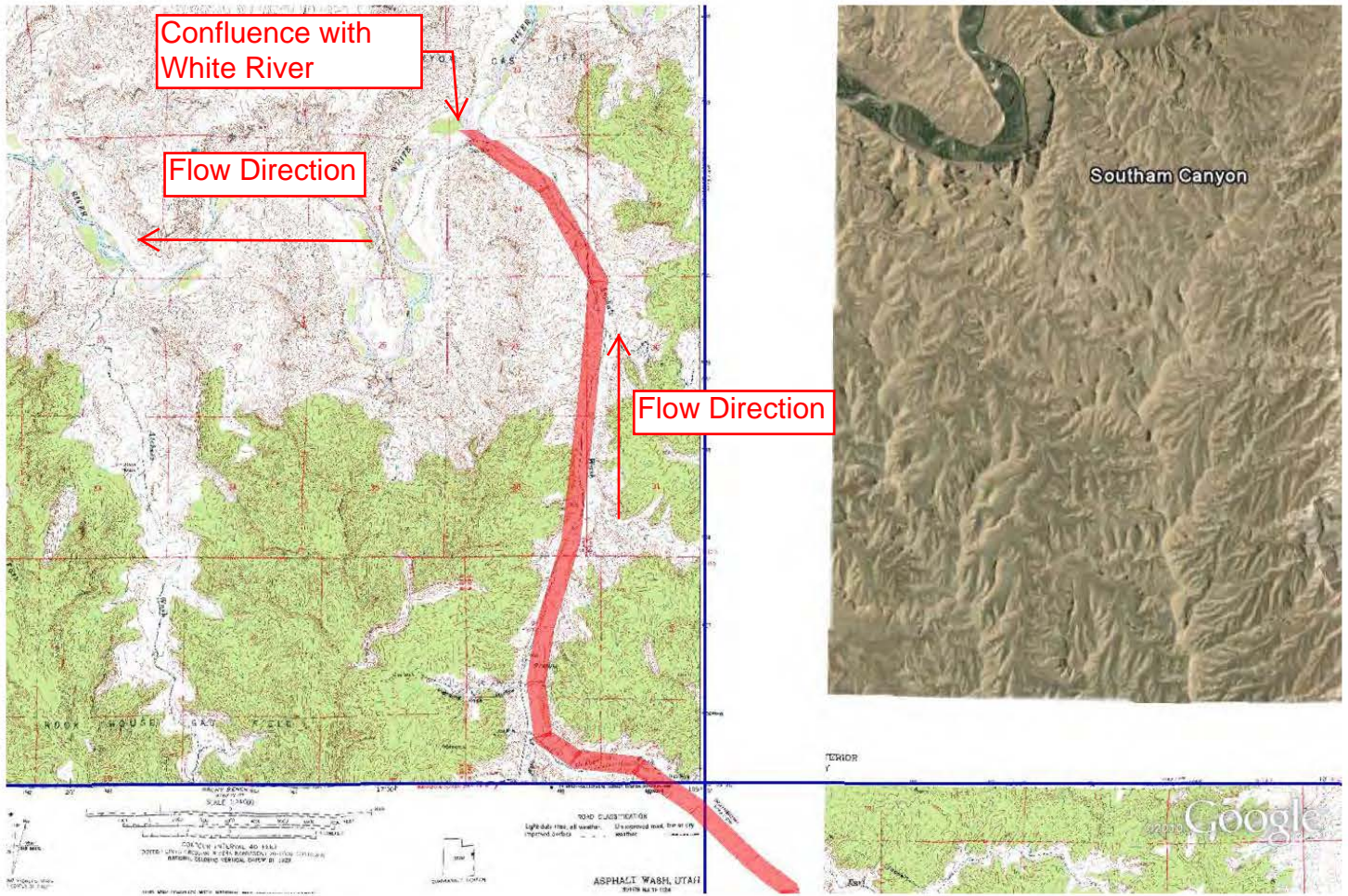
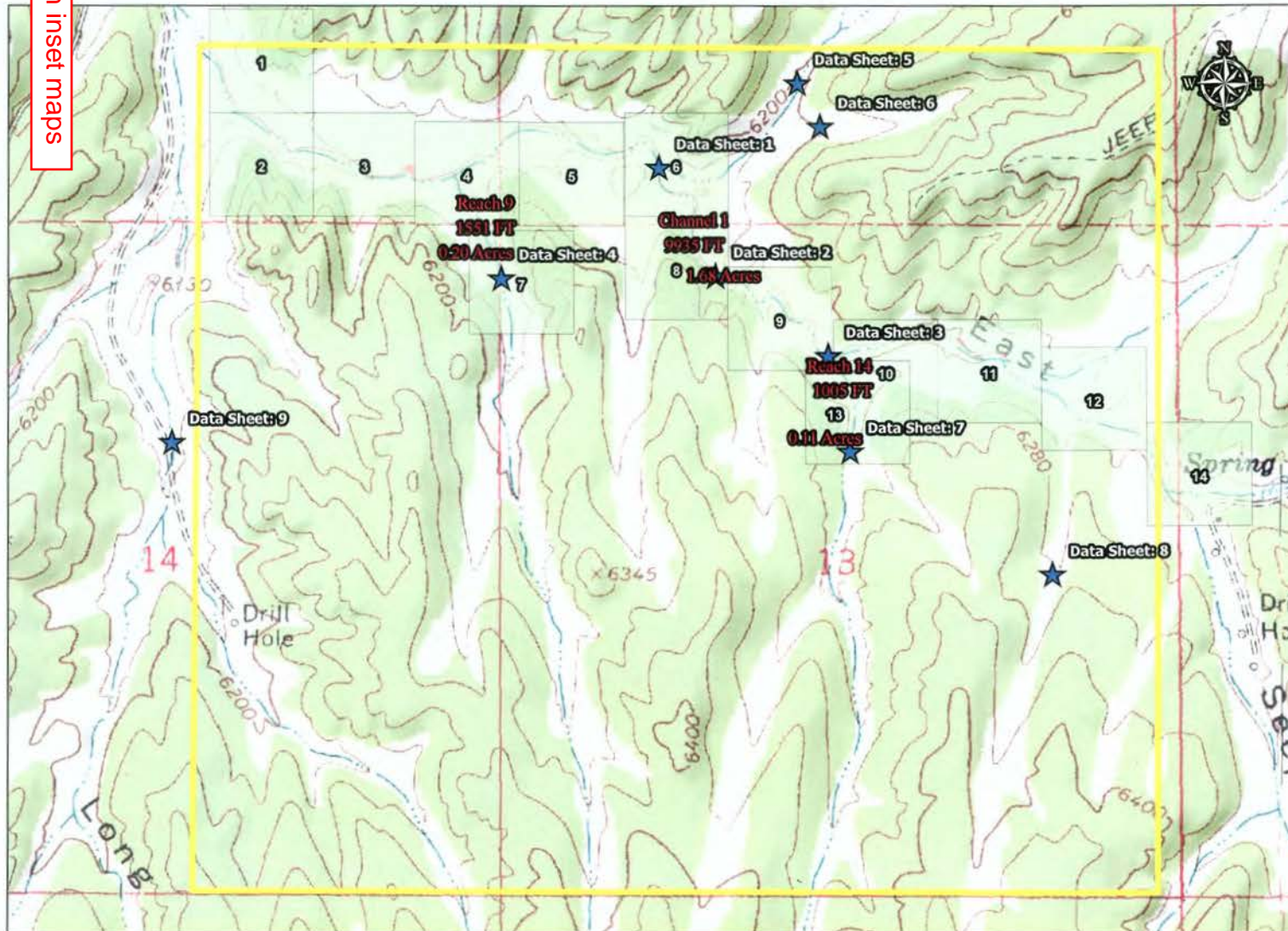


Figure 2. Flow path (cont'd)

Figures 1 and 2 identify the flow path from the project site to the White River, a perennial RPW that is tributary to the Green River, a TNW.

Figures 3-17 are the project specific maps that identify channels within the project area that contained an Ordinary High Water Mark.

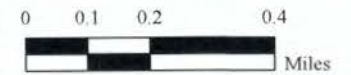

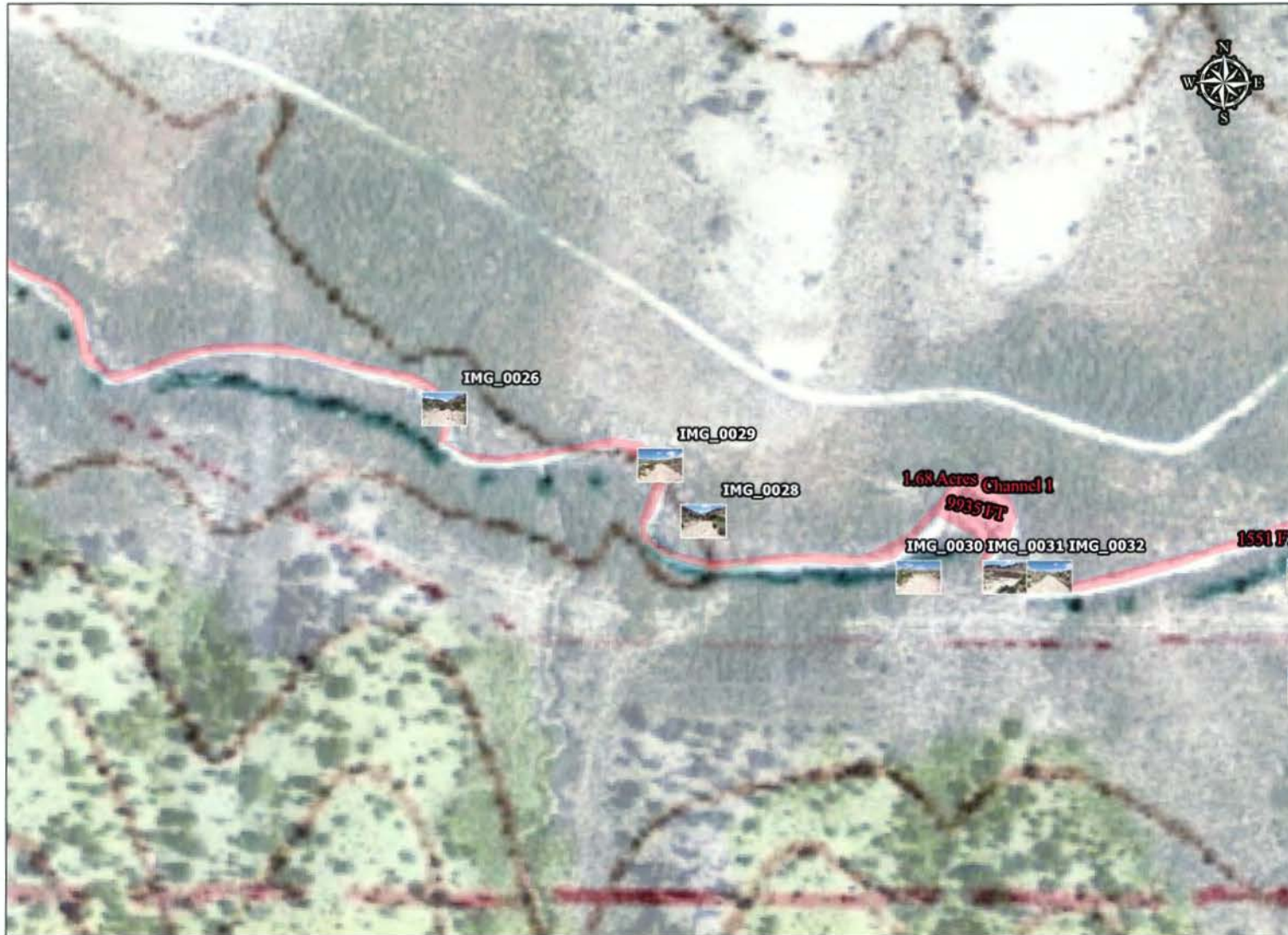

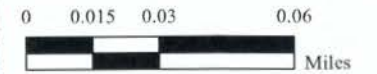


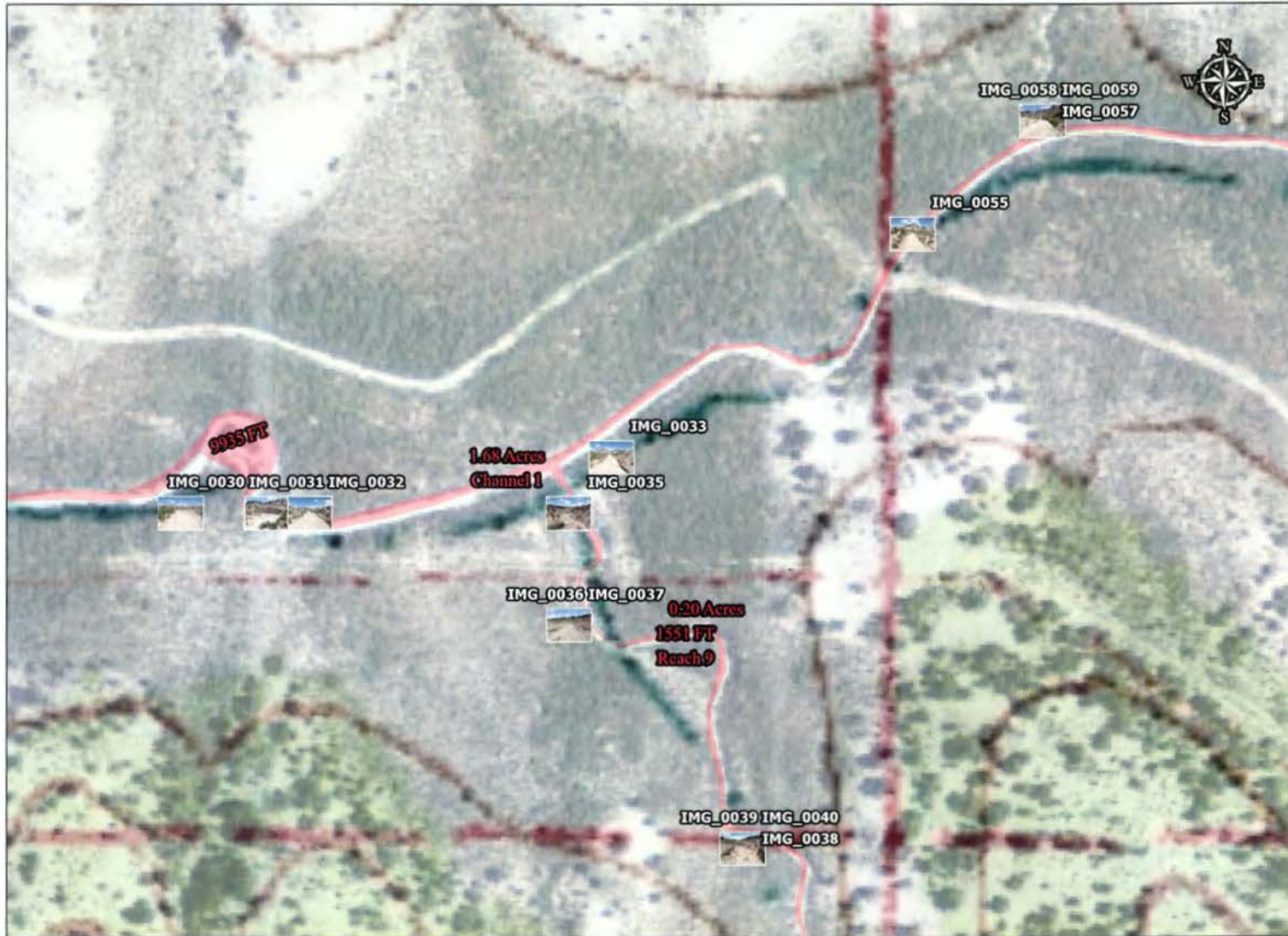

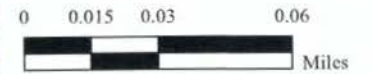

**UINTAH COUNTY, UTAH**

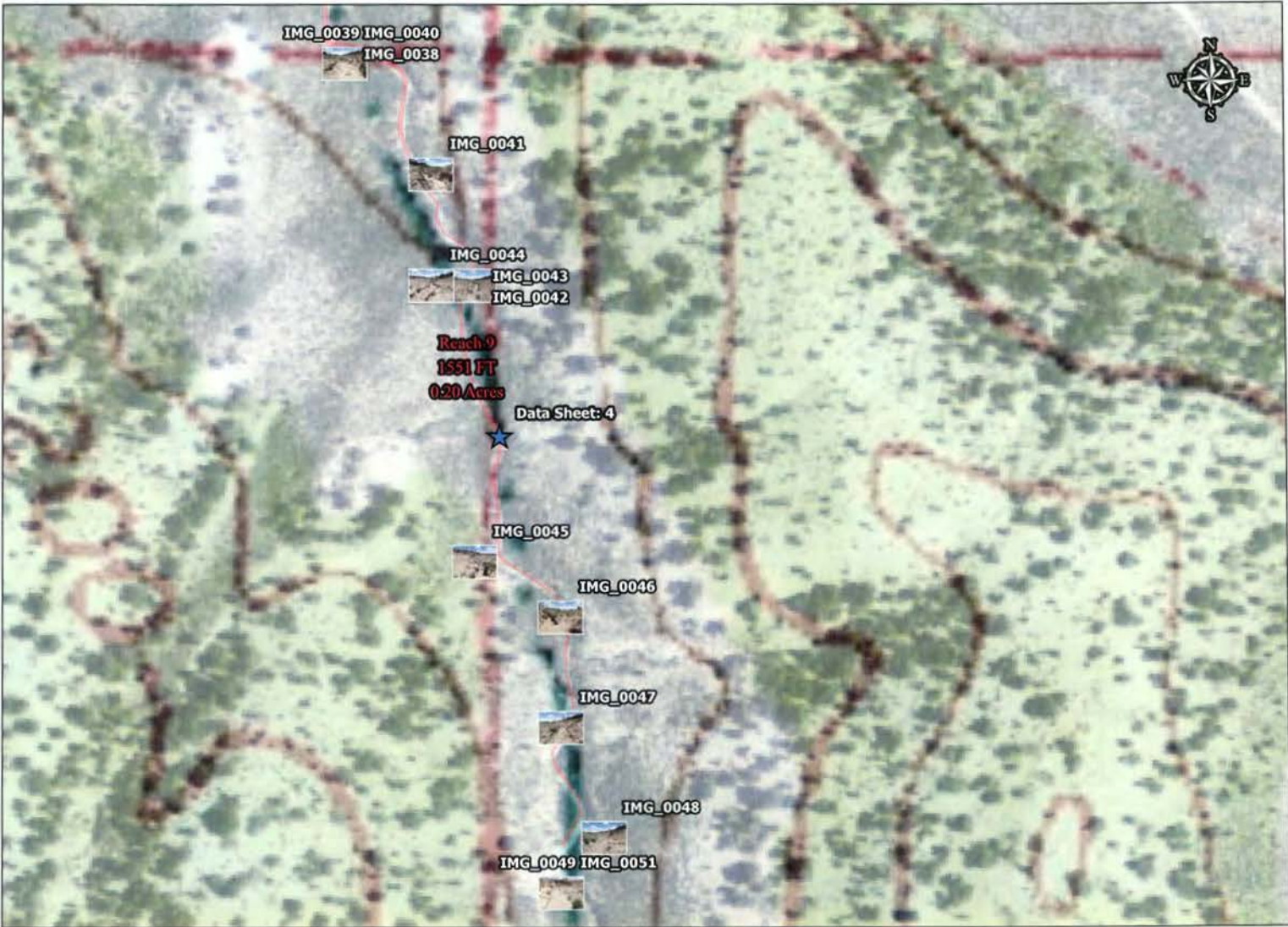

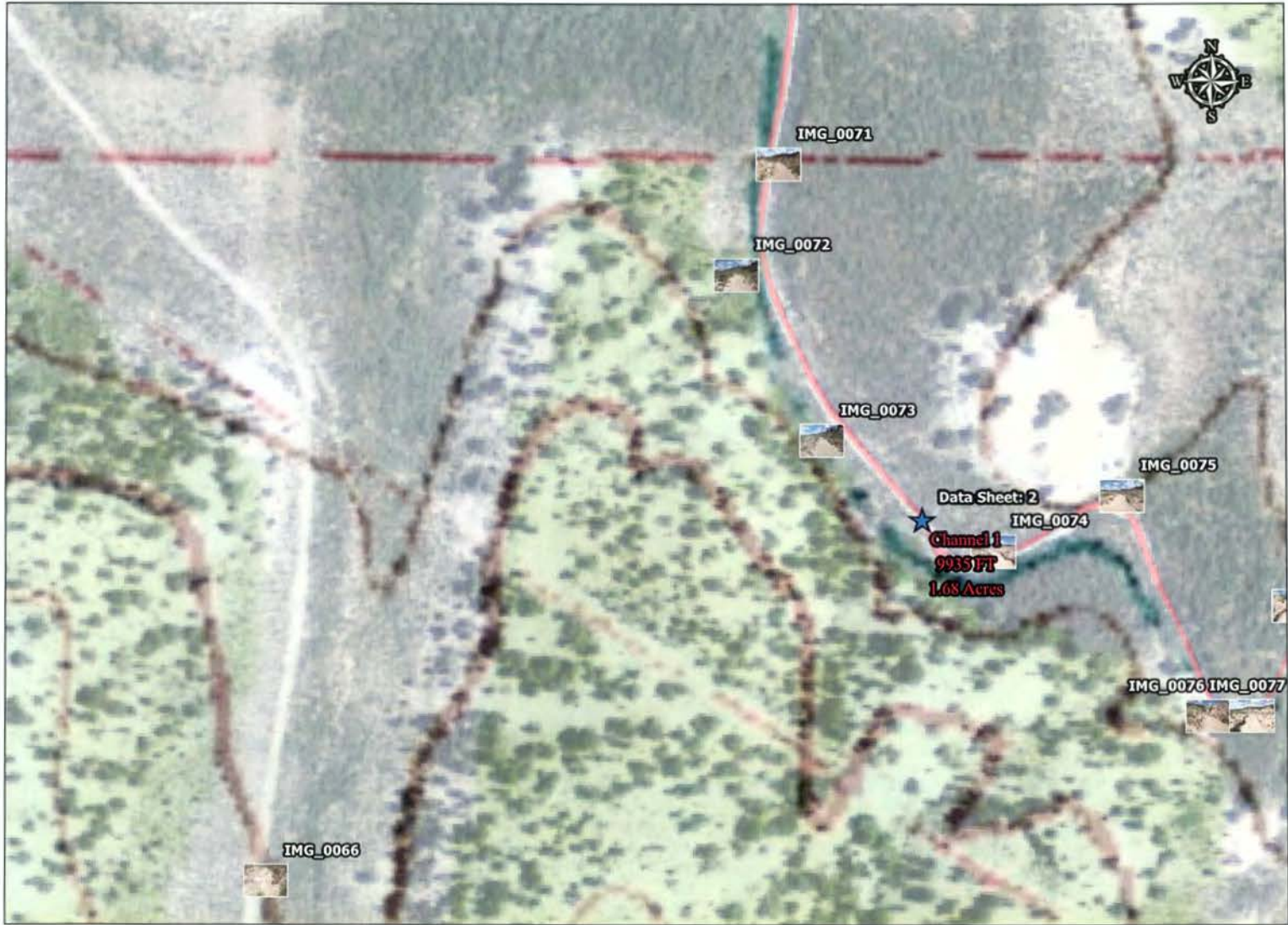

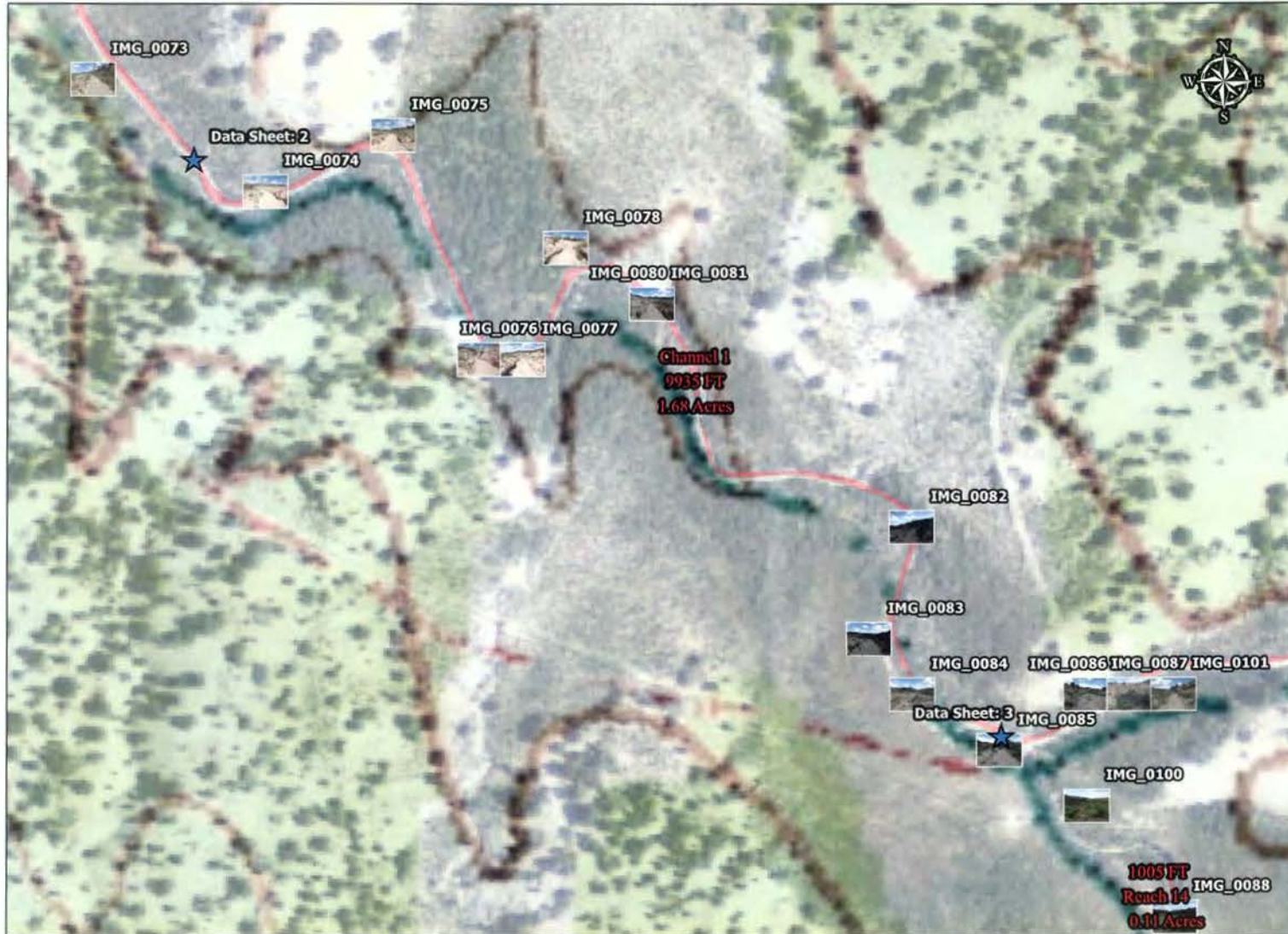

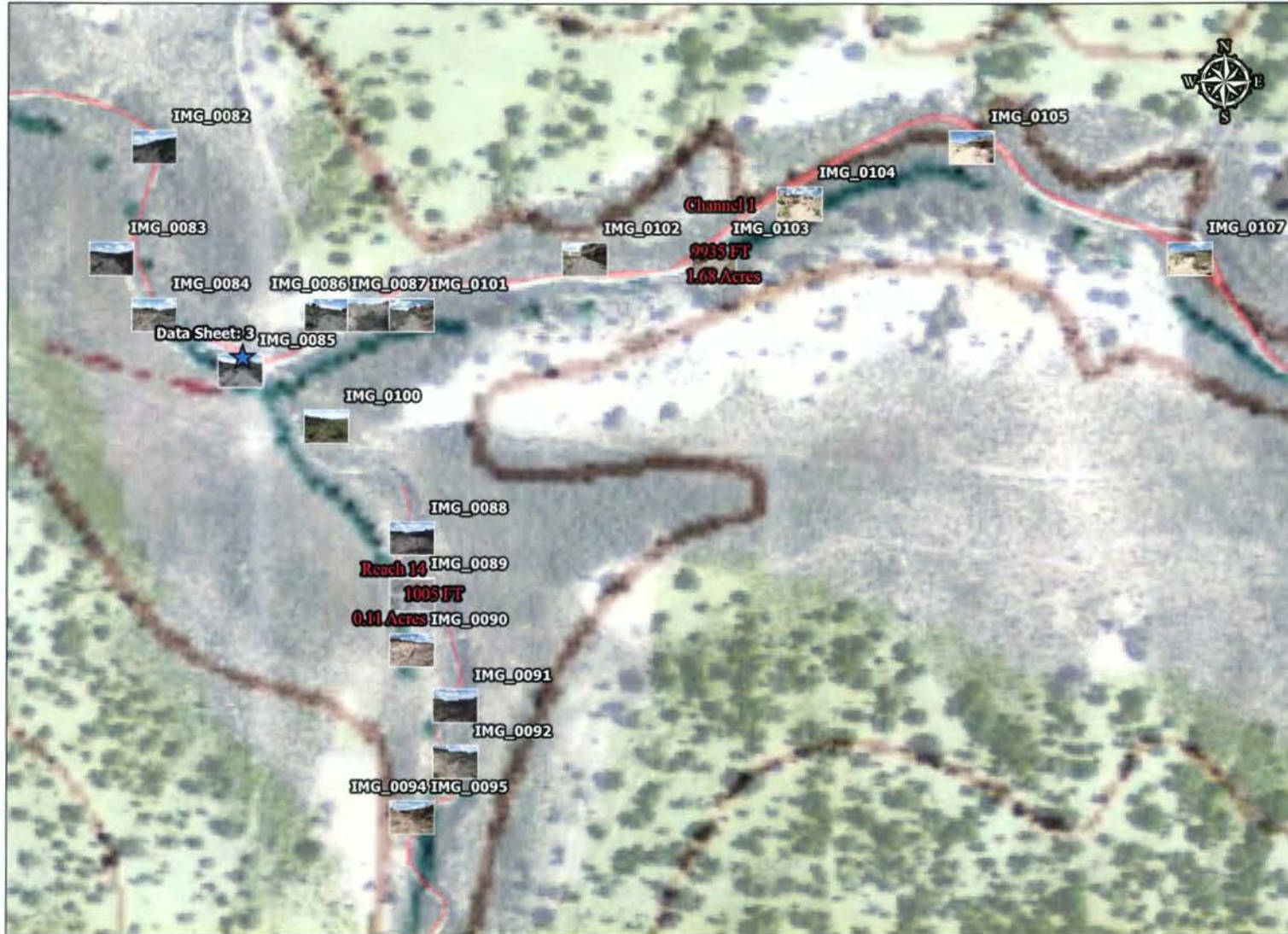

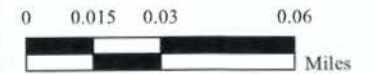


**FIGURE 10**

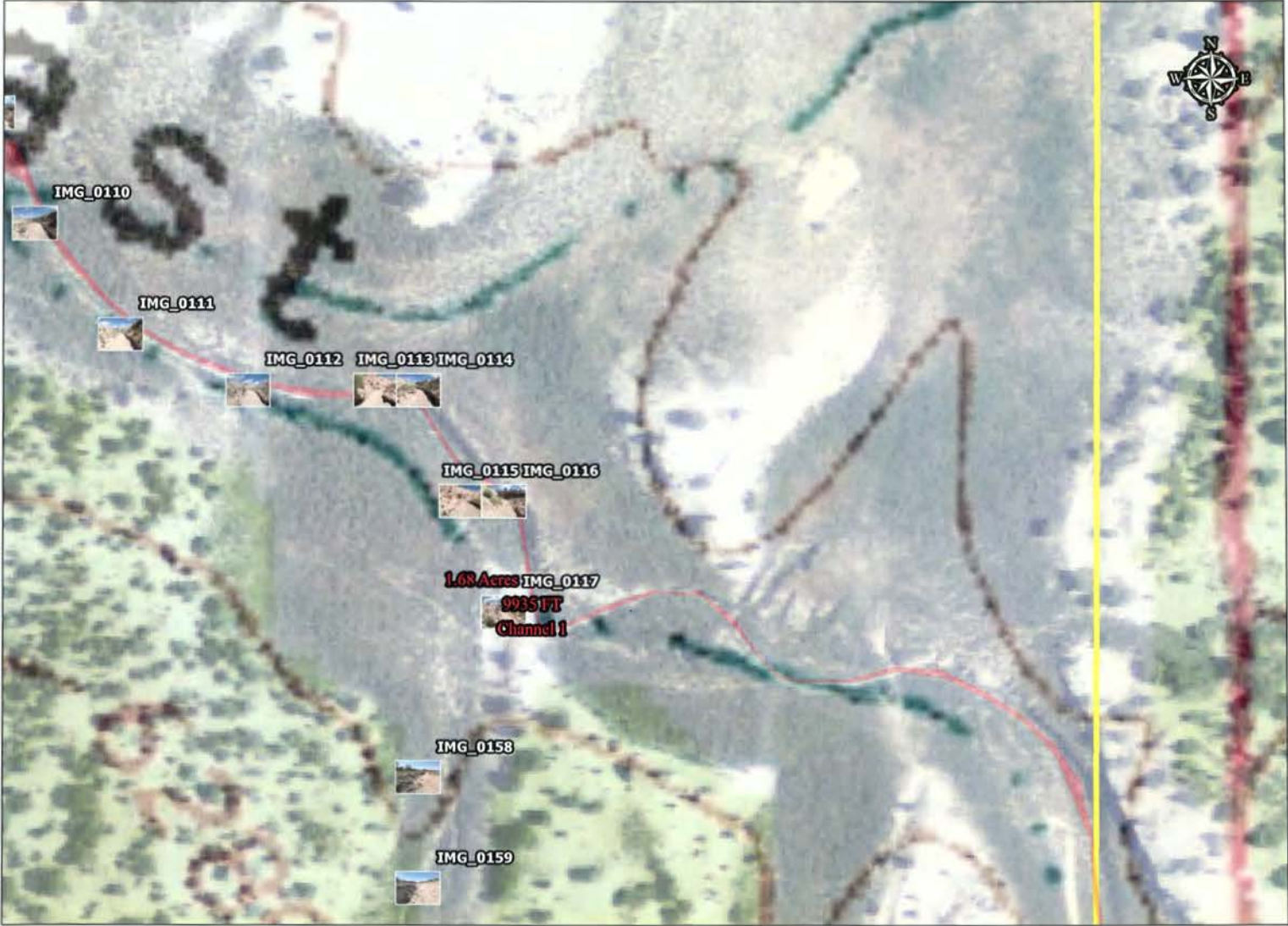
**FIGURE 11**

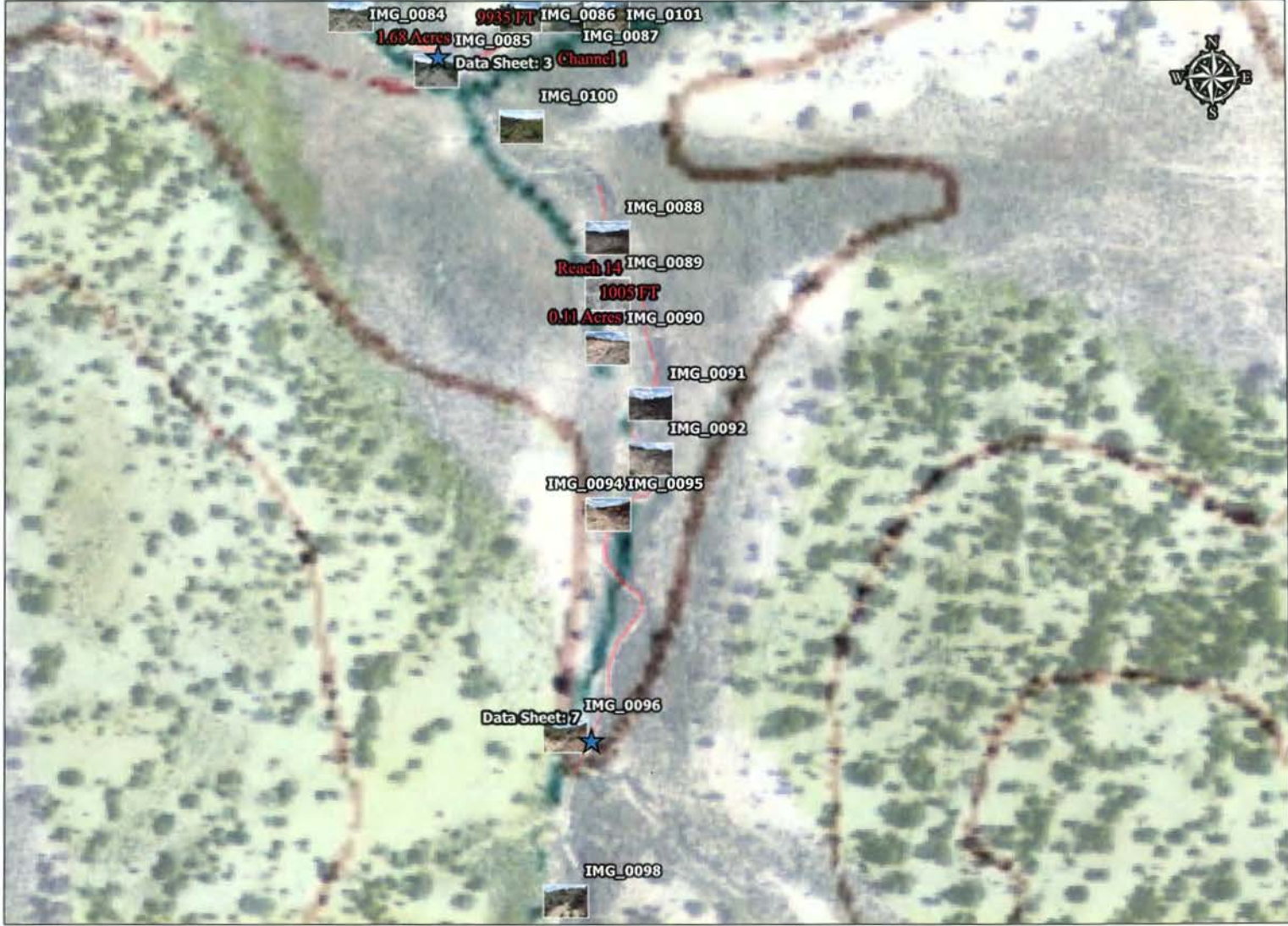


**FIGURE 12**
