C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Sediments, nutrients and pollutants in these channels would flow into Coyote Wash and then into the Green River. The flow path for Coyote Wash is depicted in Exhibits 2 and 3. The flowpath of the other ephemeral channels within the Coyote Wash Drainage are depicted in Exhibits 4 and 5.

The other ephemeral channels, listed below, within the project area that had continuous OHWM are tributaries to Evacuation Creek which is an ephemeral channel that is tributary to the White River, a perennial tributary to the Green River.

Sediments, nutrients and pollutants in these channels would eventually flow into the White River and then the Green River. The flow paths for these channels to Evacuation Creek and the White River are depicted in Exhibits 6-8.

The drainage area of approximately 1000 sq mi within the project area would capture a significant volume of water and would be more than a speculative or imperceptible contribution to the flows in the Green River.

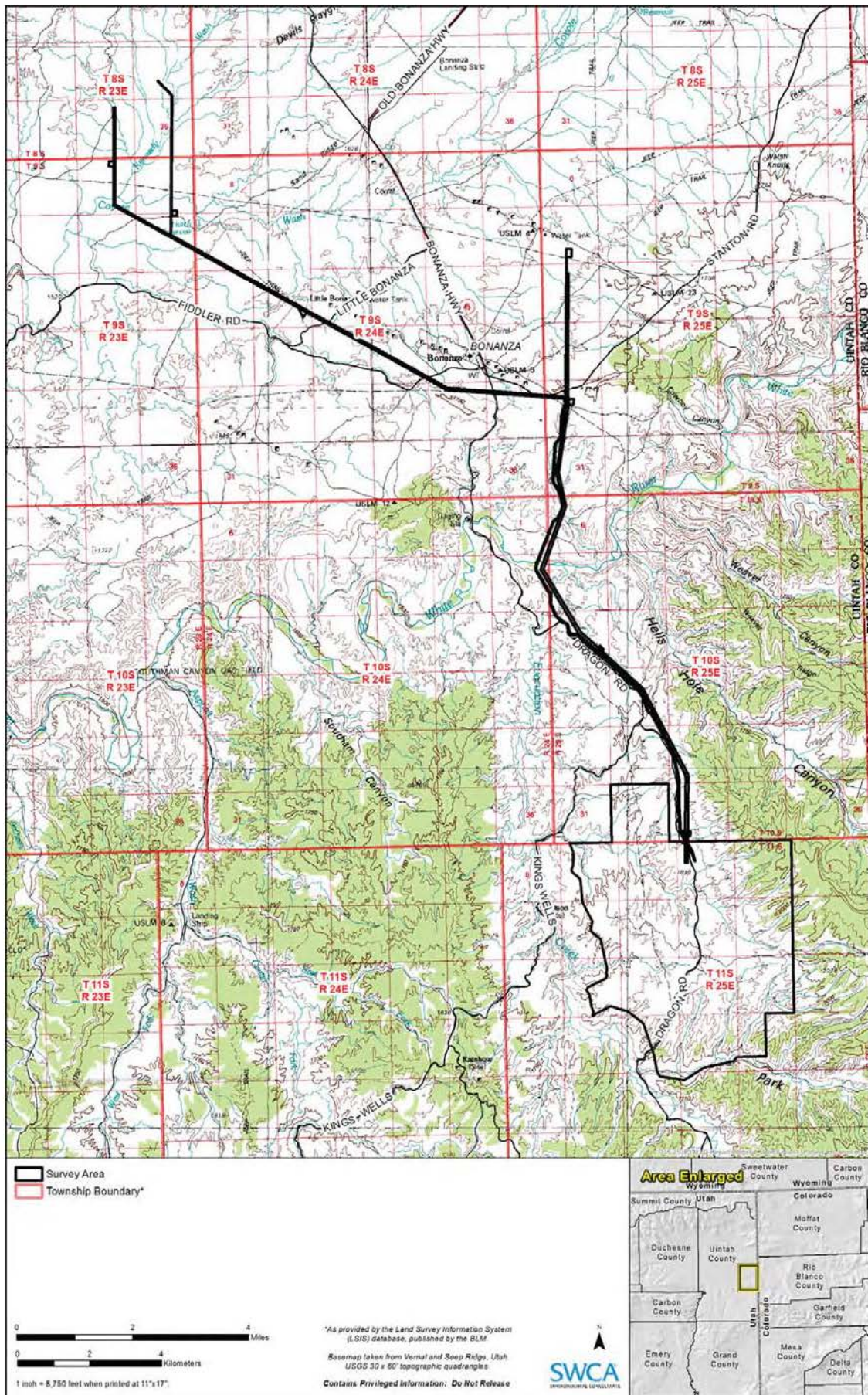


Figure A-1. Project location.

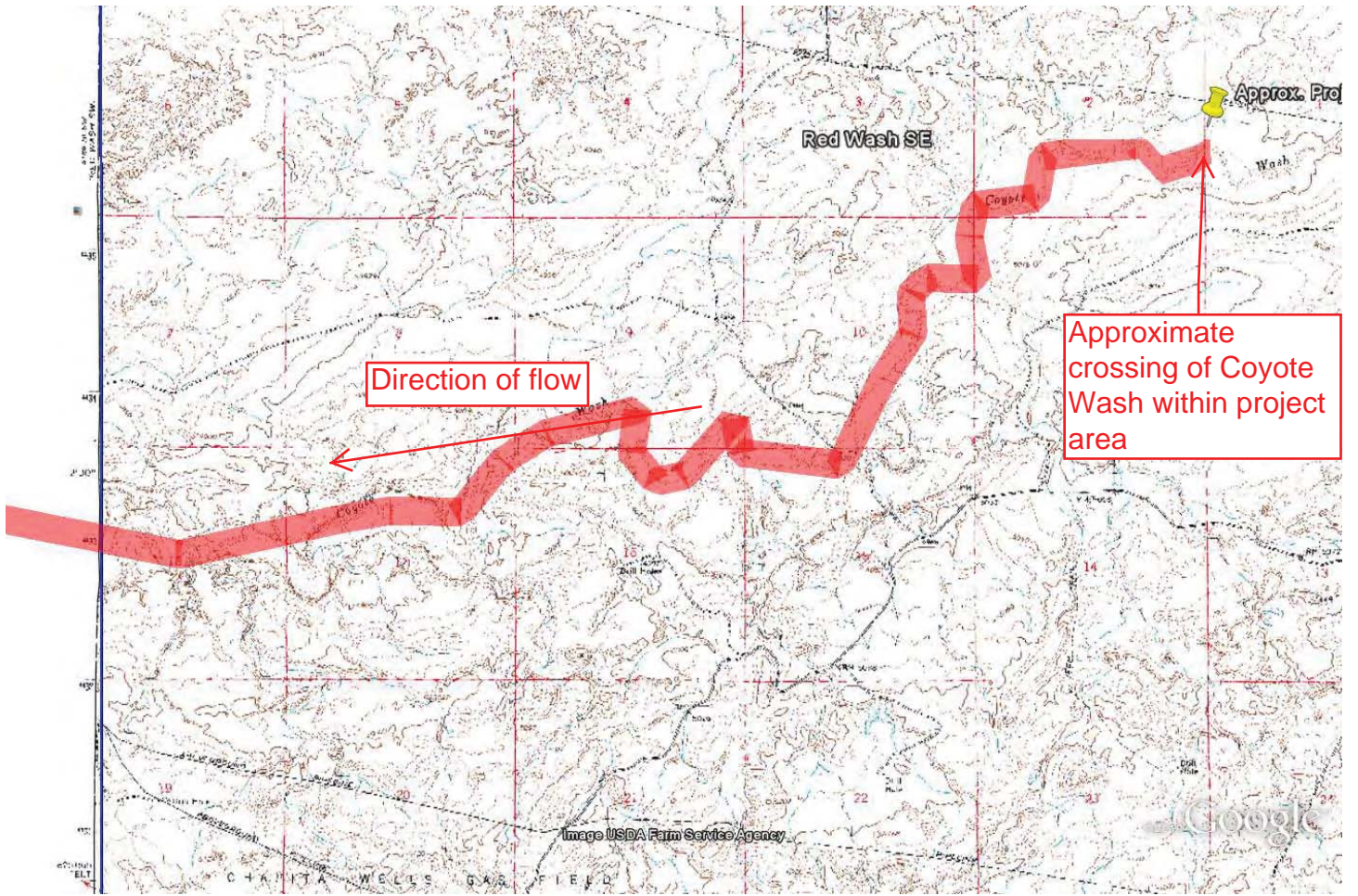


Exhibit 2. Coyote Wash flow path to White River.

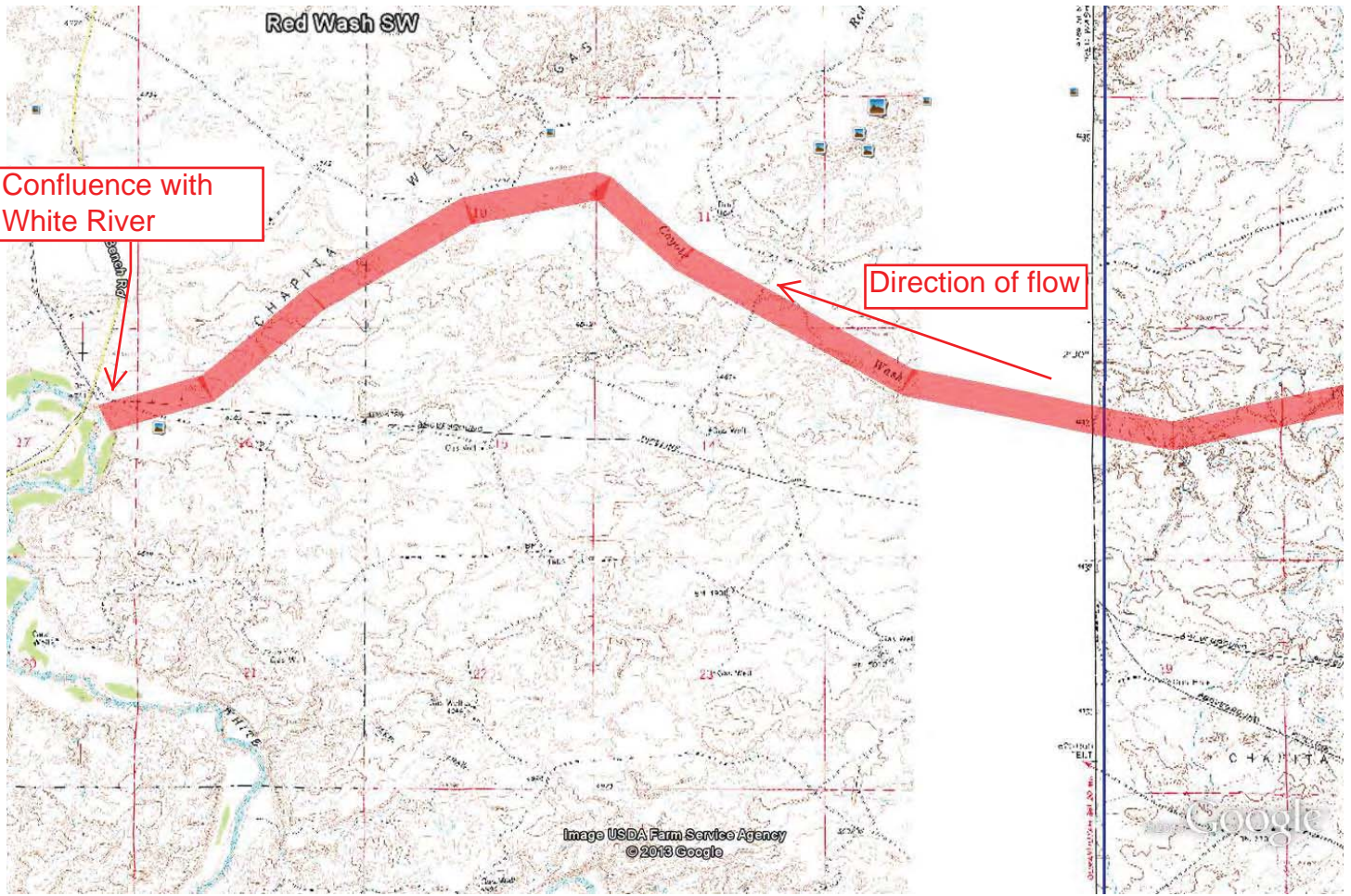


Exhibit 3. Coyote Wash flow path to White River (cont'd).

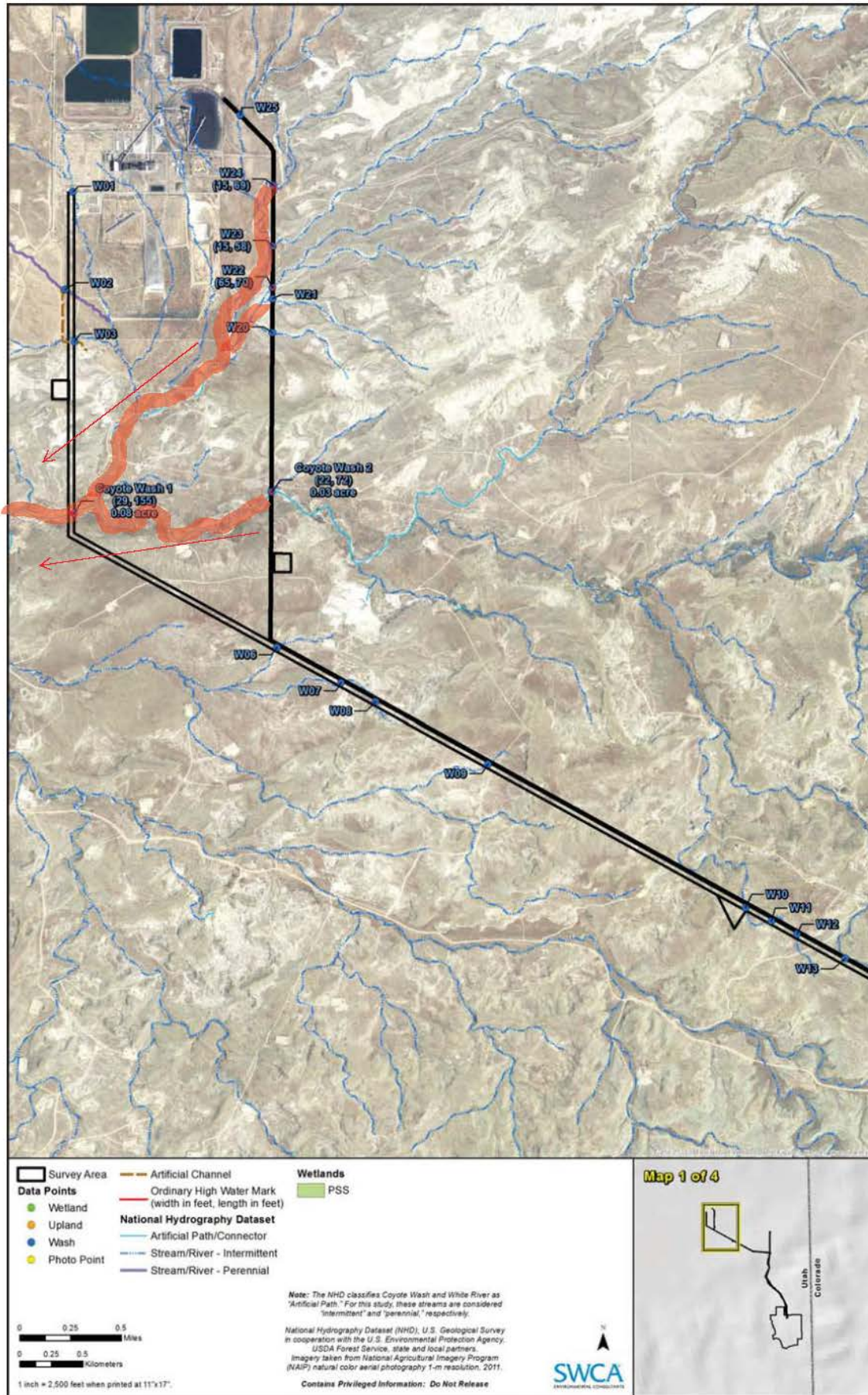


Figure A-5.1. Wetlands delineation results overview (map 1 of 4).

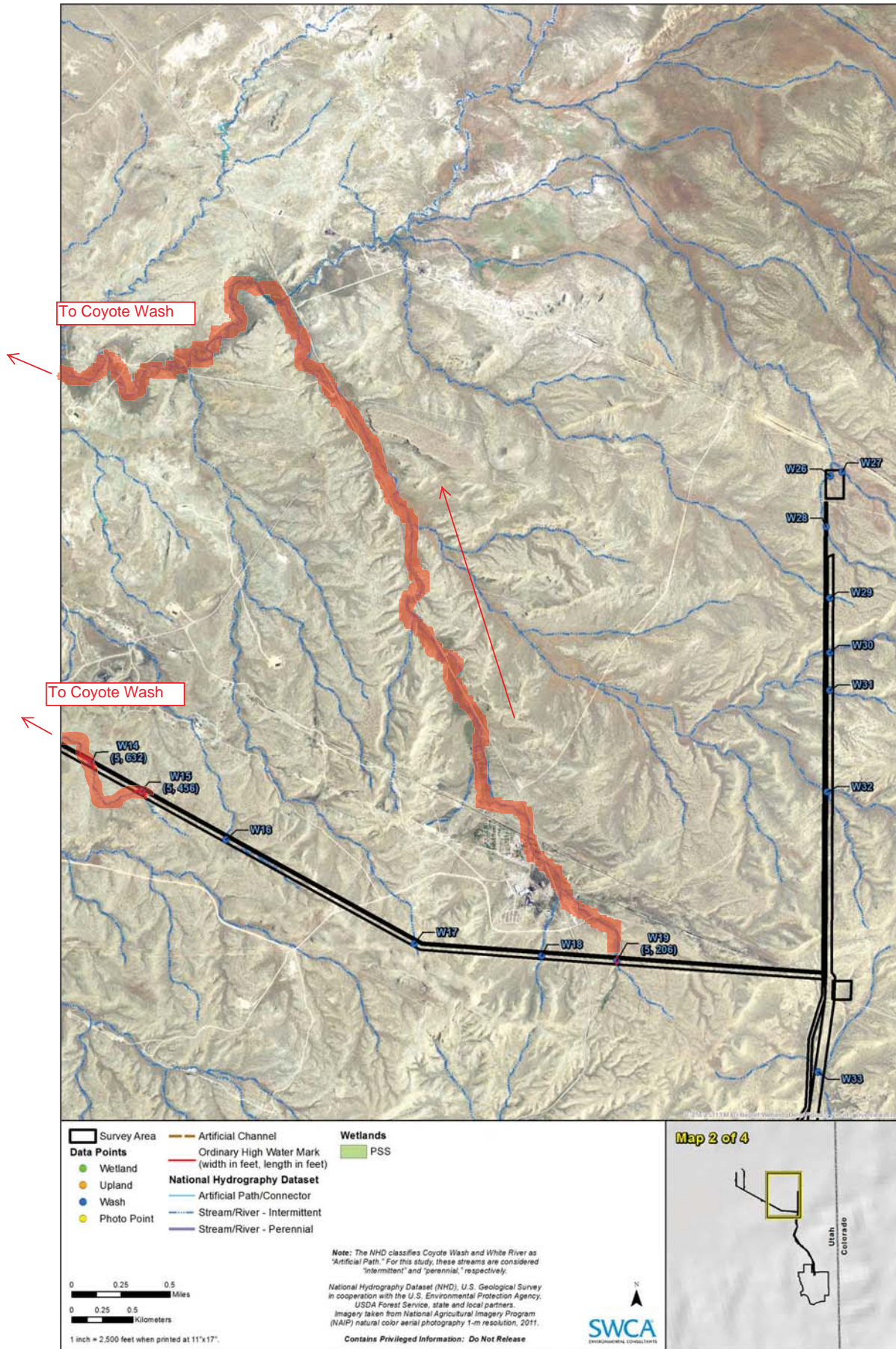


Figure A-5.2. Wetlands delineation results overview (map 2 of 4).

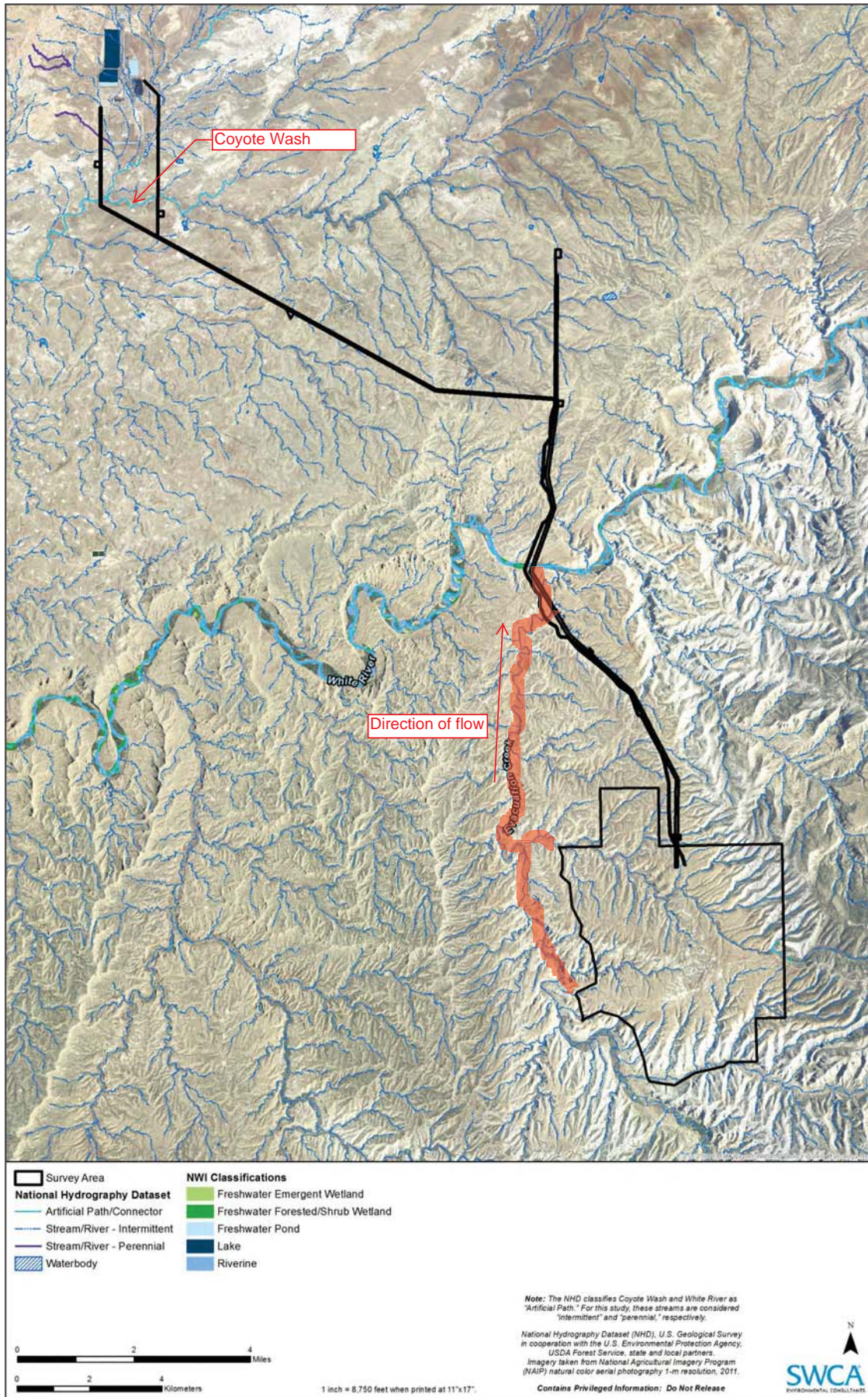


Figure A-2. Hydrology: National Wetland Inventory and National Hydrography Dataset findings in and near the survey area.
