since irrigation on the property ceased. It is dominated by coyote willow (*Salix exigua*) and reed canarygrass (*Phalaris arundinaceae*). The wetland contains the Thick Dark Surface (A12) hydric soil indicator and was saturated during the April 10, 2014 delineation survey. The wetland is in a depressional area and is surrounded by open field that was previously cropland. No culverts leading into or out of the wetland were observed during the site visit, therefore the wetland is likely groundwater driven. The closest RPW to the wetland is the ditch that runs along the eastern boundary of the site which is upgradient of the wetland and over 1,000 feet away. The closest TNW to the wetland is the Great Salt Lake, which is over 6,500 feet away. The Corps assessed the wetland's capacity for interstate commerce, however, no evidence to support that capacity was found.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

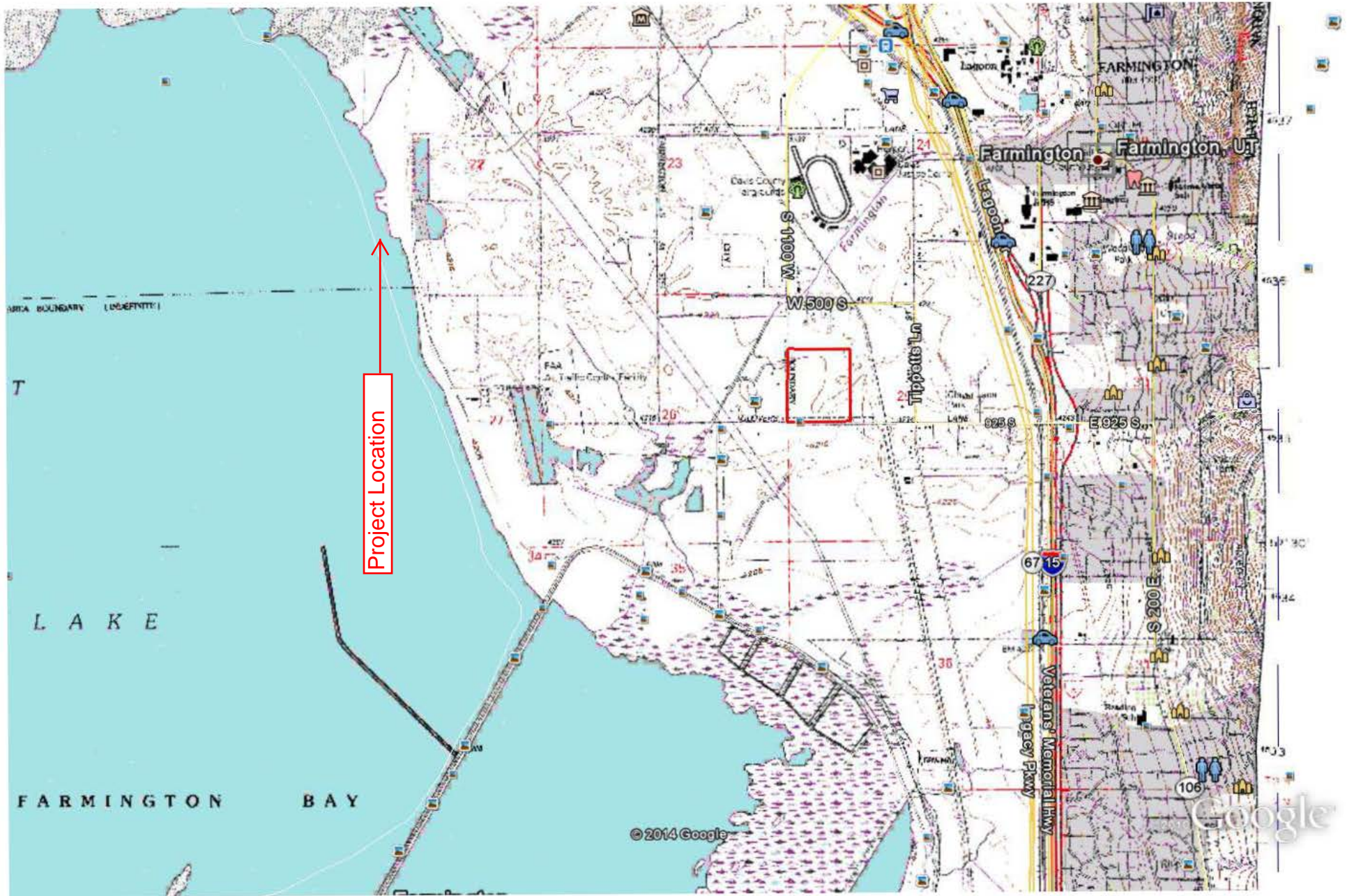

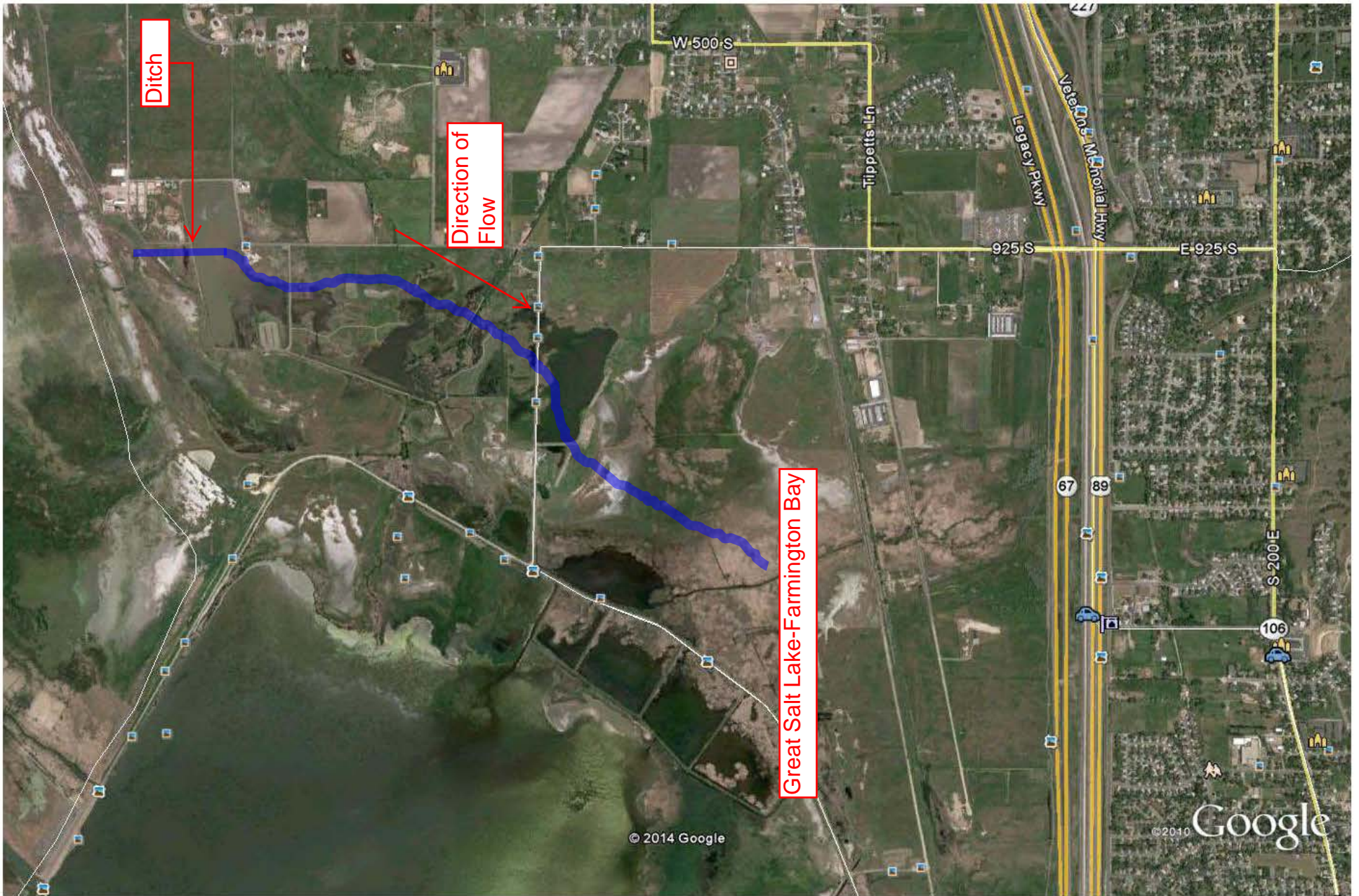
