Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The project site contains several ephemeral washes, canals, excavated earthen and concrete lined irrigation ditches and erosional features. The erosional features and some of the ditches have no ordinary high water mark (OHWM) indicators. The channels that do exhibit an OHWM, including the**

unnamed intermittent stream, EC1, EC2, EC3, EC4, D1, D2, D3a, D4, D6, CD1, CD2, CD3, CD4 and CD5 are either irrigation channels or are intercepted by irrigation channels, all of which terminate in nearby agricultural fields and dairy farms. Each individual feature was thoroughly investigated and found to have no connection to a downstream jurisdictional feature. All features on site have been highly disturbed and manipulated to capture and redirect all flows for agricultural purposes. Piute Canal is a man-made canal, constructed in uplands, which runs through the southwestern project boundary, then flows north approximately 29 miles and terminates in stock ponds 1 mile west of Yuba Reservoir. Outlet structures release water from the canal periodically along the northward path to adjacent farm fields. Each outlet was investigated and no connection to jurisdictional waters exists along the entire reach of Piute Canal from the project area to where it terminates. The Corps has determined that all features with OHWM are interstate, isolated features with no known interstate or foreign commerce connection and are non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
