a playa lake bed at its lowest elevation. The Quinn River flows from the North into the Black Rock Desert where it becomes a series of dry wash channels. The Quinn River is the primary tributary within the basin. Annual average precipitation at Gerlach, Nevada (the nearest weather station) is 7.83 inches. Most of the precipitation occurs between November and June within approximately 1 inch of rainfall falling per month in November, December, January, and May.

Within the 24,156-acre study area fifty channels were evaluated for evidence of an ordinary high water mark. Eleven of those channels (totalling 107,850 linear feet) had ordinary high water marks within the project area including Channel 1 (42,233 linear feet), Channel 8 (12,851 linear feet), Channel 12 (10,561 linear feet), Channel 18 (6,294 linear feet), Channel 19 (7,930 linear feet), Channel 27 (6,051 linear feet), Channel 32 (352 linear feet), Channel 33 (2,156 linear feet), Channel 34 (772 linear feet), Channel 35 (549 linear feet), and Rabbithole Creek (18,101 linear feet). The total length of all channels with ordinary high water marks is 107,850 linear feet with widths ranging between 18 and 84 inches and are labeled on Figure 5 of the attached drawings. No wetlands occur within the project area.

Channels 1, 8, 12, 18, 19 and 32 flow into the same channel, which was determined in an Approved Jurisdictional Determination issued on March 9, 2011 to be an intrastate isolated water with no apparent connection to interstate or foreign commerce (channel 16 in the August 2010 delineation report). These channels also lack any apparent connection to interstate or foreign commerce and are also isolated.

Channels 27, 33, 34, 35 and Rabbithole Creek flow into the same channel approximately 1.25 miles north of the project area. Based on aerial photography it appears that this channel converges into the same single channel that Channels 1, 8, 12, 18, 19, and 32 flow into, which terminates in the Black Rock Desert approximately 10 miles north of the project area. These channels are all isolated, intrastate waters that lack any apparent connection to interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

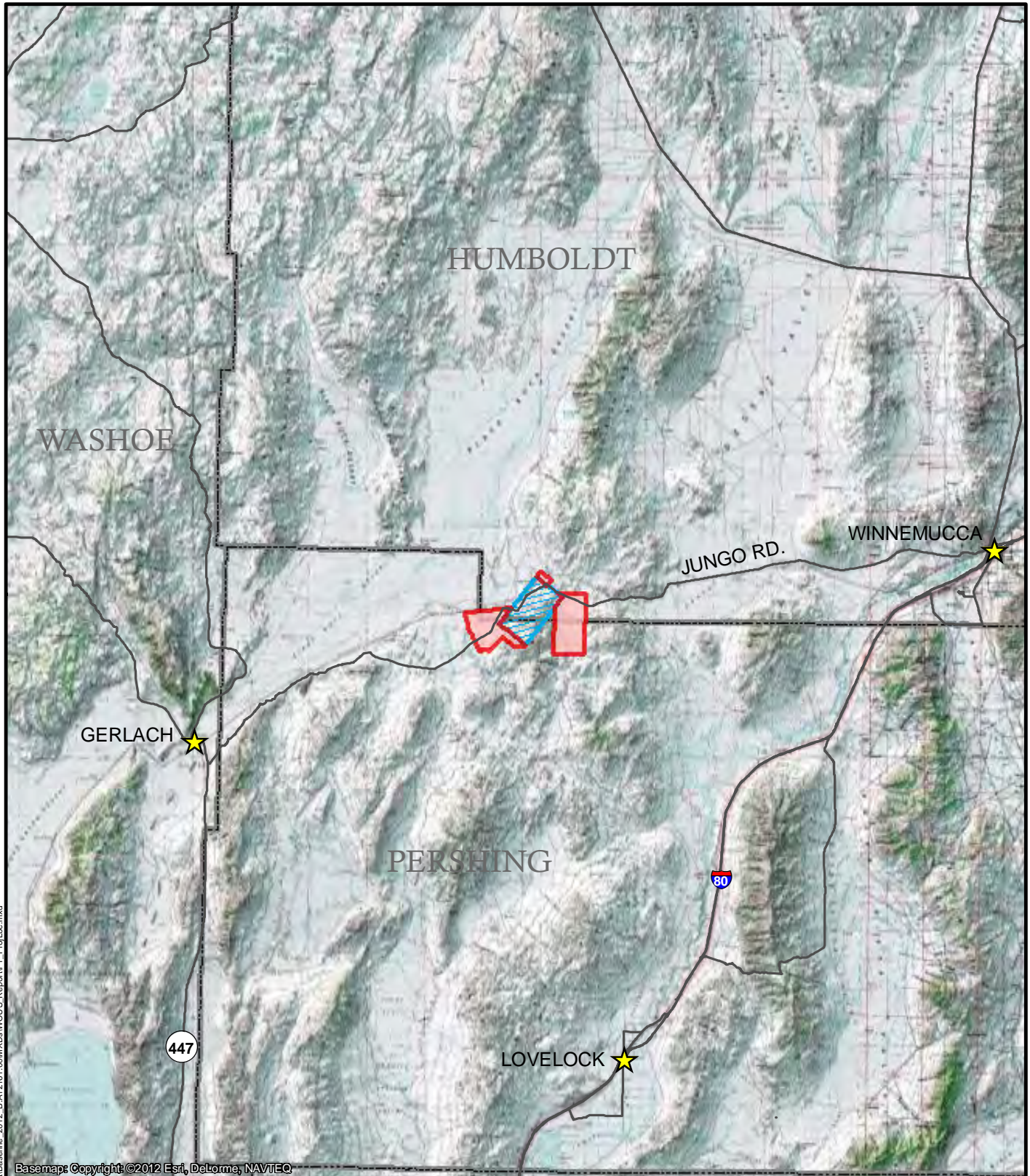

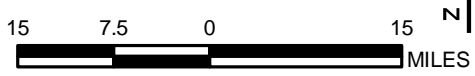

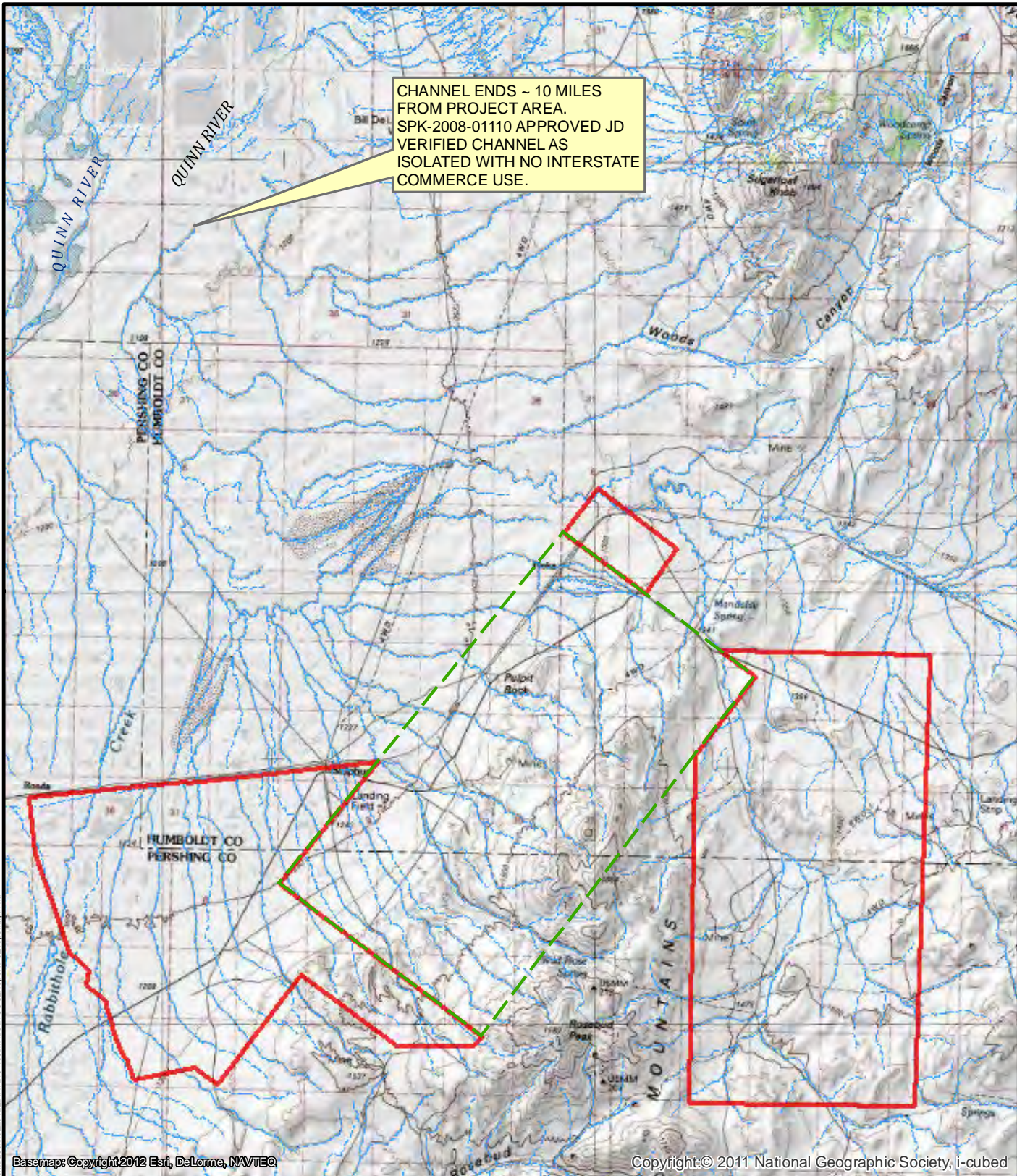
**FIGURE 1

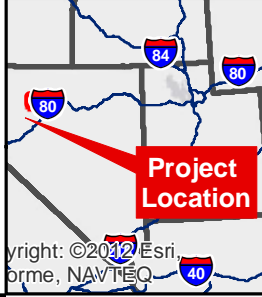

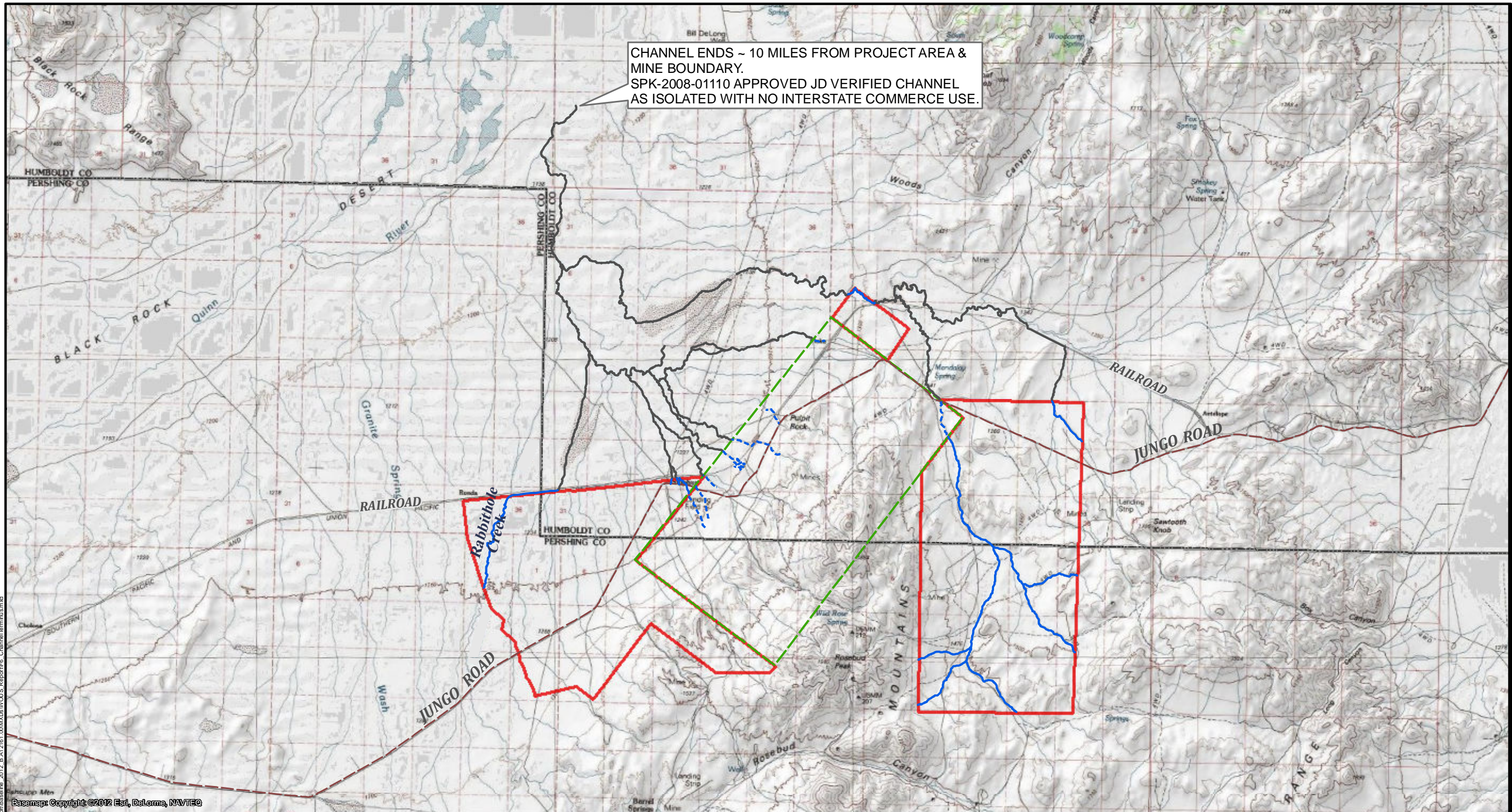
