**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**One isolated ephemeral channel and seven isolated wetlands were identified in Crescent Valley. Of the seven previously verified channels (Channels 1 - 7), Channel 3 was the only channel with an OHWM. The other channels no longer exist, no longer carry flow, or were probably misclassified as having an OHWM in previous surveys. Several new anthropogenic disturbances affecting previously delineated features were detected. These disturbances were made according to the Cortez's POO. A cross-valley transfer conveyor belt and haul road has intersected Channels 3 and 4 preventing them from continuing further down the valley. These drainages enter a detention basin upgradient of the conveyor belt and haul road. Channel 5 is located in Cortez Canyon, which has been filled consistent with Cortez's POO. The relocation of a county road appears to have diminished flows in Channel 6. The remaining channel 3 within the project area was previously determined to not have physical connection with downstream flows that may reach the Humboldt River except in periods of large (100 year) storm events.**

Near the center of the POO area within Crescent Valley, wetlands (27-48-19-24; 27-47-35-32; 27-48-30-421; 27-48-30-423; 27-48-30-412; 27-47-36-433; 26-47-01-214; and 27-48-30-44) were delineated in the Toiyabe Mountains. Wetland 27-47-35-32 directly abuts previously delineated channel 6 which no longer exhibits an OHWM. Wetlands 27-47-36-433 and 26-47-01-214 directly abut channel 5 above where the channel has been filled as part of the POO. Wetlands 27-48-19-24; 27-48-30-421; 27-48-30-423; 27-48-30-412; and 27-48-30-44 are adjacent to but do not directly abut channel 8 which no longer exhibits an OHWM.

Channel 3 is an intrastate, isolated non-navigable water. Wetlands 27-48-19-24; 27-47-35-32; 27-48-30-421; 27-48-30-423; 27-48-30-412; 27-47-36-433; 26-47-01-214; and 27-48-30-44 are intrastate, isolated non-navigable waters with no significant nexus to a traditional navigable water of the U.S.

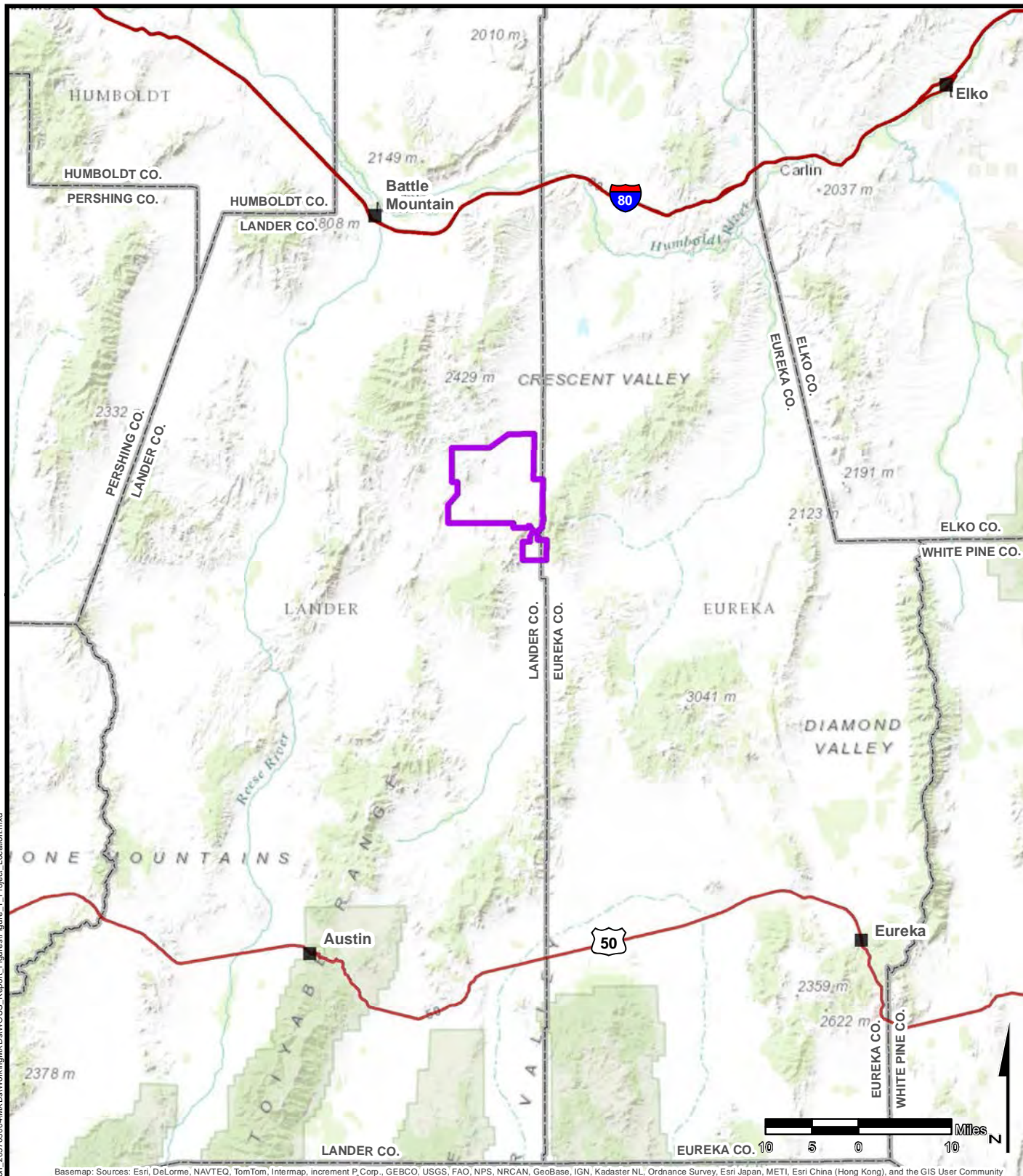
Five isolated ephemeral channels were identified in Grass Valley. The seven isolated ephemeral channels that had been previously verified by the USACE were revisited. The channels GV-4 and GV-5 no longer exist, no longer carry flow, or were probably misclassified as having an OHWM in previous surveys. New disturbances affecting previously delineated channels were detected. A borrow pit intercepts channels GV-1, GV-3, and GV-7 preventing them from continuing further downgradient in the valley. All of the channels drain to Grass Valley which is an intrastate closed basin with no connection to a TNW.

Channels GV-1, GV-2, GV-3, GV-6 and GV-7 are intrastate, isolated non-navigable waters.

Channels GV-1, GV-2, GV-3, GV-6 and GV-7 within the Cortez Mine project area were previously determined to not drain to the Humbolt River but the large playa within Grass Valley.


The channels are associated with the Cortez Gold Mine (which has interstate commerce), as they could be impacted/filled due to road crossings and tailings piles. However, the mine operation does not derive the gold from these drainages and thus the degradation of these aquatic resources would have no affect on the mine and thus no adverse impact on interstate commerce. Additionally, there are no fisheries of any type, there are no sand and gravel operations or any other commercial endeavor being conducted on the surface waters of these watersheds.

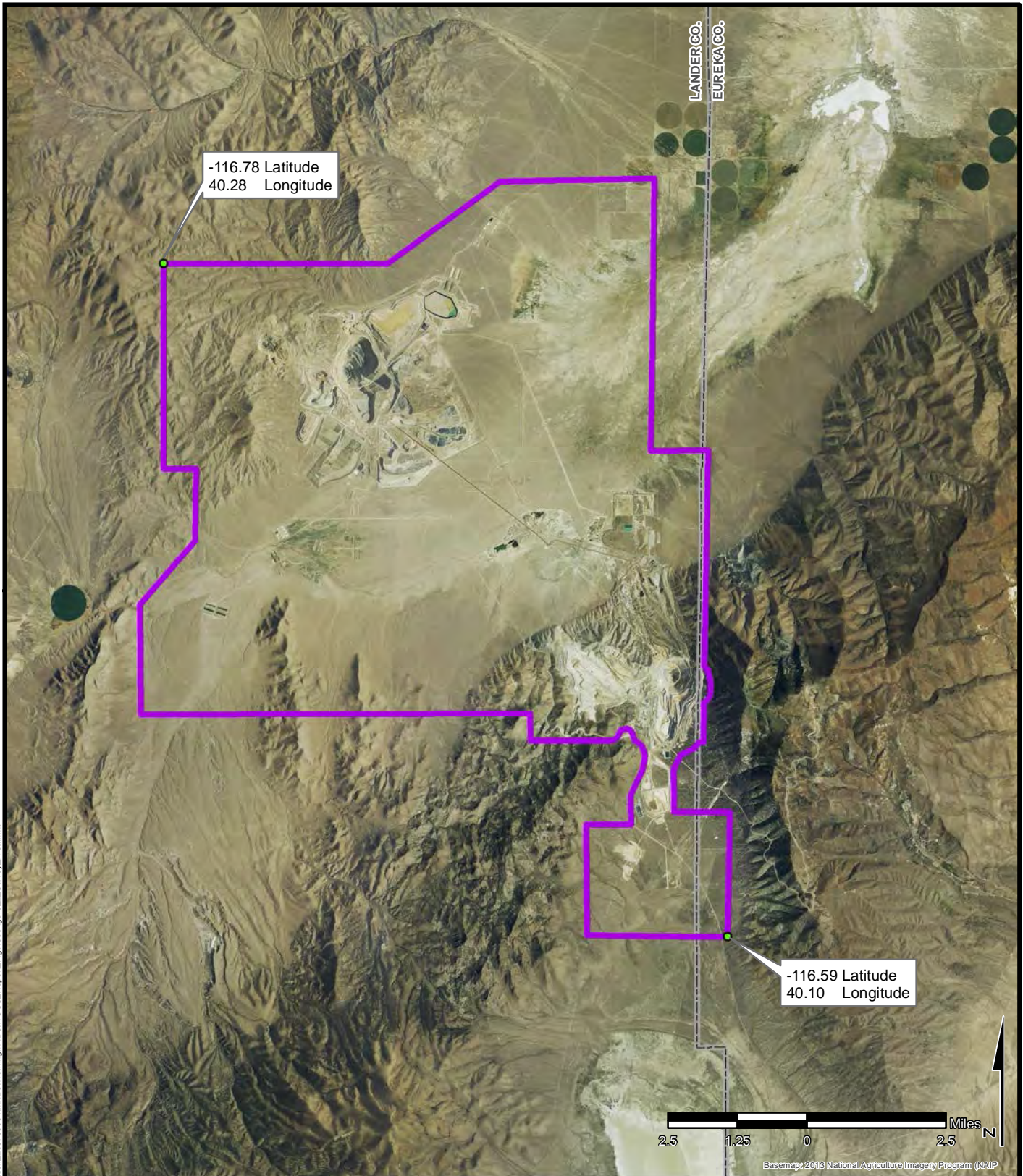

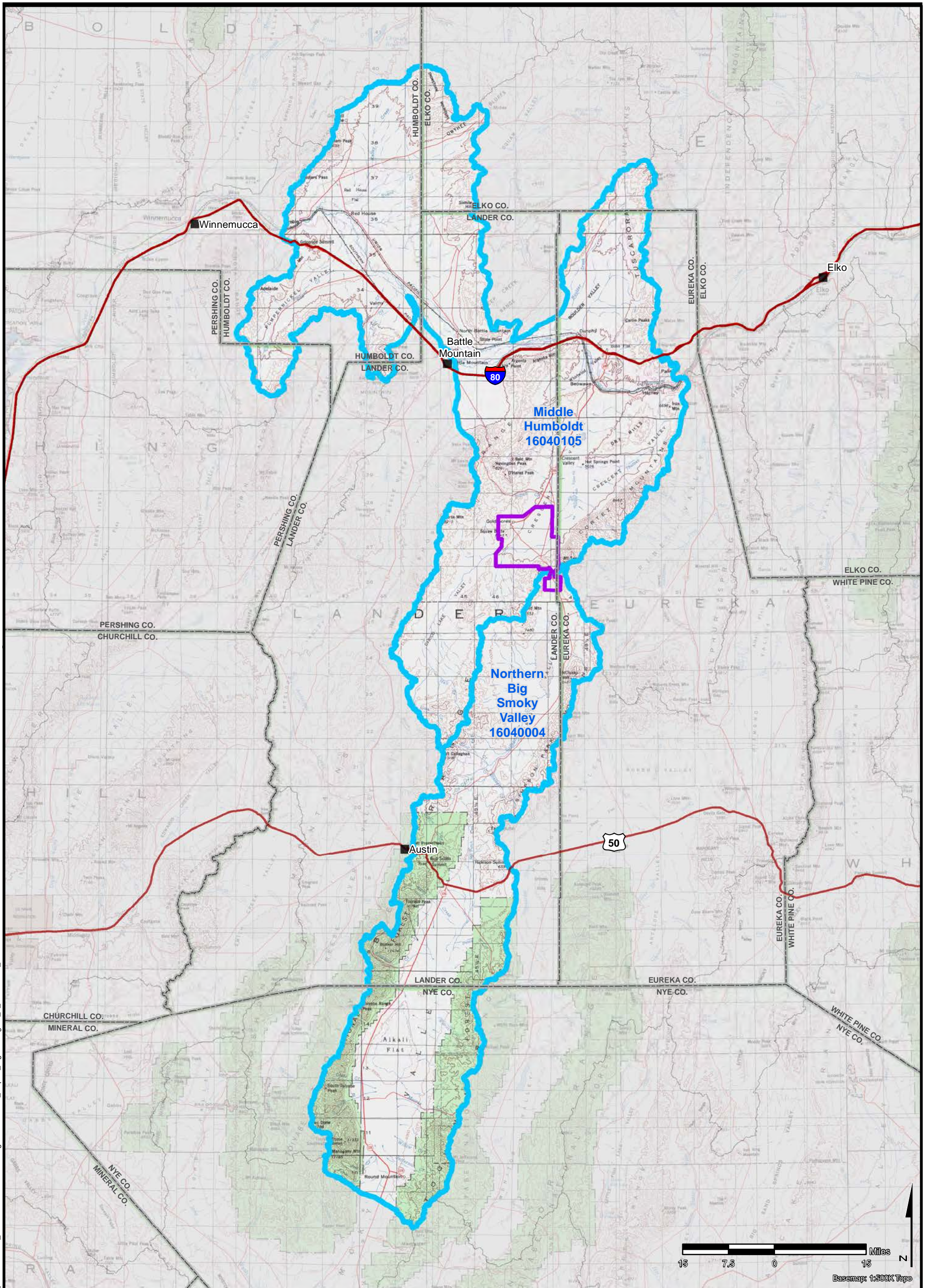

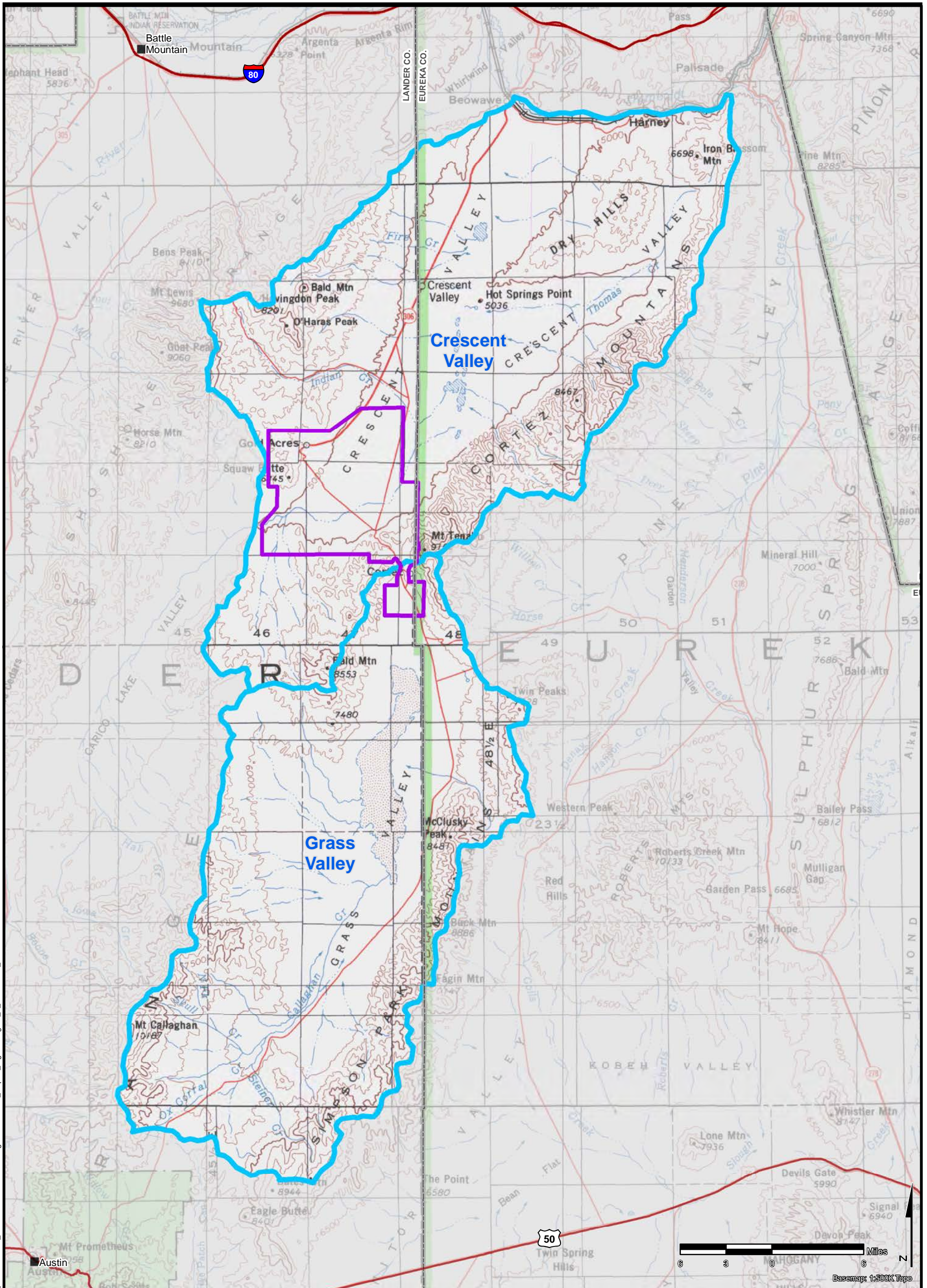

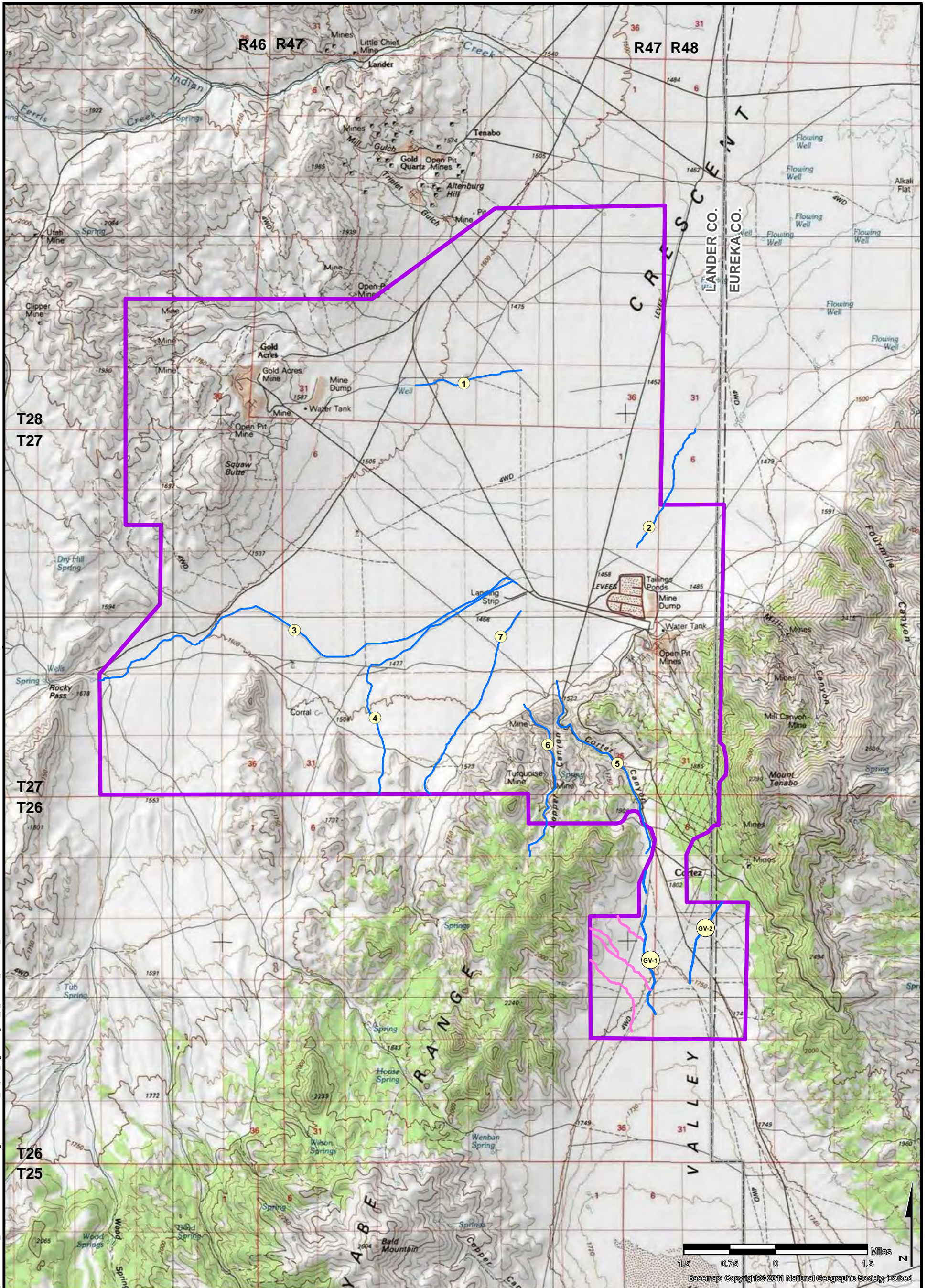

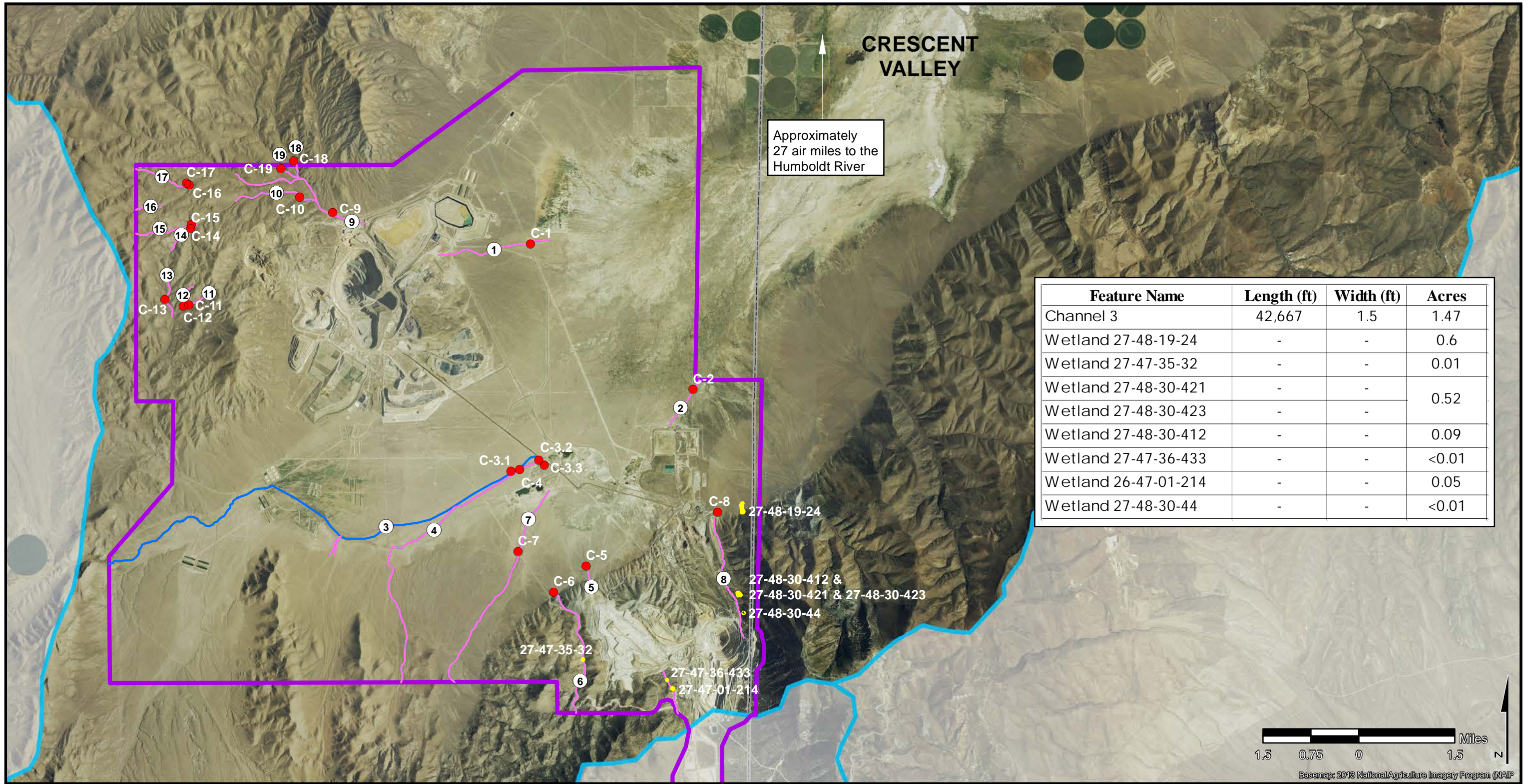

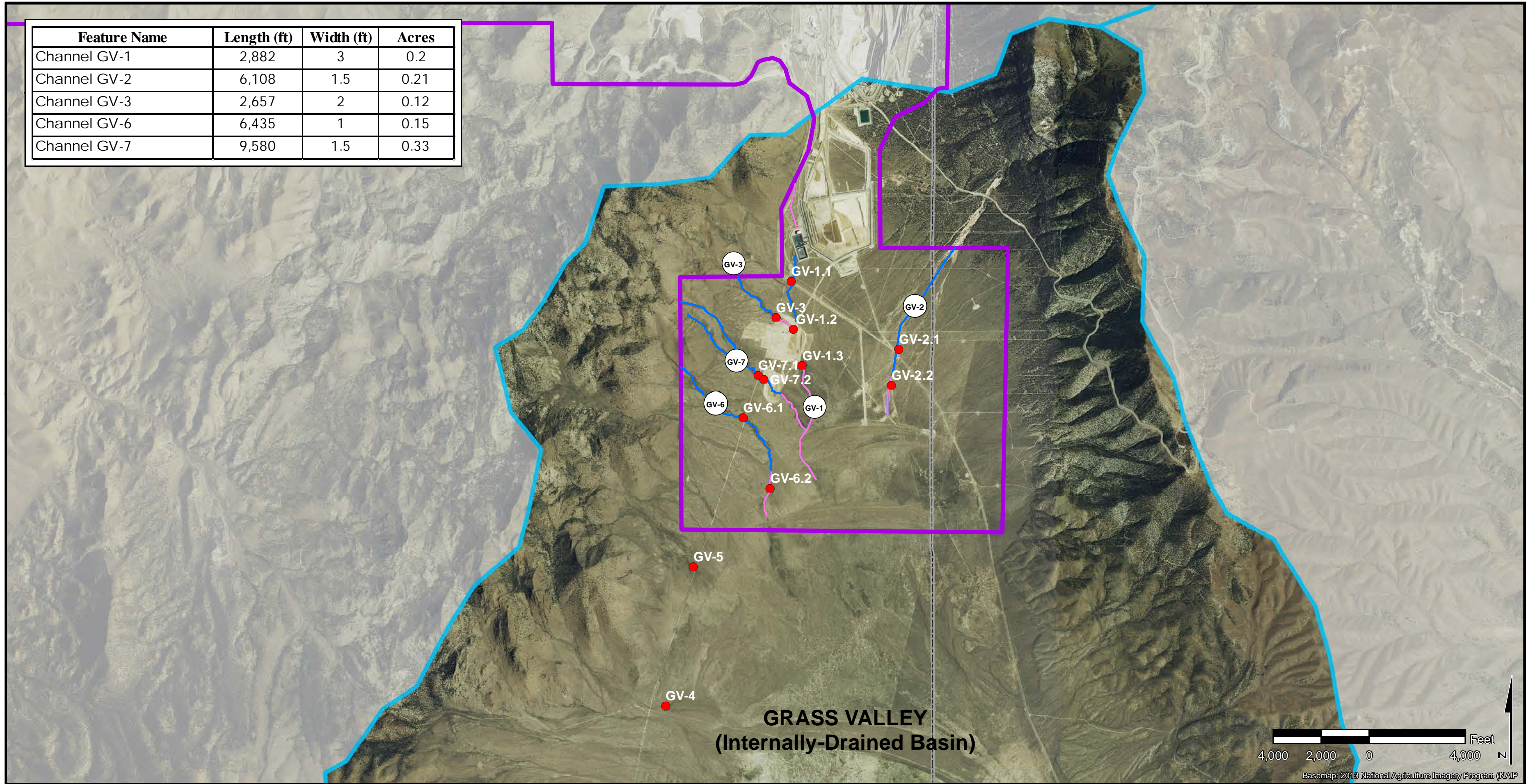
