This canal includes several water control features and diversions, and terminates in upland agricultural fields. In addition, two isolated wetlands exist in the survey area. Wetland 1 (W01) is a 0.01 acre, palustrine scrub shrub wetland which is adjacent to the aforementioned irrigation canal, and has been created as a result of pooling from a nearby water pump in a depressional area. Wetland 2 (W02) is a palustrine emergent wetland, adjacent to the same irrigation canal, and has likely formed due to irrigation**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The study area is comprised of 66.89 acres. All of the parcels surrounding the survey area appear to have agricultural activities occurring on them to some extent. An irrigation canal extends throughout 4.4 miles of the survey area. This canal, a man-made feature created for the purpose of agricultural irrigation, terminates in the surrounding agricultural fields. As such, the canal is considered non-jurisdictional.

Two wetlands exist on the site. The wetlands are dominated by Nebraska sedge, Baltic rush, Watercress, Yellow willow, and Golden current, while the upland areas are dominated by Burning bush, Flixweed, Cheatgrass, Baltic rush, Dandelion, English plantain, Brome grass, Nebraska sedge, and Crested wheat grass. Wetland 1 (W01), a palustrine scrub shrub wetland, encompasses 0.01 acres. This wetland is situated in a depressional area near a running water pump, and water has been observed flowing from the pump to pool in the wetland area. Wetland 2 (W02), a palustrine emergent wetland, encompasses 0.03 acres, and appears to be the result of irrigation on the nearby agricultural land. Both sites are isolated, with no apparent wetlands or RPWs in the relative vicinity. Wetlands W01 and W02 identified in the delineation report have no surface connection to a TNW and are not used for interstate or foreign commerce. These aquatic resources are intrastate isolated waters.
