Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 0.56-acre wetland delineated in the northwest portion of the study area is supported by land drains from the residential homes to the north and appears to be artificial in nature. The delineation includes photos of the discharge pipes and drainage features north of the study area and it is clear that these come directly from the homes to drain ground water away from the foundations. These discharges create a small wetland that runs into the study area but dissipates before reaching any other aquatic feature. No water from the wetland leaves the site. There are no surface hydrologic connection from this wetland and local tributaries. This was verified during a February 15, 2017 site visit. The 855-linear foot irrigation ditch along the western and southern boundary of the study area is separated from the wetland by at least 110 feet of uplands. This ditch flows generally

south of the study area through several parcels and becomes untraceable approximately 2,000 feet south of where the ditch leaves the study area. The ditch does not flow directly or indirectly into the Provo River, the nearest jurisdictional water. No other aquatic features exist within the study area. Deer Creek Reservoir, the nearest TNW, is located approximately 2.5 miles southwest of the study area. The Corps has determined that the wetland and ditch features identified in the study area are intrastate, isolated waters with no interstate or foreign commerce connection.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The delineated wetland in the northwest corner of the study area appears to be artificially created by land drains to the north. The wetland does not flow into any other aquatic feature. The irrigation ditch does have OHWM indicators in the study area, but disappears into agricultural and residential areas to the south. The Corps has determined that there are no jurisdictional features within the study area.
