Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The 0.44 acres of palustrine emergent wetland is not considered adjacent to and is isolated from Bear Lake, the nearest tradition navigable waterway. This wetland is not considered adjacent to a TNW, considering there is no ecological (biological) interconnection, or a chemical or hydrologic connection. This is due to its small size in comparison to the 109 square mile Bear Lake, the separation of wetland and Lake, which is approximately 900 feet of natural upland to the Bear Lake ordinary high water mark. This upland has a road constructed on top and a new development in the initial grading phase of construction. This upland area does not serve as an ecological connection between the**

subject wetland and Bear Lake. The wetland ecological functions would be considered minimal since the area is mainly comprised of non-native pasture grasses and is actively hayed. The subject property does not have any culverts under SR-30 or Buttercup Lane that would potentially connect this wetland with Bear Lake. Buttercup Lane acts as a dam and impounds irrigation tail water that likely formed this wetland that is mainly comprised of an invasive species, phragmites. Buttercup Lane is adjacent to the wetland and is at least 2 feet higher than the wetland elevation. There were no indicators of water overtopping the road into the adjacent property approximately 100 feet to the north, which may contain wetlands. Therefore, the 0.44 acre wetland was determined non-jurisdictional since it is not adjacent to a TNW and is isolated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The 4.15 acres Legacy Beach property contains 0.44 acre of palustrine emergent wetland. This 0.44 acre wetland has been determined to be not adjacent to and isolated from Bear Lake, the nearest traditional navigable waterway.

The subject wetland has no potential ecological or hydrologic connection with Bear Lake, the nearest traditional navigable waterway. The ordinary high water mark of Bear Lake is separated from the subject wetland by at least 900 feet, comprised of an upland. The subject property does not have any culverts under SR-30 or Buttercup Lane that would potentially connect this wetland with Bear Lake. This wetland is likely irrigated induced and is low functioning, due to it being mainly comprised of pasture grasses (e.g. *Elymus repens* and *Poa pratensis*) with seasonal saturation. This area is periodically hayed by late July and does not contain areas suitable for wildlife species (e.g. amphibians that would utilize both Bear Lake and this wetland as an ecological connection. Therefore, this wetland was not

considered adjacent to a TNW and has been determined to be isolated. Also, this wetland is not associated with any interstate commerce. Therefore, this 0.44 acres palustrine emergent wetland has been determined to be non-jurisdictional.
