This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: **These wetlands all directly abut an area located east of First Salt Creek. The main function of these wetlands are wildlife habitat and water filtration from non-point source pollution of adjacent fields.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A physical connection could not be identified between the RPW and wetland. There were no indications of surface flows between these waters and no subsurface flow could be identified beyond speculation. The soils between the waters are classified as Warm Springs and Sunset Loam. Neither of these soils are classified as hydric and the main soil between the areas is somewhat poorly drained, which is consistent with the test pits and crops growing in the area. The main hydrology source for the wetland is irrigation tail water which is evident through the seasons on historical aerial photographs. The wetland area is typically inundated throughout irrigation season and dries when irrigation ceases. The RPW is inundated throughout the year which demonstrates a clear separation in hydrology from the subject wetland, since both the wetland and RPW are at almost the same**

elevation. Due to no hydrologic connection, or any chemical or biological connection, which could not be identified between subject wetland and TNW, the Corps has determined the wetland to be non-jurisdictional.
