Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project area is located on a site containing the demolished and remediated remnants of an old iron works facility that operated between 1924 and 1962. The facility was demolished in the 1970s and environmental remediation was completed in the early 2000s. Wetlands on site are located within the remnants of an excavated cooling pond (Wetland I), within excavated pits likely associated with remediation work (Wetlands J and K), and within excavated concrete foundations of the old railroad bin facilities (Wetland P). These wetlands are not connected to each other and are isolated from any other feature under Corps jurisdiction. There are no drainages or outlets which could connect these wetlands to other features. The previous approved JD for this site (February 2, 2011) stated that these features were adjacent to a non RPW, which created a connection to Utah

Lake. The non-RPW was an open drainage ditch that flowed out of the north end of wetland I. This ditch was later cut off from any flow due to the removal of hydrology sources on site (capping of wells, removal of broken pipelines). A separate approved JD (SPK-2013-00728; January 2, 2014) on the abutting parcel included this ditch and found that it no longer exhibited wetland or OHWM characteristics and was determined to be non-jurisdictional. The ditch was subsequently filled. Now, the wetlands in question are separated from the nearest drainage feature by at least 375 feet of uplands. Wetlands I, J, K and P are intrastate isolated wetlands that are not regulated by the Corps.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands on site were larger and more numerous when the previous delineation was done (AJD- February 2, 2011). Since then, most of the hydrology sources, such as uncapped wells and broken ironworks pipelines, have been removed from the site. Monitoring wells installed and monitored by the consultant demonstrate this removal of water from the site. Hydrology for the remaining delineated wetlands comes from surface water collecting in depressions and a few remaining manmade water sources that have not been capped or removed. There are no natural streams, ponds, or other water features within the project area. Spring Creek, the nearest natural stream channel, is approximately 3,180 feet from on-site wetlands. Utah Lake, the nearest TNW, is approximately 2 miles to the west. The Corps has determined that Wetlands I, J, K and P are intrastate isolated wetlands with no apparent interstate or foreign commerce connection.
