Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 1.45-acre wetland delineated within the study area is located in a depression with barriers and all but the north side. A culvert used to bring water in from the agricultural field to the south, but this culvert was recently blocked and the water no longer enters the site. An outlet pipe on the east side of the parcel (west of Stouffers) drains storm water runoff from a portion of the adjacent parking lot into the delineated wetland. Also, the agricultural fields to the east are connected to the study area via a culvert on the northeast side of the parcel. However, this culvert appears to be no longer in use as no evidence of flow was observed coming into the study area at the site visit. Hydrology likely consists of ground water and some surface water, though the site is

observably getting drier since the removal of hydrology from the south field. The lower area where water used to drain out to the north now shows no indication of saturation or flow of any kind. There are no other ditches or swales that could connect the wetland to Hobble Creek, the closest jurisdictional water. Hobble Creek is approximately 700 feet west of the study area and Utah Lake, the nearest TNW, is approximately 1 mile to the west. The delineated wetland has been determined by the Corps to be an intrastate, isolated water with no potential connection to jurisdictional waters. There is no evidence to suggest that the destruction or degradation of these wetlands could affect interstate or foreign commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The artificial hydrology source was removed from the site in recent years and the wetland is now isolated and transitioning to upland. There are no longer any adjacent wetlands extending into the parcel north of the study area.
