**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

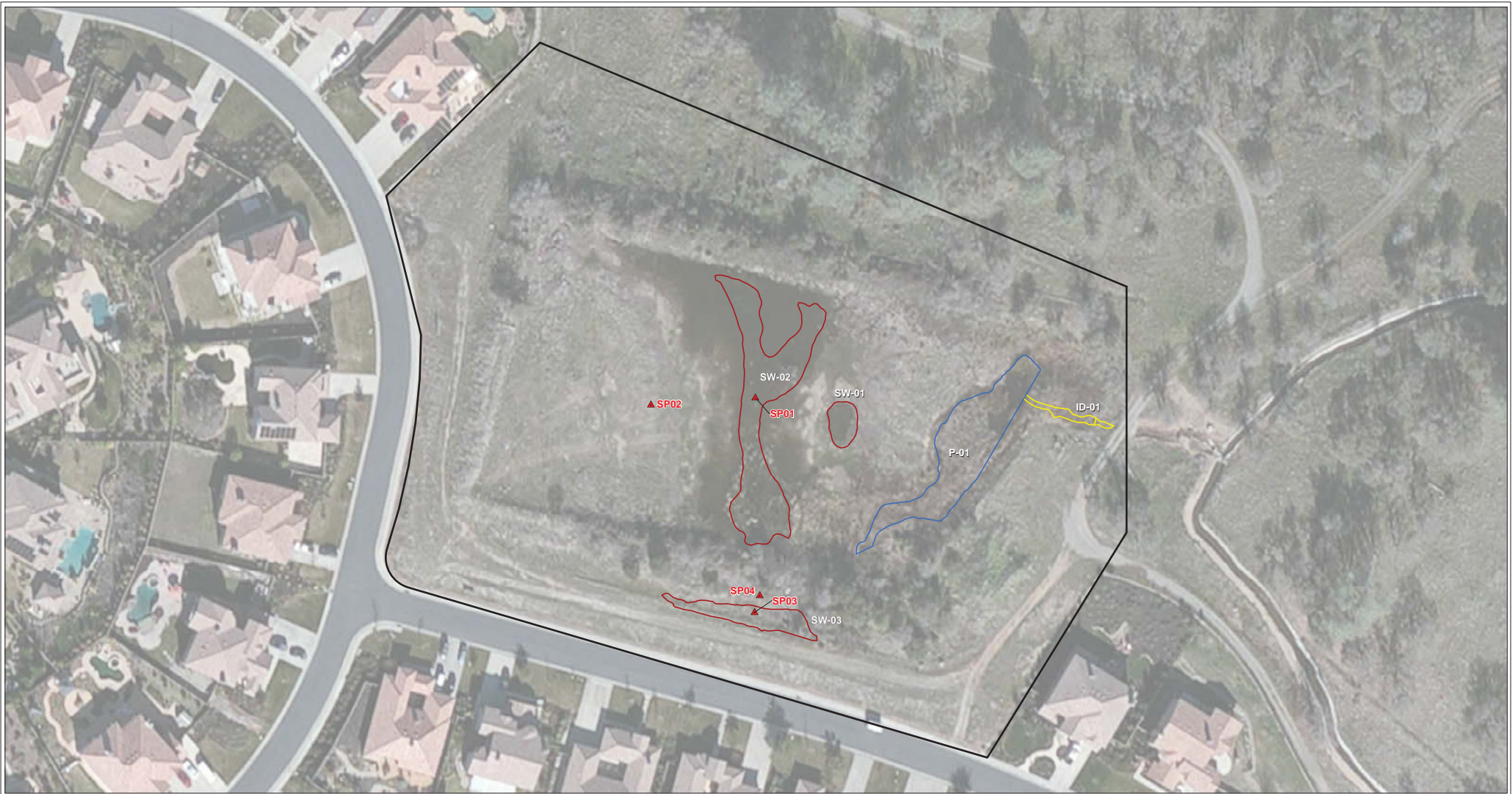

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The study area consists of an abandoned man-made detention basin, which appears to have been constructed in dry land between 1892 and 1944. The basin is no longer used for municipal water storage; however, it still receives precipitation in amounts sufficient enough for wetlands to persist. Irrigation Drainage-01 is a water supply ditch from Caperton Canal. Caperton Canal connects to Caperton Reservoir, a half-mile away. Based on historic topographic maps (USGS) dating back to 1892; Caperton Reservoir, Caperton Canal, and the detention basin were all constructed in dry land (see attached photographs). Pond-01 and Seasonal Wetlands-01 & 02 are topographically isolated depressional areas within the detention basin that support hydrophytic vegetation and soils. Seasonal Wetland-03 occurs within a topographically isolated man-made depressional area outside of the detention basin, which was likely formed as a result of adjacent land development. You can view the topographically isolated depressions on the attached LiDAR photographs prepared by the Corps on June 9, 2017.**

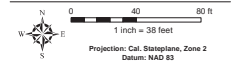

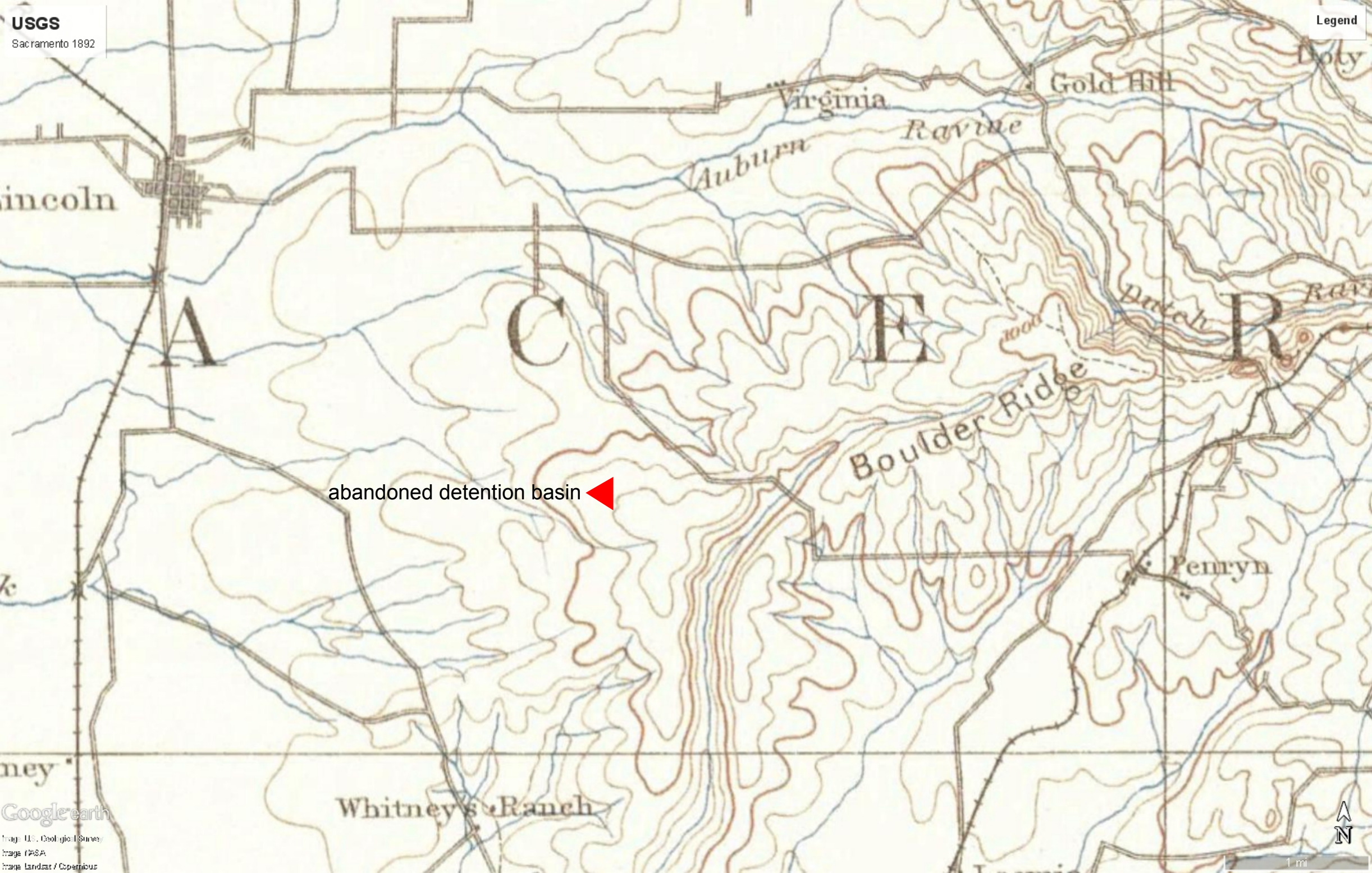


**TANK #3 AT CATTIA VERDERA SOUTH**

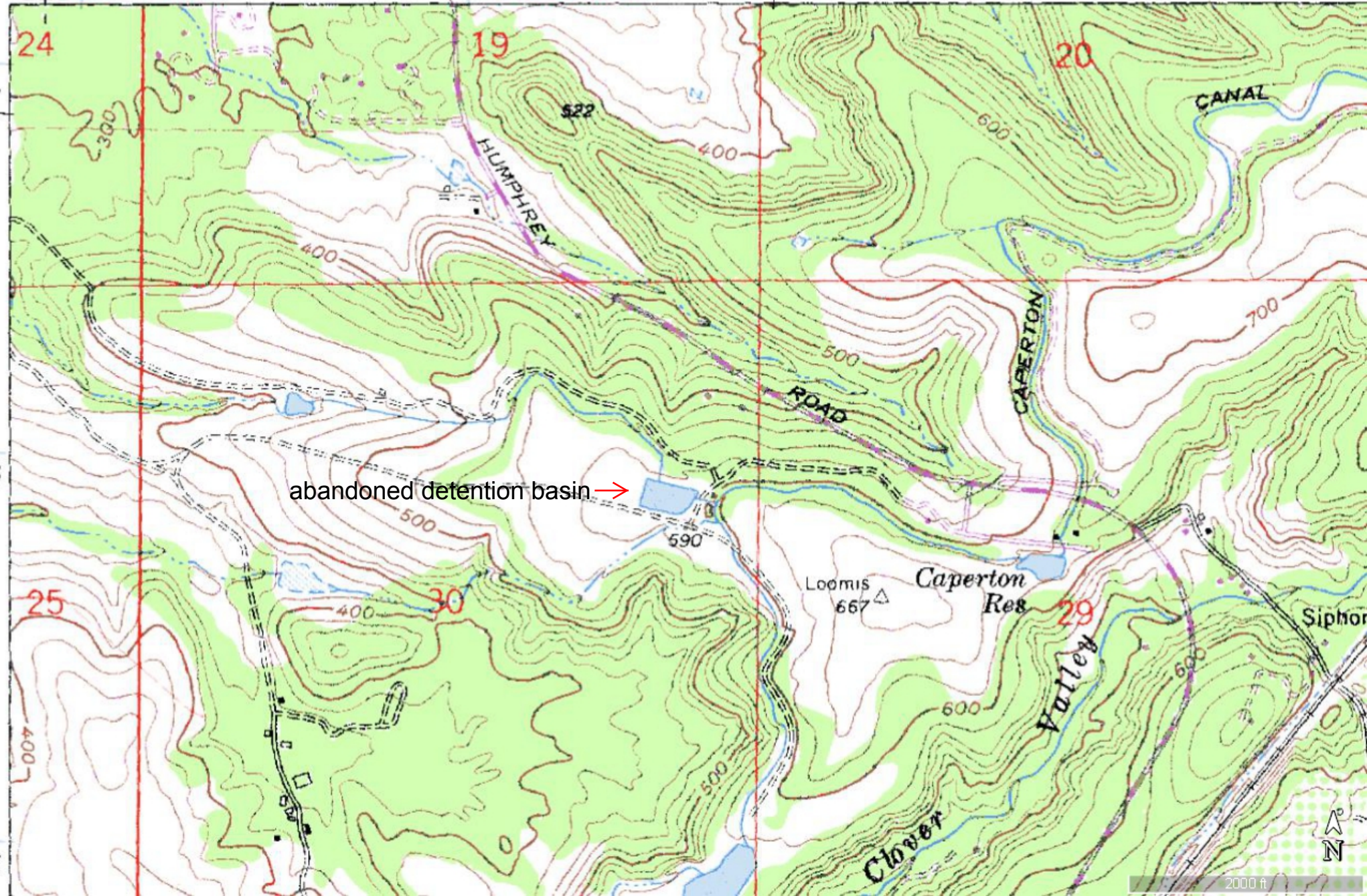
