Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area contains an abandoned canal with no ordinary high water mark that no longer receives any flow due to a piping and re-routing project several years ago. When the canal was in use, it created a wetland area in the depression below from the leaking water. The wetland area has largely dried up since piping of the canal, though a portion (1.5 acres) still contains all 3 wetland parameters. The wetland is isolated from any other jurisdictional water. Specifically, there is no connection to the ephemeral channel Adobe Wash, which is the nearest jurisdictional feature at approximately 345 feet northwest. The nearest TNW is the Green River, approximately 52 straight-line miles to the east. The Corps has determined that the 1.5-acre wetland

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The linear feature in the study area is the abandoned Clipper Western Canal. The water source has been piped and the canal no longer carries water or exhibits ordinary high water mark indicators. The isolated wetland that formed down-gradient from leaking water is transitioning to upland. There is no connection to other jurisdictional waters and no other aquatic features within the study area.
