Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The project site includes two wetland features, including 0.40 acre of riparian and emergent wetlands and a 0.10 acre\552 linear feet of manmade/excavated wetland ditch. A 0.24-acre riparian wetland is located near the northwest corner of the property adjacent to Taylor Road in a depressional area. Seasonal precipitation results in ponding of surface water in this area. The water in this area flows into the wetland ditch, which bisects the wetland and the property from northwest to southeast. The wetland ditch varies from 2 to 4 feet in depth and hydrophytic vegetation grows along the bottom of the ditch. Water also flows into the wetland ditch from the adjacent development. Due to the topography on site and the low area within the ditch, the water appears to pond for a portion of the year and the ditch dries out in the summer months. A second 0.16 acre wetland swale occurs in a depressional area, downslope from the adjacent development on the northeast corner of the property. The hydrology in this wetland**

is largely a result of seasonal precipitation. The water from this wetland may drain to the nearby wetland ditch via overland sheet flow during storm events, however there was no evidence of a connection during the Corps field visit. In addition to the Corps field visit, historic aerials of the project site do not show any connection to waters of the U.S. The aquatic resources on site are not identified in the National Hydrography Dataset or the National Wetland Inventory and are not observed on the U.S. Geological Survey Rocklin Quad map. No connectors or drainages are identified connecting the review area to any other waters of the U.S. in the vicinity. The entire review area is mapped as Andregg coarse sandy loam, 2 to 9 percent slopes, according to the National Soil Conservation Service soil survey and is typically well drained. The waters on site do not appear to flow or connect to waters of the U.S. and are therefore isolated and would not be regulated pursuant to the decision in *Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers*, 531 U.S. 159.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

from the adjacent development. Due to the topography on site and the low area within the ditch, the water appears to pond for a portion of the year and the ditch dries out in the summer months. A second 0.16 acre wetland swale occurs in a depressional area, downslope from the adjacent development on the northeast corner of the property. The hydrology in this wetland is largely a result of seasonal precipitation. The water from this wetland may drain to the nearby wetland ditch via overland sheet flow during storm events, however there was no evidence of a connection during the Corps field visit. In addition to the Corps field visit, historic aerials of the project site do not show any connection to waters of the U.S. The aquatic resources on site are not identified in the National Hydrography Dataset or the National Wetland Inventory and are not observed on the U.S. Geological Survey Rocklin Quad map. No connectors or drainages are identified connecting the review area to any other waters of the U.S. in the vicinity. The entire review area is mapped as Andregg coarse sandy loam, 2 to 9 percent slopes, according to the National Soil Conservation Service soil survey and is typically well drained. The waters on site do not appear to flow or connect to waters of the U.S. and are therefore isolated and would not be regulated pursuant to the decision in *Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers*, 531 U.S. 159.
