Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area contains an isolated wetland feature comprised of both palustrine emergent and scrub shrub wetlands. This wetland is primarily supported by a leaking canal located upslope and running north to south just outside the western boundary of the study area. The wetland does not flow off site or into any other channel, wetland or conveyance of any kind. The wetland cannot contribute any flow back into the canal, being substantially down gradient from the canal. The canal originates in Salt Lake County to the north and feed agricultural fields to the south before it terminates in a holding pond approximately 4.2 miles south-southwest of the study area. The canal is an isolated conveyance with no connection to jurisdictional waters. The Corps has

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
