C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These features are connected to each other through culverts and to Utah Lake under I-15. Aerial imagery dating back to 1946 shows perennial flow, which has also been confirmed in the field by Corps personnel on multiple occasions. During extreme high water periods, Utah Lake backs up in to the study area due to the close proximity.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetlands within the study area are directly abutting the perennial open water features that were constructed in a historic wetland drainage area of Mill Race. Utah Lake, the nearest TNW, is located less than one mile west of the study area on the other side of I-15. The aquatic features on site are associated with a golf course and could be considered ornamental. However, these features are considered jurisdictional since they were not constructed in uplands and do not drain only uplands.
