Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Rutabaga Creek begins outside of the project area and indicates an OHWM for 2,081 linear feet within the survey area. It loses its OHWM approximately 4.25 miles outside of the project boundary. Roberts Creek flows along the outside of the project area, but crosses the BLM Project Area boundary and contains OHWM indicators for 51 linear feet. This drainage contains a flow that is diverted into an agricultural field within the Kobeh Valley, where it dissipates. Drainage 19 crosses the haul road boundary (also part of the survey area) with OHWM indicators for 651 feet within the survey area. This drainage continues for 2,248 feet outside of the survey area until it loses all OHWM indicators. Coils Creek also crosses the haul road boundary and has an OHWM for 521 feet. This drainage flows to Slough**

Creek several miles outside of the survey area, which dissipates into agricultural fields in Diamond Valley and does not connect to any other waterway. Drainage 31 also has OHWM indicators that continue for 5,417 feet but are no longer visible approximately 6,422 feet outside of the survey area. Drainage 32 has an OHWM for 17,423 feet within the survey area and continues for several miles outside of the survey area. However it becomes a braided channel and terminates at Mud Spring, an isolated spring with no surface flow connection to any other drainages.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The drainages all receive surface flows from spring runoff from the Roberts Mountains, with precipitation averaging 12 inches per year. The only drainage that flows perennially is Roberts Creek, which is also fed by seeps and springs outside of the survey area. All drainages lose their OHWMs within or not far outside of the survey area and do not connect to a TNW.

Rutabaga Creek, Roberts Creek, Coils Creek, Drainage 19, Drainage 31 and Drainage 32 are intrastate isolated waters with no connection to a TNW.
