C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The study area is located in the Crescent Hydrographic Area in the Humboldt River Basin. The Humboldt River is about 13 aerial miles from the study area. Precipitation measurements collected at the Fire Creek Mine site in the study area averaged about 6.5 inches over the 3 year period of record.

The main drainage within the mine area, Fire Creek (D7), is perennially fed by a spring (Seep Spring #3) with a branch also being fed by springs 1 and 2. Flows diminish during the year from the springs so the drainage flows intermittently for 0.5 mile then becomes ephemeral when the flows infiltrate into the alluvial fan in the valley bottom prior to reaching the playa. Similarly drainage 10 (D10) is intermittently fed by Spring 4 but flows diminish and cease during the year so the drainage flows become ephemeral. Drainages 2, 3, 4, 5, 6, 8, 9, and 11 are ephemeral and channel only storm water. The study area contains no hydric soils according to the NRCS Web Soil Survey. Due to the permeability of the soils precipitation infiltrates and does not discharge into Crescent Valley. D1 is the only drainage not in Crescent Valley but it drains into the Whirlwind Basin. D1 loses a defined channel and OHWM approximately 8 miles from the Humboldt River and does not connect to another aquatic resource.

The channels are associated with the Fire Creek Mine (which has interstate commerce), as they could be impacted/filled due to road crossings and tailings piles. However, the mine operation does not derive the gold from these drainages and thus the degradation of these aquatic resources would have no effect on the mine and thus no adverse impact on interstate commerce. Additionally, there are no fisheries of any type, there are no sand and gravel operations or any other commercial endeavor being conducted on the surface waters in this watershed.
