Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Channel 1 is 4,908.21 feet long with an average width of 1 foot. Its tributary Channel 1 A is 1,106 feet long with an average width of 1 foot. Both Channels 1 and 1 A receive water from an off project emergent spring and have a defined bed and bank. Channel 2 is 2,684 feet long and an average of 1 foot wide. Channel 2 is a heavy rock stabilized channel that transitions between swales and bed and bank. Channel 3 is 14,495 feet long, and averages 1.5 feet wide, it begins in a roadside swale and has lost a small upper portion to mine activity. Channel 3 has bed and bank in the middle portion, upper-middle and lower middle portions of the

drainage. Channel 4 is 17,129 feet long and averages 2 feet wide, it receives water from 2 previously delineated springs as well as a seep which forms a small wetland (W1) and contains one manmade pond (Wetland Pond 1). Wetland 1 is approximately 0.1 acre in size and is contained within Channel 4. Wetland Pond 1 is 0.28 acres and is also contained within Channel 4. Wetland Pond 1 is a historic wetland that was dammed and turned into a pond. Channel 6 is 14,398 feet long and averages 2 feet wide, it is defined by a bed and bank and partially follows a reclaimed road which it intersects at several location. All of these drainages flow east into Whirlwind valley where they are lost prior to infiltration and evaporation in the Playa of Whirlwind Valley and were determined in the April 30, 2010 Approved Jurisdictional determination to be Intrastate isolated waters with no interstate commerce connection.

Channel 7 is 5,807 feet long and averages 4.5 feet wide, its headwaters have been filled by mining activity; however, there are many springs or seeps within the channel. Channel 7 has a defined bed and bank with incision and livestock impacts along its length. There are four wetlands associated with Channel 7; W4, W5, W6, and W7. W4 is approximately 0.06 acre, and is located within Channel 7. W5 is approximately 0.06 acre and is located in Channel 7 downstream of W4. W6 is approximately 0.01 acre and is located within Channel 7 downstream of W5. W7 is approximately 0.02 acre and is located downstream of W6. Channel 7A is a small tributary of channel 7 approximately 1,393 feet long with bed and bank features. Channel 8 is approximately 2,100 feet long, has bed and bank features and one wetland (W3). Only the initial headwaters of Channel 8 fall within the project area. W3 is approximately 0.02 acres and is contained within Channel 8. Channel 9 is approximately 2,361 feet long with bed and bank features, and one wetland (W2) at the headwaters. W2 is approximately 0.06 acre and is located at the headwaters of Channel 9. Channel 9A is a small drainage, approximately 1,646 feet long with bed and bank features and one associated wetland (W8). W8 is approximately 0.01 acre and is located within Channel 9A. Channels 7, 7A, 8, 9, and 9A drain to the west of the Shoshone Mountains where their flows are lost to evaporation and infiltration on the alluvial fans of the Reese River Valley and were determined in the April 30, 2010 Approved Jurisdictional determination to be Intrastate isolated waters with no interstate commerce connection.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: In 1995, the Corps completed a JD in the project area and determined the waters and wetlands jurisdictional based on regulatory guidance prior to the SWANCC and Rapanos Supreme Court Decisions. On December 2, 2008, the U.S. EPA and the Department of the Army issued a joint legal memorandum regarding Clean Water Act jurisdiction of tributary streams based on the Rapanos decision. This was affirmed in the April 2010 Approved Jurisdictional Determination which was coordinated with USEPA and verified in November 2011. There were no changes on site since the 2010 determination. Based on this information the aquatic resources identified are isolated intrastate waters and are not considered waters of the United States.
