Summarize overall biological, chemical and physical functions being performed: **The Chandler ditch wetland is a wetland area abutting Bailey Canyon Creek where Chandler ditch (removed from use in 2006) intersected with Chandler ditch. Chandler ditch wetland provides habitat and lifecycle support functions for feeding and nesting of mammals and birds. Chandler ditch wetland also creates a stabilized meander slowing waters as they flow towards Steamboat Creek. Chandler ditch wetland allows infiltration that also provides basin groundwater recharge.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Bailey Canyon Creek and its adjacent wetland do have a physical relationship to steamboat creek, and the Truckee. In their 2006 Geiger Grade/Toll Road Flood Control Project Existing Condition Analysis Memorandum, Wood Rogers found that Bailey Canyon Creek is directly associated with significant sediment input to downstream tributaries. The report also found that, a 100-year event with a flow of 3673 cfs had a sediment yield of 52.5 acre feet of sediment. Bailey County Creek infiltration also provides groundwater recharge. The subject water has a significant effect on the physical, chemical, and biological integrity of the Truckee River.**
