Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A total of 0.57 acre of potential waters, including 0.47 acre of irrigation ditch (ID-1) and three potential seep wetlands (Seep 1, Seep 2, and Seep 3) were identified within the study area. The irrigation ditch is known as the Newcastle Canal, and is a manmade irrigation ditch, constructed entirely**

within uplands and draining only uplands. The Newcastle Canal is an irrigation Ditch that originates from an upstream reservoir controlled by the Placer County Water Agency through valves and gates. Portions of the irrigation canal are lined on the eastern and western portions of the study area; however, the majority of the canal is unlined. Ditches constructed in uplands and draining only uplands are generally not regulated by the Corps; therefore, the Newcastle Canal within the study area is not a waters of the U.S. A geotechnical study was conducted within the project area. In general, ground water was found 3 to 5 feet below the surface in the vicinity of all potential seep wetlands. Based on the information provided by the consultant, we have determined that the wetland hydrology is caused by the leaky canal in the center of the site. In accordance with Sacramento District Regulatory Branch Memorandum 2004-03, the three potential wetlands are considered artificially irrigated wetlands; and therefore, would not have sufficient hydrology under normal circumstances to meet the hydrologic criteria and definition of a wetland.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: A total of 0.57 acre of potential waters, including 0.47 acre of irrigation ditch (ID-1) and three potential seep wetlands (Seep 1, Seep 2, and Seep 3) were identified within the study area. The irrigation ditch is known as the Newcastle Canal, and is a manmade irrigation ditch, constructed entirely within uplands and draining only uplands. The Newcastle Canal is an irrigation Ditch that originates from an upstream reservoir controlled by the Placer County Water Agency through valves and gates. Portions of the irrigation canal are lined on the eastern and western portions of the study area; however, the majority of the canal is unlined. Ditches constructed in uplands and draining only uplands are generally not regulated by the Corps; therefore, the Newcastle Canal within the study area is not a waters of the U.S. A geotechnical study was conducted within the project area. In general, ground water was found 3 to 5 feet below the surface in the vicinity of all potential seep wetlands. Based on the information provided by the consultant, we have determined that the wetland hydrology is caused by the leaky canal in the center of the site. In accordance with Sacramento District Regulatory Branch Memorandum 2004-03, the three potential wetlands are considered artificially irrigated wetlands; and therefore, would not have sufficient hydrology under normal circumstances to meet the hydrologic criteria and definition of a wetland.**
