Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Isolated Wetlands 1-4 meet the three-parameter test for wetlands; however, they occur in depressions that collect storm water runoff from the highway via upland sheet flow. They are isolated and lack a hydrologic connection to waters of the United States. This statement is supported by Light Detection and Ranging (LiDAR) data (Figure 5). Reviewing this data shows that the four identified wetlands are bordered on all sides by areas of higher elevation, and they cannot flow toward Oakwood Lake, or any other waters. This is confirmed by available aerial imagery, which shows dark areas in the mapped depressions, with lighter colored areas at higher elevations. This information does not preclude the possibility that there are culverts or drains that would transport

water outside the features. The applicant's wetland delineation report states that there are no culverts or drains within these features. In support of a previous jurisdictional determination of the site, a site visit was performed on December 13, 2012, during which all of the probable locations for a culvert were examined. No culverts or drains were found during that site visit that would allow water to leave the wetland features. These features are not adjacent to a traditionally navigable water or a non-navigable tributary of a traditionally navigable water. They are being used only for upland sheet flow storage, and have no connection to interstate commerce. Caltrans in their request for an extension of the previous jurisdictional determination, indicated that they visited the site on January 23, 2018 and that the conditions remain consistent with our previous determination.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
