of the study area, the property owner provided additional information and requested an approved JD for the 1-acre study area. A leaking irrigation pipe was identified providing artificial hydrology to the identified wetland in a December 2017, *Geophysical Investigation at the Sierra College Boulevard and Rocklin Road Seep, Rocklin, Placer County, California* prepared by Gasch Geophysical Services, Inc. In addition, a range of aerial photography was reviewed. The area identified as Seep 3 can be seen as a wetland in aeriels taken in any season starting in 2005. Seep 3 is visible in both the summer dry season and the wet season; however, prior to 2005, in U.S. Geological Survey aerial photographs dated May 21, 1993, July 27, 1999, and April 30, 2002, no wetland signature is visible. Based on an evaluation of the additional information provided in the consultant's March 1, 2018, letter and a review of aerial photography, we have determined that the hydrology as described in the January 2017, *Aquatic Resources Delineation Report Sierra Villages Site A and B* prepared by Madrone Ecological Consulting is not the normal circumstance for the study area. Since the property owner replaced the leaking pipes on the property in January 2018, the area identified as Seep 3 will revert to dry land. The Corps has determined that Seep 3 would not have wetland hydrology under normal circumstances (in the absence of the artificial water source from a leaking pipe) and that the area does not meet the definition of a wetland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Seep 3 is visible in both the summer dry season and the wet season; however, prior to 2005, in U.S. Geological Survey aerial photographs dated May 21, 1993, July 27, 1999, and April 30, 2002, no wetland signature is visible. Based on an evaluation of the additional information provided in the consultant's March 1, 2018, letter and a review of aerial photography, we have determined that the hydrology as described in the January 2017, *Aquatic Resources Delineation Report Sierra Villages Site A and B* prepared by Madrone Ecological Consulting is not the normal circumstance for the study area. Since the property owner replaced the leaking pipes on the property in January 2018, the area identified as Seep 3 will revert to dry land. The Corps has determined that Seep 3 would not have wetland hydrology under normal circumstances (in the absence of the artificial water source from a leaking pipe) and that the area does not meet the definition of a wetland.
