**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: [BL-2 is an ephemeral drainage that receives water from Little North Creek, an intermittent stream. BL-2 drains to BL-1. BL-1 is an ephemeral drainage that has been channelized and straightened. BL-1 receives water from Pine Creek, an intermittent stream. BL-1 drains back into Pine Creek, Pine Creek drains into an unnamed channel that drains to Cove Creek, an intermittent stream. Sulphur Creek is an intermittent stream that drains to Cove Creek. Cove Creek does not connect to any Waters of the U.S. and loses evidence of an OHWM at a location approximately 1.25 miles away from the Beaver River. BL-2, BL-1 and Sulphur Creek are documented on OHWM data sheets located in the documents submitted by CH2M HILL, appendix D, dated December 6, 2017. These sheets include the general area conditions, physical characteristics, and biological characteristics.](#)**
