Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 0.2-acre pond is a man-made feature excavated in uplands and was created for uses associated with the hog farm on the property. This was confirmed through aerial photography showing that the entire site was an agricultural field in a 1974 image. In a 1981 image, the square pond and hog farm buildings exist on site. The pond is completely surrounded by a high berm constructed from the excavated material and the water surface has little fluctuation being tied to the ground water level. There are currently no culverts or connections of any kind that could convey flow into or out of the pond. The wetland area north of the pond receives water from the poorly maintained ditch adjacent to the north boundary of the study area and does not

receive any water from the pond. The Corps has determined that the pond is an artificial, constructed farm pond created in dry land and is not currently regulated under CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The ditch eventually flows into the Little Bear River drainage just before entering Cutler Reservoir, which is an impoundment of the Bear River, the nearest TNW.
