**Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:** The center of the study area includes an excavated ornamental golf course pond, occupying a total area of approximately 0.95 acre. The pond was excavated in uplands and historically has been filled to maintain its water level. Other potential water sources are stormwater runoff and fairway watering runoff. It is unknown how much water the pond receives from groundwater recharge. The pond has no physical connection to a tributary or water of the United States, therefore we have determined this pond not to under the jurisdiction of USACE (please refer to 1986 preamble and 33 CFR 328.3).

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
