C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The delineated ephemeral stream channels on attached map (HBG 2019 Aquatic Resources Delineation Report, Appendix C, Figure 5) (subject channels) were each demonstrated to flow to the Pahrnagat Wash. The Pahrnagat Wash flows to the Muddy River. The Muddy River drains directly to Lake Mead. The findings of the report clearly demonstrate that the subject channels each flow into the Pahrnagat Wash and eventually to Lake Mead, a Section 10 Rivers and Harbors Act Traditional Navigable Water (TNW).

The findings of Kondolf n et al. (1991) demonstrated that ephemeral high-gradient tributaries are important to spawning and rearing habitat for fish species in downstream perennial streams. Ephemeral streams provide water, spawning gravel and cobble to down gradient perennial waters during flow events. The subject channels each have a significant effect on the physical, chemical and biological integrity of Lake Mead.

The subject channels on attached map each provide water, habitat organic carbon and life cycle support functions for fish species present in the downstream TNW. Each provides water and organic carbon to the Muddy River thereby providing water and carbon for fish species that migrate downstream to the Lake Mead. This process, which occurs in each of these tributaries, transfers nutrients and organic carbon from the headwaters to the downstream TNW and supports downstream food webs.

Surface water from the site collects into 217 separate ephemeral stream channels that drain away from the project area. 910,855 linear feet (63.79 acres) of ephemeral stream channel were delineated within the project area and were determined to be hydrologically connected to and have a significant nexus with Lake Mead, the nearest TNW.

Each stream is documented on individual forms located in the *Aquatic Resources Delineation Reverification: Coyote Springs Development in Lincoln County, Nevada* report prepared by Huffman-Broadway Group, Inc., dated October, 2019. These sheets include the general area conditions, physical characteristics, chemical characteristics, and biological characteristics of each water evaluated so the responses provided in B and D of this document should be considered averages.
