Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Constructed basin 1 is a constructed, unlined earthen basin approximately 1.93 acres in size. The basin is in the northwest portion of the project site and is adjacent to Elk Grove Creek that parallels the northern boundary of the project site. Historically, the location where this basin exists consisted of dryland grain crop fields, a mining operation and it is currently mapped as a tailings pond on USGS topographical maps. The basin is a water-filled depression created in dry land incidental to mining or construction activity, including pits, excavated for obtaining fill, sand or gravel that fill with water that are not considered waters of the U.S.

Summarize overall biological, chemical and physical functions being performed: Seasonal wetland likely serves very little biological, chemical or physical function since it is a physically small seasonal wetland that appears to have formed from a constructed berm immediately to the north of the feature. It is dominated by nonnative facultative wetland vegetation but also supports some upland vegetation. This wetland is ephemeral to provide habitat for aquatic invertebrates or aquatic vertebrates but could provide a temporary source of water (drinking) for terrestrial wildlife immediately after periods of inundation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The basin is in the northwest portion of the project site and is adjacent to Elk Grove Creek that parallels the northern boundary of the project site. Historically, the location where this basin exists consisted of dryland grain crop fields, a mining operation and it is currently mapped as a tailings pond on USGS topographical maps. The basin is a water-filled depression created in dry land incidental to mining or construction activity, including pits, excavated for obtaining fill, sand or gravel that fill with water that are not considered waters of the U.S.
