In total there were 8 palustrine emergent wetlands, 1 spring, 1 open water pond (e.g. stock pond), 1 playa (Flanigan Playa), 2 upland swales, 20 ephemeral drainages, and 9 intermittent drainages that were assessed. Aquatic resources

identified as ID-01 and 02, and ED-01 thru 08 located in Area SB1, drain towards the NV/CA state line but their ordinary high water marks (OHWM) terminate in uplands approximately 1 mile west of the state line at the nearest point, that being the terminus of ID-01 OHWM. All aquatic resources flow to the Flanigan Playa (the playa analyzed in this analysis) which is an isolated, intrastate water with no commercial or economic commerce connection. The 2 upland swales (SWS-01 and US-01) do not exhibit an OHWM or defined bed and banks and are therefore considered upland features that are not jurisdictional aquatic resources.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

While evaluating the Aquatic Resources Delineation for the Fish Springs Ranch Solar Energy Center Project, Washoe County, Nevada, dated January 2020 by Dudek, all the wetland and non-wetland waters (other than ID-01 and 02, and ED-01 thru 08 located in Area SB,1) have flow paths towards the Flanigan Playa. The Flanigan Playa is a closed basin that is bound by

mountain ranges to the north, south and east. To the west the Sierra Army Depot separates the playa from Honey Lake, an adjacent closed basin. The Flanigan Playa has no connection to any Traditional Navigable Water and does not cross states lines.

Online research found that the Flanigan Playa supports the Dead Cow Airstrip, which is now privately owned. For the past ten years the High Sierra Fly-In Festival has been held on the playa, at this airstrip. While this event appears to support some level of commercial activity, it does not represent an interstate or foreign commerce connection. The degradation of this aquatic resource has no effect on the event, as the event requires the dry lake bed conditions to support aircraft landing and takeoffs. The activity is dependent on the dry conditions.

Of the 42 aquatic resources investigated in the report, 2 of the potential resources are not jurisdictional because they are considered upland features with no defined bed or bank and no OHWM. The remaining 40 aquatic resources, which includes the Flanigan Playa, are isolated, intrastate waters with no connection to any traditionally navigable water.
