Detentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetland C and Ditches E, F, G, H, I, J, K, and L are non-jurisdictional features.

Wetland C is located in a slightly lower topographic area and holds irrigation water for longer periods. This feature and the entire surrounding area is part of an ongoing farming operation. This feature does not connect to any onsite or off-site aquatic features, specifically irrigation ditches, as verified by Corps personnel on August 30, 2019. Wetland C is an isolated feature with no interstate or foreign commerce connection and is not currently regulated under CWA Section 404.

The above ditches, totaling 5,985 linear feet, are all man-made irrigation conveyances constructed wholly in uplands and drain only uplands. None of these ditches connect to or flow into other aquatic features on or off site, as verified by Corps personnel on August 30, 2019. Ditches E through L are not currently regulated under CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
