Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area contains only man-made irrigation ditch features, and no other aquatic features are present on site. Ditches 1, 2, 3, and 4 exhibits ordinary high-water mark (OHWM) indicators within the study area and flow generally south or southwest through the site and to adjacent parcels. Ditches 1, 3, and 4 dissipate in upland agricultural fields south of the study area and the OHWM indicators of Ditch 2 disappear on the south side of the residential driveway on site. Ditches 1-4 have no apparent interstate or foreign commerce connection. The Corps has determined that Ditches 1-4 within the study area are isolated, man-made irrigation features not regulated under CWA Section 404.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g., between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
