- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The survey area contains approximately 50 acres of saline wet meadow wetland habitat and 13.6 acres of playa habitat. These aquatic resources drain westward from the survey area towards a storm drain ditch that carries waters from areas north of the site to the Great Salt Lake, however, there is a large solid earthen berm running the entire length on both sides of the ditch as it crosses to the south side of 900 South. This berm

acts as a levee and prevents all waters draining from the survey area from entering the ditch. The earthen berm on the adjacent property was walked by the consultant for its entire length and found no breaks which would allow water to enter. This berm impounds water as much as 3 feet deep adjacent to the berm and causes water to back up and inundate the playa within the survey area by as much as 6 inches of water (based on the physical indicators on site). The storm water ditch was constructed through a larger playa system in the 1950s. Prior to the ditch construction, the playa system and wetlands would not have connected to the Great Salt Lake, and thus does not constitute an impoundment of waters of the U.S. Further, the railroad bounds the southern boundary of the property and contains no culverts except where the large stormwater ditch crosses under it further to the west.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The wetlands consultant was able to gain access to the adjacent parcel to the west which contains the stormwater ditch, which is the only potential surface hydrologic connection from the survey area to the Great Salt Lake. He surveyed the berm and talked with the users of that land. No gaps in the berm were identified. This is confirmed by the 2018 LiDAR data available for the site.
