Isolated Feature: Barneys Wash combines several smaller drainage channels that eventually lead to a culvert which crosses under Highway 111 along the west boundary of the study area. The remains of Barneys Wash within the project area are not clearly channelized, with many wide, shallow swales that vary between 2-3 feet deep and 20-50 feet wide. According to information in the Aquatic Resources (AR) report, most of the historic channel was filled in the 1950s, which altered what may have been any previously defined channels and since

then, the project area has been used for agriculture. On the northeast side of the property where the wash would have historically left the site, a culvert was added during the roadway construction of 6400 South around 2005/2006. This culvert is, however, not topographically connected to the historic wash path across the property, but rather appears to guide storm drainage from the road and other storm flows from the north back into the historic channel that is still present downstream of the study area. There are no wetlands adjacent to or directly abutting Barneys Wash within the study area.

A review of the National Hydrography Dataset (NHD) flowlines, shows the wash as an intermittent stream; however, the Ordinary High Water Mark data sheets included in the AR report indicate the wash has no indicators of an OWHM and no floodplain areas were documented on-site. The wash continues off the property to an area downstream that was reconstructed to accommodate surrounding residential development, as it is now channelized and rip-rapped for over half a mile through the residential and recreation areas to the east of the project area. The wash terminates at approximately 400 feet east of the railroad tracks near Festive Way, West Jordan, Utah. Maps and historic aerial records confirm that Barneys Wash is an isolated feature with no connection to any other drainage features or any other jurisdictional waters on or off site, with no apparent connection to interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
