- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The approximately 148.62-acre aquatic resources study area is a 12-mile long linear segment of State Route 59. The surrounding land use is dominated by agriculture consisting mostly of irrigated row crops, grain, orchards, and vineyards. The irrigation ditches and basins have little to no vegetation and appear to be highly managed by the farmers. The study area contains 1.318 acres of aquatic features, 1.213 acres of irrigation ditches/canals consisting of ID-01, ID-02, ID-03, ID-04, ID-05, ID-06, IC-01a, IC-01b, IC-02a, IC-02b, IC-03, IC-04, IC-04a, IC-04b, which are non-tidal irrigation ditches constructed entirely in uplands and drain only

uplands, they do not carry a relatively permanent flow of water and are not relocated tributaries and 0.105 acre of irrigation basins consisting of IB-01, IB-02, IB-03, IB-04, IB-05, IB-06, which are artificial ponds created by excavating dry land to collect water used exclusively for irrigation purposes. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: All of the aquatic features within the study area appear to be part of an extensive irrigation system constructed in uplands and designed to move irrigation water to the various agricultural fields. The ditches/canals are non-tidal irrigation ditches excavated on dry land, ephemeral in nature, carrying water during summer/fall irrigation season. The basins or ponds were constructed on dry land to be used exclusively for irrigation purposes. None of these aquatic features is considered jurisdictional.
