Isolated Feature: Wetland A/Pond (1.7 acres) - This wetland is situated within the remnants of an excavated stock pond in the southwest corner of the study area. This wetland is an isolated feature with no discrete downstream surface or shallow sub-surface connection to other aquatic features. The wetland receives irrigation water that is diverted onto the property from an off-site canal located immediately to the west of the study area boundary. The canal is a manmade raised water conveyance structure that branches off the North Point Canal approximately 1.5 miles north of the study area. The canal was constructed

with earthen berms and is approximately 4 feet higher in elevation compared to the surface elevation of Wetland A. A control notch in the canal is used to divert water that periodically floods the study area causing ponded/saturated conditions. The canal drains into Wetland A; however, Wetland A cannot drain upgradient into the canal. Given that the wetland is isolated and is an intrastate water with no interstate or foreign commerce connection and has no direct or indirect surface or subsurface connection to a Traditional Navigable Water, the Corps has determined that the aquatic feature is not regulated under the CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
