Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area has been extensively disturbed from various historic land uses, such as agriculture, a golf course, and a residential development project that was not completed. Wetlands C, D, E, F, G, H, I and J are isolated features located throughout the central portion of the study area. These wetlands are the result of water ponding in depressional areas that were excavated for development infrastructure or for sand traps

and other golf course related features. A June 10, 2022 site visit confirmed that these isolated features have no connection to other jurisdictional resources on site. Channel 1 and Ditches 1 and 2 convey on and off-site water around these isolated wetlands and do not contribute any surface hydrology. Ditch 2 receives water through a culvert under the roadway directly from the south and does not connect to or receive any water contribution from Wetland I. The site is known to have seasonally high ground water, which supports the wetland vegetation in these low-lying areas. Due to the amount of time since the site disturbances occurred, Wetlands C-J cannot be considered non-jurisdictional based on being artificial/ornamental features or water-filled depressions excavated in uplands. However, the Corps has determined that these wetlands are intrastate, isolated features with no interstate or foreign commerce connection not regulated under CWA Section 404. In 2008, wetlands delineated in this same area, though smaller in size than the current delineation results, were also determined to be isolated, non-jurisdictional features.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
