These two basins form the HUC 6 Black Rock Desert Basin which is a closed, endorheic basin with no hydrologic outflow to other external bodies of water. As such, the aquatic resources within the study area are all isolated.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Pyramid-Winnemucca Lakes HUC 8 basin contains Pyramid and Winnemucca Lakes, both Navigable-in-Fact Section 10 waterways, and is adjacent to the Black Rock Desert basin. For the Black Rock Desert basin to have connectivity to Pyramid or Winnemucca Lakes, surface water would need to exceed an elevation of approximately 3,973 feet above sea level. It is believed that these basins were connected during the Holocene period when Lake Lahontan connected numerous basins within the larger Great Basin. This scenario is not possible under existing climatic conditions.
